## The Massachusetts Gaming Commission Hires Director of Administrative Services

New Role also includes Duties of a Transition Start-Up Manager

Today Chairman Steve Crosby on behalf of the Massachusetts Gaming Commission (MGC) is pleased to announce Eileen Glovsky as the new Director of Administrative Services and Transition Start-Up Manager. Glovsky brings over 30 years of experience in administration and technology to the new state gaming commission.

As the Director of Administrative Services, Glovsky will be responsible for overseeing and executing a number of duties relative to Administration, Human Resources and Information Technology. This position was designed to assist the Massachusetts Gaming Commission to establish and advance the critical internal operations of the organization.

Chairman Crosby stated, "The establishment of a strong internal infrastructure and the capability to meet operational goals will be essential to the MGC's successful introduction and implementation of expanded gaming to the Commonwealth. Ms. Glovsky's demonstrated track record in the areas of administration, human resources and technology will be a valuable asset as we continue to aggressively move forward to accomplish the Commission's ambitious goals and objectives."

Prior to joining the Commission, Glovsky served as Deputy Treasurer at the state's Office of the Treasurer. As Deputy Treasurer, Glovsky was tasked with overseeing Administrative Services for the Treasury. In that role, Glovsky supervised all administrative functions of the office including procurements, budgeting, accounts payable and reporting functions. Glovsky, who has been Deputy Treasurer for six years, was promoted to that position after holding previous positions at the Treasury including Assistant Treasurer of Human Resources, Director of Financial Education and Director of Deferred Compensation.

Prior to joining the state's Office of the Treasurer, Glovsky did extensive administrative and IT work as an independent consultant following positions held in software solutions and project management.

Glovsky holds degrees from the MIT Sloan School of Management and San Francisco State University.
