'Host Community' Public Hearings on Resort-Casino Gaming Applications**
*Public input meetings to offer early opportunity for community members to provide the
Commission feedback on resort-casino proposals*

WHO: Members of the **Massachusetts Gaming Commission**, representatives from resort-casino applicants **MGM Springfield, Mohegan Sun MA**, and **Wynn MA LLC**; and members of the public

WHAT: The Massachusetts Gaming Commission will host three 'host community' public hearings as a means to facilitate public discussion regarding the recently submitted Category 1 or resort-casino applications. These public hearings are in addition to upcoming meetings held by the Commission in neighboring communities to the proposal. The purpose of these meetings is to provide members of the public with an additional opportunity to address the resort-casinos applicants and the Commission. The meetings will also serve as a vehicle at which the community can receive updates from applicants on their resort-casino proposals and mitigation strategies. No vote or decisions will be made at these hearings; they are opportunities for the Commission to gather information and gauge public sentiment relative to the applications.
