Dear Massachusetts Gaming Commission:

I am one of many residents of Revere opposed to the proposed Suffolk Downs' Casino. I voted NO on November 5, 2013 and I'm outraged that Suffolk Downs and the City of Revere would move forward with a new Revere-only casino proposal.

Suffolk Downs' casino proposal failed on November 5, 2013. The developer was unable to choose or properly vet a casino operator. Unambiguously located in both East Boston and Revere, the developer failed to win the East Boston vote. Massachusetts law clearly states that if a proposed casino is located in more than one city or town it must win a referendum vote in both communities. East Boston said NO; Suffolk Downs' casino application is dead.

A new proposal to move forward with a Revere-only casino proposal at the Suffolk Downs' site is a deliberate effort to disenfranchise East Boston voters and circumvent the clear intent of the law. A Revere-only casino will not only negatively impact the residents of Revere, but would also still negatively impact the neighboring communities of East Boston, Winthrop and Chelsea. As a Revere resident, I'm concerned about these potential negative impacts a casino would bring to our community:

- Casinos Kill Jobs & Local Purchasing- Casinos in big cities don't add new jobs; they just transfer wealth from local spending to the casinos. Experts say every slot machine kills 1-2 jobs per year by taking money out of the local economy. Local businesses can't compete when customers choose to spend money at the casino, forcing them to lay off staff or close their doors. The promise of 4,000 jobs is a lie when there will be 4,000+ slots.
- Increased Crime Rates- Rates of assaults, larcenies, burglaries, robberies, murders and auto theft in areas around casino's go up significantly over time. The promised \$2 Million to Police and Fire Departments will not come close to mitigating the 22-114% rise in crime over time.
- Proximity to Schools & Mitigation Money- The site of the proposed casino is 1,000 feet from the Garfield Elementary School and 500 feet from the Beachmont Veterans Memorial School. There are 6 other schools within a 2 mile radius of the proposed casino site. Furthermore, the promised \$1Million in revenue is only 1% of the Public Schools annual budget. As a parent, I will NOT be sending my



children to Revere Public Schools exposing them to gambling addiction, crime, drug habits and increased traffic. I strongly believe that families will move out of Revere over time rather than move in.

- **Zoning Problems** The residents of the Parkway Mobile Home Park will be forced out of their homes to make room for the rezoned 12-story hotel. Promised casino revenue is trumping care for our current residents.
- Traffic Nightmares on Local Roads- Although you promise \$40 Million in road construction "improvements," it will actually take \$500 Million to solve current traffic problems on 1A without a casino.
- No Guarantees for Revere Residents- In the end, the deal gives residents little ability to renegotiate terms. We will be owned by Mohegan Sun.

Therefore I call on the Massachusetts Gaming Commission to adhere to the proper licensing procedures and application deadlines previously set forth.

The law is clear. I insist that Suffolk Downs' be immediately removed from consideration for a gaming license.

Ladies and Gentlemen;

Along with this letter are three letters which I submitted to local newspapers in May of 2012. All three letters are a cry for local representatives to work to position the community of Winthrop as a "Host Community" for any development at the Suffolk Downs location. This argument is relevant regardless of the exact location of the casino being in Revere, East Boston, or if it straddles the property line.

Winthrop is uniquely positioned unlike any other community in the Commonwealth, and Winthrop will be impacted at least as significantly as any host community. Below I summarize my argument to designate Winthrop as a "Host Community" with regards to a SD casino. The reason is:

- 1. Winthrop is less than a mile from the Suffolk Downs property.
- 2. Winthrop has only two egresses. In order to enter or exit Winthrop from either entrance you must pass by the proposed SD casino every time. Winthrop residents would always encounter added congestion. It is impossible for Winthrop residents to avoid the casino site to get home or for any travel whatsoever. This same condition would impact safety vehicles or ambulances which frequently shuttle Winthrop residents to hospitals for emergency services.
- 3. Being within a mile of the casino site Winthrop will be directly impacted by any changes in crime, property value, increased municipal spending, negative social impacts, etc.
- 4. As a community Winthrop has never even been asked or sampled as to what their position is on a SD casino project. In fact there is an active and organized anti-casino movement within the Community of Winthrop.
- 5. To grant the city of Boston "host or surrounding community" status, and to ignore the needs of the community of Winthrop is a dereliction of responsibility. Winthrop is far more impacted than Boston or any other community.
- 6. Winthrop is as impacted as any host community.

For these reasons I explore you to designate Winthrop as a host community in ANY development at the Suffolk Downs location.

I believe Josh Resnek missed the point in his casino Op-Ed in the Winthrop Sun Transcript (March 22) to Winthrop's detriment. Josh discussed the style and design of the casino he believes suits us best. Josh accepts the reality that our elected officials have made the casino at Suffolk Downs a foregone conclusion, which I also believe.

However, the responsible report should be that Winthrop is in a subordinated position in the casino process. The questions need to be asked, is a casino in our best interest and why is Winthrop's interest subordinated?. The desire to expedite the casino development with the least interference is not a good enough reason. Nor can we be seduced by the appeal of a finite development project.

Winthrop will be just as surely impacted by the casino as the communities of Revere and East Boston, and access to our community will be impacted on both entrances. Yet, Winthrop does not have equal status with either of these communities. We will be impacted seven days a week, 365 days every year for generations by issues such as congestion, crime, property values and safety.

The first step is to have a meaningful conversation about whether the citizens favor a casino at SD, the impact to Winthrop from a casino and mitigating measures we should expect from the citing of a casino at SD. Most importantly Winthrop's status in the process politically and legally should have been elevated. We must be in a leadership position in the negotiations, planning and mitigation process, and Winthrop's status should be upgraded now. We deserve "host community" status.

Our elected state officials have been entrusted to represent our interests. It is apparent we have not been represented properly in this issue We must demand more from our representatives, and we deserve more.

THE BELOW ARTICLE WAS SUBMITTED TO LOCAL WINTHROP TRANSCRIPT AND BOSTON HERALD NEWSPAPERS IN APRIL/MAY OF 2012

Clarifying the Issues.

In a letter to the WST on 4/26 I wrote that Winthrop does not have adequate representation of its interests on the casino proposed to be sited at Suffolk Downs. Mr. DeLeo responded that Winthrop was protected by the "surrounding community" designation. However, that is precisely the point: that Winthrop is relegated to "surrounding community" status and not host community status. A host community has the power of a vote on the issue, a surrounding community has no such power, nor does it have Host community leverage.

Winthrop is landlocked to a casino development at Suffolk Downs in East Boston and Revere. Due to this unique situation Winthrop cannot be separated from the communities of Revere and East Boston in status. Winthrop can neither escape nor avoid any impacts of congestion, crime, property issues, etc. and should be entitled to this special status. Our State Representative district is only Winthrop and some of Revere, and we should not be forgotten. Winthrop did not have a vigorous advocate when this legislation was drafted and a "2 mile rule" will not suffice.

Surrounding communities are defined in the law as "municipalities in proximity to a host community which the Commmission determines may experience or are likely to experience impacts from the development or operation of a gaming establishment, including municipalities from which the transportation infrastructure provides ready access to an

existing or proposed gaming establishment." This can include lots of communities and entitles the new Gaming Commission to determine adequate mitigation measures, if any, for surrounding communities.

I am sure the citizens of Winthrop believe mitigation that satisfies a politically appointed commission will not reach the level of scrutiny necessary to protect our homes and our community. Residents of Winthrop must decide Winthrop's future. This task can not be relinquished to some politically appointed Commission; none of which live in our District. To believe otherwise reflects an out of touch leadership.

Finally, jobs are important, but snapshots of job creation are meaningless. On May 5 in the Winthrop Transcript it was stated that we have gained 40900 jobs since March 2009, yet from January 2008 to date we lost 57900 jobs. From March 2008 to date Massachusetts lost 61800 jobs. The chilling reality is that Massachusetts was just ranked 47th, (3rd from the bottom as one of the worse states in America to do business) by Chief Executive magazine's annual survey just released in May. Additionally the Boston Business Journal on 2/24/2012 reported that a study by Chmura Economics and Analytics showed Mass has the highest underemployment rate of any state. The next closest state on the list had its underemployment rate at 2percentages points lower.

Indeed it is a strong private sector that creates job growth. And a dollar spent in the private sector has an economic multiplier effect which far exceeds a dollar spent by government. So the \$5.6 billion state spending increase (19%) over the last four years was irresponsible; using almost \$.5 billion of rainy day funds in this fiscal year alone. A jobs growth plan should contain the following. First, a reduction of the state personal tax rate to an already voter approved 5%. This would put more money into taxpayer hands and circulate that money throughout the state economy. Second, the state sales tax should be reduced to 5% to boost small businesses and make Mass businesses more competitive with surrounding states. Third, lower the state corporate tax rate to attract more businesses and jobs to Massachusetts. This will also help retain those businesses that are still in Massachusetts and return a vibrant economy.

But really, when it comes to the current condition of the economy in this state, The question to ask is, "are we better off today than we were in March of 2009?" (which last weeks letter to the editor referenced). We all know the answer, and new policies and new approaches are the solution.

Powerful Leadership or Flawed Representation?

In the Winthrop Sun Transcript the Independent News Group described our elected state officials as "powerful representation" in the "Our Opinion" article on page 6 of April 19 edition. However, read the adjoining column under Roll Call, and you will discover it is really flawed representation; Beacon Hill Roll Call, H3399.

Nestled inside the Budget Bill H3399 is a provision that bans debate about the new casino legislation. H3399 also bans proposing any amendments about casino gambling within the House of Representatives. Isn't this odd that our elected leaders are banned from addressing one of the most important issues in the state not to mention the local communities? A casino located at Suffolk Downs will impact Winthrop, Revere and East Boston for generations and our representatives have banned the discussion of it. This is not true representation and this is unacceptable.

In a letter to the editor on 4/12 I advocated for Host Community status for the community of Winthrop on the casino proposal. My position is that Winthrop is directly impacted by the casino development at Suffolk Down. Winthrop will be inaccessible without enduring the resulting congestion from a Suffolk Downs Casino and the local communities cannot avoid associated crime and the potentially negative effect on property values. At a community meeting on 4/17 Winthrop Town Councilor Linda Calla echoed my request for Host community status to our state elected representatives. This will NOT become a reality! Our own representative prevented Winthrop from becoming a Host Community.

H3399 bans debate of casino gambling, and it bans any amendments to the newly enacted gaming legislation. The "most powerful positions in Masachusetts," our own elected officials have silenced us. A result of what is tantamount to a gag order, we have lost our voice by those entrusted to represent us. This displays acute lack of transparency in leadership and government at our expense.

The question needs to be asked and answered, "where is our representation" and why did we tolerated this for so long?

Revere City Officials are Crossing the Line, Intimidating Local Businesses

Revere, MA – Revere city officials are trying to silence the voice of those opposed to the proposed casino. This past weekend representatives from Don't Gamble on Revere visited local businesses, where they politely discussed the issues with small business owners. Multiple businesses agreed to put "vote no" signs in their windows realizing the negative impacts a casino will have on their businesses. The business owners were receptive and generous. It was this kindness that was abused by city officials the following day.

On January 20th, Don't Gamble on Revere members noticed many of the "vote no" signs were gone and replaced by "vote yes" signs. When members asked the business owners, several looked concerned and said, "We don't want any problems." Business owners revealed that Revere City Council members took the "vote no" signs down. One business owner stated, "The man from the city came and took it." Many of the business targeted by the Revere City Council members are owned and operated by minorities, many whose first language is not English. Revere City Council members used their positions to intimidate small business owners to take their "vote no" signs down and replace them with "vote yes" signs.

During the day Don't Gamble on Revere group members ran into Anthony Zambuto, President of the City Council, in the business district of Shirley Avenue. When group members approached Zambuto, wearing his official regalia, he became irate and yelled, "Go preach your social justice garbage somewhere else." Later Don't Gamble on Revere members saw City Councilor, Ira Novoselsky, on Shirley Avenue. Members asked Novoselsky, "Are you switching the signs?" Novoselsky calmly responded, "Every chance I get." Don't Gamble on Revere members then found a "vote no" sign in a dumpster on Shirley Avenue.

This incident continues to reveal the injustice occurring in Revere neighborhoods during the weeks before the February 25th vote. Revere politicians are acting inappropriately in a blatant effort to skew public opinion. Joseph Catricala, spokesperson for Don't Gamble on Revere says, "We will not tolerate this behavior by Revere City Council members. The politicians elected to represent the public are instead trying to dictate and even bully Revere residents and business owners for the purpose of accelerating the agenda of Mohegan Sun. The City of Boston's host community status & administrative incompleteness of Mohegan Sun's RFA-2

Dear Commissioners:

No Eastie Casino is a municipal ballot question committee which represents the interests of Suffolk County residents who are opposed to a casino at Suffolk Downs. This letter is intended to summarize a number of notable issues relating to the RFA-2 filed by Mohegan Sun on December 31, 2013 in connection with the most recent iteration of its plan to site a casino at Suffolk Downs.¹

While we intend to file a comprehensive analysis of the RFA-2 in the near future,² this letter is intended to summarize our immediate concerns with this application prior to applicant Mohegan Sun's response to a surrounding community petition previously filed by the city of Boston.

I. ALL AVAILABLE EVIDENCE INDICATES THAT THE CITY OF BOSTON IS A <u>HOST COMMUNITY</u> FOR ANY GAMING ESTABLISHMENT AT SUFFOLK DOWNS.

A casino at Suffolk Downs remains a casino at Suffolk Downs, no matter its exact location within the 161-acre site. The Revere and East Boston sides of the Suffolk Downs parcel cannot be practically separated, and both communities will bear the substantial burdens which inevitably accompany any urban gaming establishment. The city of Revere was entirely correct in its argument on this point during initial negotiations with prior applicant Sterling Suffolk before being granted host community status, and we do not hesitate to unconditionally re-appropriate these arguments now.

The Expanded Gaming Act defines a "host community" as anywhere in which a "gaming establishment" is located; the premises of such an establishment include "a gaming area and any other nongaming structure related to the gaming area." M.G.L. 23K §2. Given the unique nature and transportation requirements of the Suffolk Downs site, Boston must qualify as a host community for a casino at Suffolk Downs under this (or virtually any) definition.

A ballot question which would have approved a gaming establishment at Suffolk Downs (with a legal address of 525 McClellan Highway in East Boston) was previously decided in the negative by East Boston voters in an election held Nov. 5, 2013. While the Expanded Gaming Act appears to contemplate that such a split result would not allow a gaming establishment to go forward on a site which spans two host communities, we recognize that this is a question which will not be answered short of judicial review.

² The publicly-available portions of Mohegan Sun's RFA-2 are voluminous, and our legal and policy analysis continues to be conducted on an entirely volunteer basis by concerned East Boston residents.

As a preliminary matter, we are disappointed that Mohegan Sun has withheld significant portions of its RFA-2 from the public in the guise of "trade secrets," and urge the Commission to reconsider its apparent decision to permit portions of this application which are of vital public interest to be deemed confidential pursuant to 205 CMR 103.

In the absence of more detailed plans, the only effective maps of the entire proposal are found at 4-05-01 (Schematic Design). While these basic blueprints do not include any indication of development beyond the Revere city line, it is also clearly apparent that significant improvements on the East Boston side of the property will inevitably be required.

From as much as we can ascertain from the publicly-available site map, the proposed gaming establishment is Boston-facing, and oriented to welcome the majority of visitors from the existing East Boston 1A Suffolk Downs entrance. Despite this fairly obvious point, the applicant posits that this entrance "is available for existing [racetrack] users" and that the current main gate "will not be signed or encouraged for use." We do not share the applicant's optimism in this regard. Regardless, it is beyond question that significant improvements will be required to Tomasello Way along the entirety of the lengthy entryway into the site.

The only other points of entry to the casino would be at 1A in Revere at Furlong Drive (currently serving a heavily-trafficked shopping plaza) and a major thoroughfare at Winthrop Avenue near a major entrance to 1A. Given that 1A is expected (by Mohegan Sun's own estimate) to carry up to 80% of the gaming establishment's traffic and the existing dedicated Suffolk Downs 1A entrance is by far the most convenient point of entry to the site, we feel that further close study of this point is necessary.

In light of the above, we aver that Boston's claim to host community status is equal to (or possibly even greater than) that rightfully held by Revere in the pre-November 5th proposal previously advanced by former applicant Sterling Suffolk LLC. While the gaming establishment and structural improvements for Suffolk Downs were proposed entirely upon the East Boston side of Suffolk Downs site, the city of Revere immediately claimed and received host community status. A brief misunderstanding on this point which arose during the summer of 2012 led the editors of the Revere Journal to respond that any claim that Revere was not a host community for a casino at Suffolk Downs was "specious at best, foolish and uninformed at worst" as well as "factually and legally incorrect." We recognize no cognizable difference between the latest iteration of the so-called "Revere-only" gaming establishment and the prior plan which was based almost entirely upon the East Boston side of the property.

Boston Mayor Martin J. Walsh has recently expressed his concern that the city of Boston has not been provided with the amount of time or detail necessary for the city to effectively review or argue its host community status. ⁵ While the Commission ultimately declined to allow more time for this purpose, we continue to agree with this position and reiterate Mayor Walsh's request that the city be permitted to fully brief and argue the case for host community status before the Commission.

Finally, Suffolk Downs remains an integral part of the casino development plans on its property, and its attempts before this Commission to maintain the legal fiction that will merely be a "lessee" to applicant Mohegan Sun fall far short of the mark. An objective observer need only review its most recent round of marketing and promotional materials⁶ to find that Suffolk Downs refers to Mohegan Sun as "our partners" and continues to promote the casino development project as key to preserving the racetrack. We also find it significant that even the initial draft terms of Sterling Suffolk's proposed lease to Mohegan Sun have not been released.

II. MOHEGAN SUN'S RFA-2 IS ADMINISTRATIVELY INCOMPLETE, AND SHOULD NOT BE ACCEPTED FOR FURTHER REVIEW.

"If an applicant is unable to comply with or respond to any part of the application it may apply for a waiver or variance from the Commission in accordance with 205 CMR 102.03(4) in advance of the filing deadline." RFA-2, p. 6. The Commission will then review the applications for administrative completeness, and applications which are deemed administratively incomplete shall be given no more than seven days to cure a material deficiency or fourteen days to cure a non-material deficiency.

Three weeks prior to the December 31, 2013 submission date,⁷ the Commission invited this applicant to file a waiver of perhaps the single most important component of an application for a Massachusetts gaming license: the requirement that the certified results of a successful voter referendum in the host community be filed with the application. This waiver was filed and granted by the Commission shortly thereafter. The applicant has neither requested nor received any other waivers.

While we believe there are a number of respects in which Mohegan Sun's RFA-2 might be deemed administratively incomplete, one clear deficiency stands out: the applicant's failure to include an Environmental Notification Form and certificate from the Secretary of the Executive Office of Energy and Environmental Affairs pursuant to 205 CMR 119.01(b)-(c).

The Environmental Notification Form is far more than a technical formality. This component of the RFA-2 is absolutely essential, especially in a project on the magnitude of a resort casino with the potential to significantly impact nearby delicate ecological sites. The RFA-2 as filed on December 31st does not include an ENF or EOEEA certificate from this applicant.

As plainly stated in the RFA-2, an application for a gaming license "does not constitute an offer of any nature or kind to any applicant or its agents," and "the Commission is under no obligation to issue a license to any of the applicants." RFA-2, at 6. Applicants should be strictly held to filing requirements and deadlines, and

As a racehorse owner and breeder in the state, I wanted to share my concern over Suffolk Downs' proclamation that they will continue live racing.

For starters,

- 1) where will they house the horses? We all know there is no room on the East Boston side to relocate the number of barns to accommodate horses.
- 2) their announcement to race offsite is total BS. It is incredible unrealistic and improbable to house horses off site and maintain training and races. Saratoga is the only track that does so and they have a separate training track called the Oklahoma training track to accommodate their offsite horses and provide training. This is Boston! Where are they going to find a facility to house hundreds of horses WITH an appropriate sized track.
- 3) If off-site, where is the exact location and is there at least a 6 furlong track present? I know of ZERO 6 furlong tracks in the area (6 furlongs is the minimum size for speed work). A 1/2 mile track for speed/gate work is deadly and not a valid option.
- 4) please ask them where they plan on housing the backstretch workers? EVERY track has housing for the backside grooms and exercise riders.
- So, their statement that they will house offsite is INSANELY UNREALISTIC.

It is also not possible to force horses to have to trailer in DAILY just to train and gallop and do gate work if no site off the property is available.

Just wanted to send a message to you to please do proper diligence and gain access to these answers. Don't t take their word for anything. Take the time to speak with other tracks and other gaming commissions to find out what is truly realistic for racing.

Obviously, I want to see live racing continue but not in an abhorrent, impossible form that leaves no room for a safe and realistic existence.

Re: Provisions of Massachusetts General Laws Chapter 23K regarding Horse Racing

Dear Chairman Crosby:

On behalf of the New England HBPA and the Massachusetts Thoroughbred Breeders Association, we are writing to further address our concerns related to recent events that appear to derogate from the legislative intent to require a gaming licensee who has been engaged in racing or simulcasting to continue such business upon the award of a gaming license. By correspondence to you dated December 6, 2013, we previously addressed our concerns relative to the proposal of Sterling Suffolk Racecourse LLC (SSR) to change the name on its application to Mohegan Sun. We now understand the Mohegan Sun application is being viewed as a different application from the prior submission of SSR and that SSR has asserted it is a landlord and not an applicant.

There was a clear intent of the legislature when addressing gaming legislation to protect existing live Thoroughbred racing at Suffolk Downs, the Massachusetts breeding industry, horse farms, the associated agricultural network, and the thousands of jobs in these industries. Chapter 23K expressly acknowledges the objective to preserve jobs in existing industries in the Commonwealth. The Massachusetts Gaming Commission was accorded the duel responsibility of oversight and regulation of both gaming and horse racing in the Commonwealth. Application is now pending for a license to conduct gaming on the Revere Massachusetts portion of the Suffolk Downs property. We understand that the provisions of Chapter 23K that pertain to horse racing may not apply if the Mohegan Sun gaming application is successful because SSR is not the applicant.

We believe that the provisions of the statute imposing additional requirements upon gaming licensees that have been engaged in racing reflects the intent of the legislature to require the continuance of existing racing and simulcasting businesses on parties benefiting from a gaming license. We believe that in the event a gaming establishment operates on the SSR property, SSR will enjoy the financial benefits that caused the legislature to impose certain obligations if SSR were the gaming licensee. We believe that the statutory obligations related to continuance of horse racing were intended by the legislature to be imposed in the event a gaming facility operates on the SSR property and seek action by the Commission consistent with this legislative intent.

Since last fall, the NEHBPA has sought to negotiate with SSR a purse agreement for the upcoming 2014 racing season. SSR has recently begun to negotiate with the NEHBPA on a contract. If SSR presently held a gaming license, Chapter 23K would mandate arbitration by the Massachusetts Gaming Commission and cause the matter to be timely resolved. The lack of a contract negatively impacts the prospects of a successful meet as it causes horsemen to consider alternative venues due to the uncertainty of the local situation. We believe that if SSR enjoys the benefits it will receive from the presence of a gaming facility on its property, then the Massachusetts Gaming Commission should impose upon SSR the obligations intended by the statute.

We also ask the Massachusetts Gaming Commission to address relocation of the barns utilized for horse racing. These barns are presently located on the Revere portion of the SSR property. Construction of a gaming facility at that location necessitates removal of the barns. We suggest that it is appropriate to require that adequate barns be constructed on the SSR property in East Boston adjacent to the racetrack. An offsite barn facility as now being considered will be detrimental to horse racing and could result in significant job loss from Massachusetts if a remote site such as Rockingham Park is utilized as the barn area.

We are requesting that in the event a Category 1 license is awarded to anyone utilizing any portion of the Suffolk Downs property for gaming that a condition be imposed on the license requiring compliance with the provisions of the General Laws that would apply had the license been awarded to an applicant with a live racing license under Chapter 128A as of July 1, 2011.

Thank you for your consideration and for providing us with an opportunity to offer our comments.

WalkBoston has reviewed the Notice of Project Change (NPC) for the Mohegan Sun Massachusetts project in Revere and offers the comments below.

The NPC was prompted by the shift of the project location to Suffolk Downs property that is located solely in Revere. This change will have significant impacts on pedestrian movement into and through the project. The elements of the project – two hotels, large gaming space, numerous restaurants and spa- have not changed. But, in the new location, the buildings have a substantially reduced footprint and are much closer to existing business and residential areas.

Walking Access to Transit - Beachmont MBTA Station
The principal impact of the project change for people arriving on foot is the much greater proximity of the development to transit access, now shifted to the Beachmont MBTA Station (formerly focused on the Suffolk Downs Station). The revised location for the proposed resort places the main entrance only 300 feet from Beachmont Station, and will likely shift some trips from autos to transit because of this proximity.

In order to encourage transit and walking trips, we suggest exploring several pedestrian amenities including the following:

- A significantly wider sidewalk along Winthrop Avenue between Beachmont Station and the site of the resort.
- An weather-protected sidewalk along Winthrop Avenue between the primary entrance and exit locations at Beachmont Station to Washburn Avenue. The canopy or arcade should connect directly to the existing MBTA station entrance which already has weather protection.
- A weather-protected walkway from the edge of the resort property on Washburn Avenue to the main resort entrance.
- Significant upgrades in wayfinding inside Beachmont Station and along the route to the resort to encourage transit

ridership and reinforce the convenient transit access.

- Upgrades of escalators and elevators inside Beachmont Station to adequately and safely handle greater numbers of riders using transit.
- Signalization or signage protection for pedestrians crossing Washburn Street on the south side of Winthrop Avenue.

Traffic mitigation

We are fearful that the project will add a great deal of traffic to an area that cannot handle it easily. Winthrop Avenue and the Revere Beach Parkway are heavily used already. Improvements to the interchange with Route 1 will only add to the use of these streets, which cannot easily accommodate them.

Better access might be provided via Tomesello Way, from Route 1A the Suffolk Downs Racetrack parking areas, which will have greater capacity for storage of vehicles and a more orderly approach to the casino. We think the proponent would be well advised to encourage use of Tomesello Way and the MBTA Blue Line for principal access points into the casino property.

In addition, the parking garage is enormous, suggesting a commitment only to vehicular access. Perhaps the proponent could save some of the construction cost of this garage through the use of thoughtful techniques of encouraging patrons not to drive - perhaps a benefit of some sort that patrons could use on the floor of the casino.

We appreciate your consideration of our comments and look forward to your responses to them.

RE: Opposition to Casinos in General, and Comment on Mohegan Sun Casino's Suitability as a Resort-Casino Applicant for a Development in Revere

Dear Commissioners:

I am writing in opposition to casinos in general and, specifically, in opposition to Mohegan Sun's operating a casino in Revere. My perspective is that of an East Boston resident, a deacon in the Roman Catholic Church and an attorney.

OPPOSITION TO CASINOS IN GENERAL

In addition to the obvious problems that casinos bring to communities such as more crime, traffic nightmares on local roads, air polution, harm to local businesses, gambling addictions, divorces and personal bankruptcies, I would like to briefly address the alarming connection of casinos and suicide. Tom Larkin, a licensed psychologist and President of United to Stop Slots, wrote in "The Social Costs of Gambling," "Suicide 'Suicide attempts are higher among gamblers than for any of the addictions.' --Dr. Rachel A. Volberg. This is a complex subject but suicide rates (including teenagers) in gambling counties are 2 to 4 times greater than nongambling counties. Las Vegas has the highest suicide level in the country. In Atlantic City, abnormally high suicide levels appeared, for vistors and residents, only after casinos appeared." The sources he cited were: Kindy, John, (Ed). US International Gambling Report, Hein and Co. 2008; and Phillips, David P. Ward Welty and Marrisa Smith. "Elevated Suicide Levels Associated with Legalized Gambling." Dec. 1997 (on line). Further, in 2013, the Institute for American Values, in "Why Casinos Matter," noted in a report by the Council on Casinos, at page 20, "Spouses [of gamblers] are harassed by bill collectors and suffer a wide range of stress-related physical and mental problems; they attempt suicide at three times the rate of the general population."

We all have a moral obligation to protect our families, our children, our grandchildren, our neighbors and generations to come from this very real threat to their lives. One life lost to casinos is one life too many. Certainly, many lives will be lost to suicide through casino gambling in Massachusetts, and many families will be forever shattered. If we know that casinos will increase suicides, and we welcome them into our communities, we share in the responsibility for these foreseeable deaths.

Some will compare the casino-suicide issue to alcohol use and the number of deaths that will be caused every year by drunk drivers. Should we outlaw alcohol because we know that deaths will be caused by drunk drivers?

We tried prohibition once and it did not work. Alcohol and the trouble it brings are here to stay, but casinos do not have to be. The people of Massachusetts are not crying out *en masse* for casinos. Rather, it is the casinos who, like predators, are advancing to prey on those who can least afford to gamble, i.e., the poor. One of the 7 themes of Catholic Social Teaching is the option for the poor and vulnerable. Our Catholic tradition instructs us to put the needs of the poor and vulnerable first. In contrast, it is from the poor and vulnerable that casinos extract most of their profits, thereby putting them last.

This is a matter of public health. Note that the Host Community Agreement between Revere and Sterling Suffolk Racecourse in paragraph 2M states, "The owner shall mitigate the potential negative public health consequences associated with the Project." However, none of the negative public health consequences are specifically named.

Arguably, this loss of life could also be considered a matter of public safety. Consider the Wikipedia definition of public safety: "[This term is used in many capacities by counties, states, cities, and regions to describe the authority and responsibilities the entity oversees. The public safety issues a city might grapple with include narcotic use, trespassing, burglary, harassment, juvenile delinquency, unauthorized living, noise, littering, inappropriate social behavior, DUI's, and other quality of life issues.] The following definition only looks at a higher level of function such as a county task force: involves the prevention of and protection from events that could endanger the safety of the general public from significant danger, injury/harm, or damage, such as crimes or disasters (natural or man-made)." Families of victims of suicide caused by gambling addictions would clearly see casino gambling as a matter of public safety, just as we all would see the selling of heroin and the deaths associated with it as a matter of public safety. Because casinos present serious problems of public safety, especially loss of life, they should be kept out of our communities.

Sadly, casinos in America today are making an increasingly large contribution to what has been described by Pope John Paul II as a "culture of death." Rejecting or supporting casinos is ultimately a question of who we are and what we value more—human life—or money and entertainment. Sometimes, as with casinos, the cost of an economic quick-fix is just too high.

OPPOSITION TO MOHEGAN SUN IN REVERE

I am also writing to comment on the lack of suitability of Mohegan Sun to operate a casino in Revere. Hartford Business.com reported on June 1, 2012 that the owners of Mohegan Sun refinanced \$1.6 billion in debt. On January 30, 2014, Businesswire.com reported decreases of revenues for the Mohegan Tribal Gaming Authority for the first quarter of fiscal 2014 as compared to the first quarter of fiscal 2013 in the areas of net revenues (3.7%), gaming revenues (5.1%), gross slot revenues (2.5%), table game revenues (11.2%), and income from operations. Income from operations decreased by 36.3% from the first quarter of fiscal 2013. It appears that the only area in which an increase was made was in the area of non-gaming revenues, an increase of 8.5% over the first quarter of fiscal 2013. Lastly, in the same article, Businesswire.com reported for the first quarter of fiscal 2014 a "Net loss attributable to the Authority of \$67.3 million compared to net income to the Authority of \$9.1 million [for] the first quarter of fiscal 2013."

The numbers speak for themselves, and they do not inspire confidence in the ability of Mohegan Sun to operate a new casino in Revere. I would respectfully ask how an organization as deep in debt as Mohegan Sun, and showing continuing decreases, can now be trusted and relied upon to enrich the economies of Revere and Massachusetts? Given its on-going financial problems, even with outside money to prop it up, it seems all too possible that Mohegan Sun, even with "best efforts," may not deliver.

Dear Chairman Crosby:

We are writing today to ask to open a dialogue with the Massachusetts Gaming Commission in order to maximize the benefits of a new casino in Eastern Massachusetts to the region's communities as envisioned in the legislation. Regardless of where a casino is sited, low income and diverse communities face particular impacts but can also receive huge benefits from a project of this magnitude through shared commitment and careful planning. We are writing to request both a meeting and continued dialogue going forward.

We are broad regional coalition that extends from Somerville across the river to Malden, Everett, Chelsea, to East Boston, Roxbury, and Dorchester. Community groups, religious groups, and issue-based organizations focused on returning citizens, housing, good jobs and access to good jobs have all come together to reach out to you today. Action for Regional Equity, the convening organization, is a multi-issue, regional coalition founded on the principle of equity. We recognize that equity is a strong economic foundation for the whole economy and our whole region, as well as a social justice principle.

We have seen that some parts of our communities have not been active participants in the debates surrounding casinos. For example, in both Everett and East Boston, we have documented that immigrant communities have had less information and less opportunity to make their needs heard. We want to ensure that as we move into implementation, this weakness is remedied.

We recognize and applaud the debate that has been fostered by the public process across the state and the work done within each potential host community to shape an agreement to meet local needs. Nevertheless, we believe there is still a need to identify a few issues we believe have not received sufficient attention. We have attached a list titled **Issues to Discuss**. We want to ensure that we apply lessons that have been learned elsewhere and adopt the most creative and effective strategies possible. The time for this conversation is now, before final decisions are made.

We look forward to hearing from you about a meeting time to open this discussion with the hopes of establishing an ongoing working group during this lengthy start-up period.

ISSUES TO DISCUSS

Job standards: While many jobs will eventually be covered by collective bargaining agreements, it is possible that not all will be. We are addressing this issue to ensure that all positions—even those such as contracted workers working in retail outlets or fast food on the property—will be living wage jobs that can support our families and sustain our communities. We believe that all jobs on the property should be at above minimum standards, regardless of the position.

Our goal is permanent full time jobs with benefits, including the following:

- Living wage jobs standards including permanent, living wage, full time jobs, with health and other benefits, and with stable shifts and hours
- Contracted workers have the right to retain their jobs for 90 days if a contractor changes
- Requirement to pay the "standard" wage if there is a dominant labor union in the particular occupation
- "Labor peace" requirements to ensure the maximum possible share of jobs have collective bargaining rights
- Right to be free of retaliation for using the rights provided here

Job access: We are concerned about access to both construction jobs and the permanent jobs that follow. Much of the public policy surrounding opening casinos has focused on jobs and the potential impact of access to those jobs for specific communities. We hope to partner to ensure we achieve these goals. While the host agreements have been vague, it is now time for concrete requirements.

In addition, successful job access for diverse communities requires the creation of gateways and pathways—not just putting out a sign and saying apply here.

While host agreements specify local hiring, community colleges are already training people without regard for their residency. We know the Gaming Commission is already considering the problem of recruiting enough people. We want to ensure that diversity standards including gender, income, people of color, and age, be met, as well as local hiring goals from the region surrounding any proposed casino. We also want to minimize predatory training that costs those seeking work and does not result in a job.

With a large project and long time horizons, particularly for permanent job hiring, we have an opportunity to work collaboratively to implement effective pipelines for both construction and permanent jobs.

- Diversity: We are proposing hiring goals that mirror the diversity in the communities surrounding the final site for both construction and permanent jobs.
- CORI backgrounds. As we have noted in other statements to you, we want to maximize the number of jobs available to applicants with CORIs, set goals for how many hired, and then monitor hiring. The stringent requirements set in the legislation place even greater demands on the Commission to make this happen.
- Gateways and pipelines.
 - Construction: Job access should build on the programs such as Building Pathways and YouthBuild that are now underway, but not be limited by them. Opportunities for workers who want to return to unionized construction but need a loan to pay back dues or who have skills but need a way in should also be part of the overall program. Retention will matter. Funding needs to be available for preapprentice programming, for a job placement program for those not needing pre-apprentice training, and retention services.
 - Permanent jobs: Pre-placement services such as ESOL and job readiness training should be available starting well before any hiring starts—at least six months before and possibly earlier. We would like to work with you and others to identify and target funding now.
 - Community gateways: For both construction and permanent jobs, community organization rooted in their constituencies need to serve as gateways for their communities. These are base-building organizations, churches, and other similar organizations that can build relationships both with the public workforce system and employers. For them to play this critical role, they need a small amount of funding.
 - O Workforce partners. We hope the Gaming Commission will convene the public workforce development system, community colleges, organizations working with returning citizens, community gateway

organizations, unions, developer, owner and contractors to shape a plan that will ensure success of this critical policy element.

Enforcement. We have learned that enforcement of standards and access requirements such as these is not easy or automatic. As a result, we are suggesting we discuss the following set of practices that can ensure effective implementation, compliance, and enforcement.

- Creation of an "Access and Opportunities Committee" representing developer, employers, labor unions, Gaming Commission and community organizations to monitor access and enforcement of both job access and job standards. The participation in the committee can change as the site moves from construction to operations.
- All commercial contracts shall include requirements to implement the agreed upon standards and information requirements, making each contracting entity obligated to enforce the requirements on its contractors.
- All employers shall provide agreed upon information related to implementation of these requirements to its contracting entity or other agreed upon intermediary in a timely manner in the form required.
- All employees covered by these obligations have the right to make a payroll deduction to a non-profit worker education and service entity that will carry out information dissemination and support for employees.
- In addition to any agency enforcement, all employees covered by these obligations have the right of private action to enforce any provision set out for job standards.
- To reduce or eliminate labor-related disruptions, including retaliation against employees, upon request from a labor organization, all employers shall agree to a "labor peace" agreement.
- Penalties for failure to comply with standards need to be set. These need to include loss of contract and loss of right to bid.

DISPLACEMENT OF TENANTS AND SMALL BUSINESSES

Across the country, major developments are leading to residential and small business displacement. Re-zoning in areas around new casinos will allow current landlords and landowners to make their own decisions to stay or leave. We are primarily concerned with the immediate impact on tenants and small businesses.

We are proposing that an audit be conducted in the area immediately surrounding any licensed casino to:

- (1) Map an "eviction-free zone" around the final site with the commitment that no one in that zone be displaced by this development
- (2) Survey and identify by name and situation all residents and small businesses that may be impacted
- (3) Identify if programs exist to assist them in staying in the town and what further step should be undertaken.
- (4) A committee including community residents should be convened to assist in this process and the review of results.
- (5) It should be completed within 6 months after the designation of a casino. Resources should be identified to be tapped if necessary to mitigate displacement and maintain the community.

The Mystic River Watershed Association (MyRWA) appreciates this opportunity to comment at the Public Input Meeting for Mohegan Sun Massachusetts, a destination resort casino proposed at the Suffolk Downs racecourse in Revere, Massachusetts.

The Mystic River Watershed Association is a 501(c)(3) nonprofit organization founded in 1972 by a group of concerned citizens. The Mystic River Watershed Association's mission is to protect and restore clean water and related natural resources within the basin's 22 communities and to promote responsible stewardship of Mystic River natural resources through educational initiatives and science-based advocacy.

As an environmental organization, we are particularly attuned to how proposed projects will impact existing environmental conditions within the highly urbanized areas of Mystic River communities.

The Mystic River Watershed Association has been actively engaged in evaluating the prospective environmental impacts of both of the resort casinos proposed to be built in the Mystic River Watershed.

While we greatly respect that there are many other issues about which Mystic River communities will be concerned, throughout this process the Association has maintained steady focus upon environmental issues associated with casino development. Broadly, these issues include impacts on water quality, wildlife and aquatic habitat, wetlands impact and protection, wastewater and stormwater management, and water conservation.

On September 25, 2013 the Mystic River Watershed Association and the US EPA Mystic River Steering Committee hosted a special presentation on the environmental impacts of both proposed Mystic River casinos. Over 80 people attended this public meeting and had the opportunity to ask questions of each proponent. Attendees agreed with the Mystic River Watershed Association that

casino proponents have a unique opportunity to provide leadership in efforts to protect the Mystic River and restore this important natural resource.

The Mystic River Watershed Association would like to request that the Massachusetts Gaming Commission give strong consideration in its decision making to initiatives that provide for protection and restoration of the local environment. Such initiatives that are included in the resort casino development proposals and gaming license applications will become an important component of the benefits that result from Casino development in Massachusetts.

We urge the commission to study and evaluate carefully the Expanded Environmental Notification Forms, the Draft and Final Environmental Impact Reports and the Secretary of Energy and Environmental Affairs Certificates, as these documents ought to provide a clear and unambiguous picture of the proponent's treatment of and contribution to improving and enhancing the Mystic River Watershed. Restoration and preservation of local natural resources in the Mystic River Watershed will provide important benefit to all residents of the host and surrounding communities.

Given its extraordinary scale and scope, the Resort Casino project proposed by Mohegan Sun Massachusetts at Suffolk Downs represents an extraordinary opportunity for proponents to provide important leadership and support for the transformation of this hardworking urban river system.

To support this interest, the Mystic River Watershed Association has met with representatives of Mohegan Sun Massachusetts and its consulting team to outline specific ways that additional protection and restoration of the local natural environment can be incorporated into the development process and we are pleased that Mohegan Sun Massachusetts has been responsive to these recommendations.

In addition we have outlined a number of concerns in letters to the Secretary of the Executive Office of Environmental and Energy Affairs.

We have noted that the project site includes portions of Sales Creek and abuts Belle Isle Marsh, part of the Rumney Marshes Area of Critical Environmental Concern. The Rumney Marshes Area of Critical Environmental Concern encompasses over 1,000 acres of highly productive salt marsh, salt meadow, tidal flats, and shallow subtidal channels. This Area of Critical Environmental Concern is extremely valuable to our region for the habitat, climate resilience and other environmental services it provides. The Association seeks to ensure that any potential impacts on this critical environmental resource be closely scrutinized and mitigated.

We have also recommended that:

- Best Management Practices be used to remove nutrient loads and other urban pollutants from stormwater discharges
- Additional setbacks and improved treatment of Sales Creek be undertaken
- The proponent develops a lower Mystic River watershed inventory that delineates all
 opportunities for potential ecological restoration. Such an inventory will help provide a
 much needed foundation through which to prioritize prospective habitat and ecological
 restoration projects in the area

The Mystic River Watershed Association plans to monitor and remain in contact with the proponent and relevant authorities during the preparation of the Notices of Intent and all other State and local permit applications to be filed under the Massachusetts Wetlands Protection Act and other State and local ordinances. We are encouraged by efforts to date and the stated commitment of the Mohegan Sun Massachusetts development team to setting high standards of excellence with regard to site design and environmental protection. We look forward to the opportunity to review in greater detail plans for the Resort Casino and the ways that proponents will support restoration of the local natural environment through this significant project.

It is important to our efforts and to efforts of all local and regional environmental advocates that the Gaming Commission makes a clear statement that protection and restoration of the local natural environment is a high priority of the commission and a component of the license provided.

We write in support of the Mohegan Sun Massachusetts at Suffolk Downs resort casino application. The Mohegan Sun Massachusetts plan is comprehensive, well-thought and thorough.

Mohegan Sun Massachusetts is a \$1.3 billion destination resort proposed for Revere. Mohegan Sun Massachusetts will be a world-class destination resort casino that evokes the rich and deep history of Revere and Greater Boston. To the MGC:

I am writing to express my opposition to the proposed Mohegan Sun casino at Suffolk Downs. Not only do I believe that the proposed casino will have negative impacts on the communities of Revere, East Boston, Winthrop, and Chelsea, but I believe that the proponents of the Suffolk Downs casino have shown a blatant disregard for the gaming legislation and other relevant laws, specifically:

- Suffolk Downs' casino proposal failed. M.G.L. c. 23K, § 15(13) clearly states that if a proposed casino is located in more than one city or town, it must win a referendum vote in both communities. As you are well aware, East Boston voters overwhelming rejected the casino proposal at Suffolk Downs. Therefore, Mohegan/Suffolk Downs' ongoing pursuit of a license is in violation of the gaming legislation and is an attempt to disenfranchise East Boston residents and circumvent the clear intent of the law.
- Mohegan/Suffolk Downs failed to follow the proper licensing procedures stipulated by M.G.L. c. 23K, 205 CMR and the MGC's own application deadlines previously set forth.
- Mohegan/Suffolk Downs violated the confidentiality requirement of its negotiations with a surrounding community (Winthrop) and through this breach, is not negotiating in good faith with an impacted town.
- Mohegan/Suffolk Downs has failed to complete accurate environmental impact studies, and is instead attempting to
 utilize prior studies for its earlier, substantial different, casino proposal with Caesars Entertainment. Not only were
 environmental impact studies required to be filed as part of the MGC's application process, but such information is of
 critical importance as the MGC and potential host/surrounding communities attempt to assess the proposed projects.

In light of these actions (as well as a substantial fine paid to the EPA for environmental violations, which occurred prior to the licensing process), I do not believe that Mohegan/Suffolk Downs can be entrusted with a casino license or to fulfill any of the requirements of their host/surrounding community agreements. If Mohegan/Suffolk Downs is willing to break and disregard the law BEFORE a license has been awarded, it is clear that such behavior will continue, and likely worsen, in the event they are successful with their MGC application.

The MGC should not award a license to Mohegan/Suffolk Downs, as doing so would not only be an affront to voters in East Boston, but to all of the other gaming applicants who have acted in good faith and followed the rule of the law in their pursuit of a license.

My name is Leslie Gould and I am the President/CEO of the **Lynn Area Chamber of Commerce** representing over 400 businesses in the communities of Lynn, Lynnfield, Nahant and Swampscott.

On behalf of the Lynn Area Chamber of Commerce, job creation and economic vitality are always a central focus.

Our role as a Chamber is to not only fight for the economic health and vitality for our local business community, but identify our regional connections to see where we fit and how we can work together to create positive progress.

I know what Suffolk Downs was and I know what Suffolk Down can be; and I would hate to see it closed after all those years, with the elimination of local jobs, the virtual demise of the horse racing industry in Massachusetts and the loss of all that history in Boston and Revere.

Having such fond memories of East Boston and Suffolk Downs, I was truly shocked when my hometown rejected the hotel and casino proposal that would have revitalized the racetrack and created new hotel and casino facilities as part of a larger new destination resort. East Boston would have benefited far more than Revere from the new hotel and casino facilities, which were all located in East Boston. East Boston and Revere were both host communities; but East Boston was host to the hotel and casino and Revere was host to the old stables and the parking. Not a particularly equitable arrangement, in my view; and obviously I like the new arrangement much better.

Nonetheless, Revere voters overwhelmingly supported that initial proposal and East Boston voters did not. If they had, we would not be here today; but there is no going back. Quite the contrary, we are moving forward. In a prompt and positive reaction to the surprising rejection by the East Boston community, Revere Mayor Rizzo and his team responded with a proposal to

locate the hotel and casino in Revere, with Revere alone as the host community. In February of this year, Revere voters even more overwhelmingly supported the proposal for a Mohegan Sun hotel and casino on our side of the city line. And we have now voted in favor of a hotel and casino on the Suffolk Downs reservation twice in the last six months.

Revere and East Boston both made the choices to which we were entitled. And those choices have consequences, for better or for worse, whether expected or unexpected, intended or not. Now Boston wants to regain the host status that it rejected in November. And it is not just that Boston wants it both ways, which is bad enough; it is that Boston now seeks to make the Revere vote in February meaningless, as they made the Revere vote in November irrelevant. That is disturbing and offensive to me as a citizen. Is this supposed to be democracy in action? Do not Revere voters count for anything? I obviously think we should; and I think the Massachusetts Gaming Commission should insure that we do.

Does the proposed Mohegan Sun hotel and casino in Revere impact East Boston? Of course it does. Does the planned relocation of the stables from one side of the Suffolk Downs reservation to the other impact East Boston? Of course, it does. Can these and other impacts be minimized and mitigated? Of course they can – and they should be. The fact is that Boston had already addressed and resolved such impacts in a Host Community Agreement that was made irrelevant by the East Boston vote. Now those project mitigation plans need to updated and incorporated into a Surrounding Community Agreement. That should be Boston's focus and priority, rather than seeking to regain the host community status they rejected in November and is not now warranted.

The fact of the matter is that East Boston did not think beyond the November vote; and Revere did. Revere officials responded with dexterity and with imagination; and they came back to the table with a proposal that preserved and enhanced the benefits of the hotel and casino for our community. Revere continues to support a hotel and casino on the Suffolk Downs reservation because the Host Agreements that we voted for in both November and February would update our transportation infrastructure, improve our school system, expand local job opportunities, support our local businesses, and provide more recreational opportunities for our residents and visitors.

It would also be a catalyst for long-awaited redevelopment of our oceanfront properties, many of which have been vacant for decades. If you are not sure what I am talking about, take a ride down Revere Beach Boulevard, along the first public beach in America, to see what it is now and to imagine what it can be in the future. And while your are at it, drive by the closed and shuttered Wonderland Racetrack to get some idea of what Suffolk Downs might soon look like if the Massachusetts Gaming Commission fails to approve this proposal.

In sum, the Mohegan Sun proposal can begin the renaissance Suffolk Downs as an integral element of a new regional recreational destination; and it can also begin the Revere renaissance. East Boston may have benefited from the development boom in Boston; but Revere clearly has not. East Boston may not want or need a new hotel and casino; but Revere certainly does. And Revere should not be denied this once-in-a-lifetime opportunity simply because East Boston rejected it. The residents of Revere want Mohegan Sun; the taxpayers of Revere need Mohegan Sun; and by all that is right and fair, the voters of Revere should not be ignored.

Remarks from J. Justin Pasquariello

East Boston voted no, and I shouldn't be standing here right now.

Chairman Crosby, on September 13, 2013, you said "it would be paternalistic to deny them the opportunity" to vote on casino gambling. You also said you wouldn't want one too close to your town because of the impact on property values.

The theory that each town's people should be given the right to determine whether or not a casino will come to their own town would seem to be a fair one.

Unfortunately, there has not been a fair vote yet on this issue in this Commonwealth. In every vote, the cards have been stacked against casino opponents—and so the true right to self-determination on this issue has not been realized.

Chairman Crosby, you suggested some communities need casinos more and would make different decisions than you would because of that. I interpret the data differently. Beating a political opponent takes money. In the case of casinos, to have a fair and equal fight would cost literally millions of dollars. Casino operators know wealthier towns like Wellesley, Weston, Lexington and Longmeadow can afford to fight that fight.

The legislature, the casinos, and our past city leaders assumed East Boston could not afford to fight—and would not fight. The state legislation was written specifically so East Boston could have an independent vote—rather than having the entire city vote. Let's be clear: this was not to give power to the people of East Boston—this was to help lead to an easy vote with low resistance, so Suffolk Downs could build a casino. And let's be clear about Suffolk Downs' relationships to our elected officials. The owners of Sterling Suffolk—and family members of those owners—consistently maxed out on donations to our elected officials—both when they were pushing to legalize gambling in Massachusetts and when they were pushing to put a casino in my backyard in East Boston.

Those owners and managers have much better access to our elected officials than the people in this room representing our no vote have. I have often seen them standing together, talking and laughing at community events. How could a vote ever have been fair?

Why did so many people want East Boston alone to vote? Research shows lower-income and less educated areas are more likely to vote in favor of a casino. The American Community Survey (2007-2011) shows East Boston has the highest percentage of residents with less than a high school diploma in Boston—by a wide margin, at 34.2%, and the second lowest attainment of a Bachelor's degree or higher at 17.8%—this, in a city where 46.5% have a college degree or more. Eastie's median income of \$45,849 is more than 12% lower than the city median (which is itself lower than the state median)—and among all Boston neighborhoods, Eastie has the

second lowest percentage of households earning more than \$150,000. That gives us fewer financial resources with which to fight back.

This vote was never meant to be fair.

Suffolk Downs spent \$1.9 million—not counting money spent on campaign contributions for various elected officials, or donations to those officials' favorite charities—to convince us and the people of Revere to vote in their favor. That spending was not designed to give us a fair and balanced picture of pros and cons; cons were never mentioned. The biggest difference between us and the people of Wellesley is that we couldn't as easily raise an amount to come anywhere near competing with the casino industrial complex.

They wanted to rule out any chance of this vote being fair.

I mentioned the campaign contributions. Perhaps those had something to do with our experience of having a previous mayor of Boston who was unwilling to engage in a balanced discussion and tried only to force this proposal on us. In fact, our mayor was associated with the direct payment of people to place large signs on neighborhood vacant lots—and that sign posting was aligned with suppression of signs expressing opposing viewpoints.

Those contributions might have had something to do with our experience of having every other official we had elected to represent us tow the same line as our mayor. Maybe those contributions were tied to the many stories we heard of No Eastie Casino signs being taken down, and stores being told they could not have signs—unless the signs supported the casino effort.

Massive banner ads for Suffolk Downs in our local newspaper might have been tied to coverage leading up to the vote which was far from balanced—and which helped the Suffolk Downs side.

This vote was never meant to be fair.

In Wellesley, I think the opponents would have been able to afford more ads in the local newspaper. In Wellesley, the opponents could have given more to the campaigns for their elected officials to help balance outside interests. This was never meant to be balanced. This was never meant to be fair.

Sterling Suffolk—the sole supporter of the \$1.9M in disclosed spending for the pro-casino side before November 5—spent much of that money at local businesses. They also suggested to a far higher number of businesses than actually would be present in the original casino plan that they would support those businesses, and did not (of course) discuss research indicating local businesses would be hurt when residents with limited resources spent those resources at slot machines instead of their restaurants and stores. Is it any wonder the Chamber of Commerce suppressed dissent and voted to support this project?

It is a wonder—given Sterling Suffolk's spending at local restaurants, exaggerated claims of future business, and intimidation by elected officials—that any business owner stood with us against the casino—but a few were brave and did. Businesses were afraid they could be denied

permits and licenses, and could face other business challenges if they stood up to the casino-backed political machine, but a few were brave and did.

Did I mention this was never meant to be fair or balanced?

East Boston is not Wellesley. Yet East Boston is stronger and more resilient than people cared—or dared to imagine. A determined group of Eastie residents rose up—and with about 2% of the resources that Suffolk Downs had—and 0% of the official political support—we educated the people of our neighborhood. We told our neighbors, friends, and family members about the increased crime that would come to this safe neighborhood, the doubling in addiction in a city and neighborhood already reeling from too many lives lost to—or ruined by—addictions, the increased pollution from traffic in a neighborhood already disproportionately burdened by particulate matter from an international airport.

When we spoke with them, many of our neighbors—having dealt with old politics and intimidation before—were afraid to even admit they wanted to vote against this proposal. But . . .

This neighborhood has heard broken promises before—and on November 5, we were determined not to let our elected officials, or anyone else, break another promise. In this city on a hill, we voted to serve as a national example of having a better vision, rather than falling prey to an idea whose time has already past. In this birthplace of the American Revolution, we chose to fight back against a political system that was attempting to repress dissent.

Although there has never been a fair casino vote in Massachusetts—and this vote certainly wasn't fair, we voted no—and our vote was resounding. Let me say that again: East Boston voted NO.

This was despite the fact that this never was meant to be a fair vote.

The story should have ended there. We voted no about a casino proposed on the same property where somehow a new casino was proposed only hours later. On a property that straddles two cities. A property which—by state law—should require the affirmative vote of both those cities if casino development is to happen.

Here is the thing: just like Taunton, Springfield, and East Boston, Revere has a median income below the state average. In 2011, Revere's median household income was estimated to be \$48,278— more than 20% lower than the state median. In Revere, as in East Boston, fewer than 20% of those over age 25 have a bachelor's degree or higher. In Revere, as in East Boston and Springfield, there is a significantly greater non-white population than in the rest of the state.

Did I mention this was never meant to be fair?

And in Revere in this last election—one that was illegal because East Boston is a host community and we already voted no—the casino again vastly outspent the underresourced, but valiant opponents. In Revere, there was similar intimidation of any business that tried to hold a sign in opposition. In Revere, we watched elected officials send messages with their title of

"mayor"—on Mohegan Sun email letterhead. Those same elected officials literally dismissed facts about negative impacts of casino development—calling them "conjecture." They painted all opponents as being paid by Wynn or Everett to discredit us.

Trust me—and I speak for everyone I know here who voted no in East Boston. We are not being paid. We are doing this as volunteers. In fact, we ourselves donated time and treasure to stop this from happening. How many casino supporters can say the same about their commitment to bringing casinos here? In terms of donations, the answer is 0. No one has donated his own hard earned money to support casino development here.

Mayor Rizzo—and for that matter Mayor Menino—lied about us and the opposition in Revere and tried to call into question our character to advance their purposes. We are thankful now to have a mayor: Mayor Walsh, who is representing the people of East Boston and our best interests.

There was no fair vote in Revere, although there was a valiant, strong opposition that made us proud.

We don't need to worry about paternalism here. What we do have to worry about—here, in the Cradle of Liberty—is democracy. You can name any municipality in this commonwealth. If you give people on both sides of this issue equal resources and you keep intimidation out of the picture, people will overwhelmingly vote casinos down. Because ultimately, with the facts, we all know casinos are a bad deal for the people of our towns.

There was no fair vote in Eastie, but we overcame and won anyway. We are a host community and our vote needs to stand—not only for us, but for democracy in this great Commonwealth where American liberty was born. A Commonwealth where I hope democratic principles will continue to stand. Let's be an example of what America can be, rather than an example of the corruption that in too many places, at too many times, has come to dominate our political system.

We believe we, in East Boston, in this city on a hill, and across this commonwealth, can be that example of what America can be. We believe we should be. We believe we will be.

This is why our vote matters. This is why we voted no.

Testimony before Gaming Commission re Construction Job Access and Cori Regulations

My name is Chuck Turner. I am here as a member of the Boston Jobs Coalition which is part of the regional coalition conveened by Action for Regional Equity. My testimony will focus on ;the issues of access to constructions jobs and Cori regulations relating to casino development ;not only in this area but also throughouit the state.

Becuase of time constraints, I am going to focus on specific recommenations for Gaming Commision consideration and action. I assume that there is no need to convince the members of the Commisswion of the need to structure casino development thorughout the state so that it has the maximum possible economic benefit fo thee broadest possible segment of our workers.

To achieve that goal in the area of Construction access, I urge the Commision to take the following actions:

- 1) Work with the unions and developers to set construction diversity goals for each casino that enables the achievement of the beneficial impact for workers of color and women that needs to be achived. Minimum compliance must be viewed aHotel sunacceptible.
- 2) Work with the unions and developers to assure that that there is a supply of construction workers of color and women necessary to meet the deversity goals established for the project. Included in this effort should be loan programs to enable union members behind in their dues to pay their arrearages through employment on the project.
- 3) Work with the unions and developerws to develop a monitoring and compliance program that will provide incentives for compliance. Compliance with the diversity goals must be viewed as a component of casio development as the structuard integrity of the buildings.

There is a major problem regarding the employment in all of our casinos across the state. My understanding is that over one third of the residents of Massachusetts have Cori records. This means that the present legislative guidelines relating to employment could exclude a third of our citizens for the economic benefits of the developmental initiative.

To remedy this program I urge that the Gaming Commission follow the request of the Restaurant and Hotel Workers Union to work with the Governor and legislature to add to part b of Section 16: Grounds for denial of application for license or registration that now reads which reads The commission shall deny an application for a license or registration, other than a gaming license or a license for key gaming employee, under this chapter if the appliant: 1) has been convicted of a felonny or other crime involving embezzlement, theft, fraud or perjury; the following language:

PROVIDED, HOWEVER, AN APPLIANT MAY DEMONSTRATE, AND THE COMMISSION SHALL CONISER, THE APPLICANT'S REHABILITATION AND WHETHER SUCH CONVICTION SHOULD NOT BE AN AUTROMATIC DIDQUALIFIATION UNDER THIS SECTION, TAKING

INTO ACCOUNT BOTH THE NATURE OF THE CIRME AN THE TYPE OF JOB THE APPLIANT IS SEEKING.

Obviously, this will require the Commision developing the capability to play the roal required by the language. However, I think this development initiative is an excellent one to apply the concept that once a person has served his or her time for the commission of a crime, they have the right to be treated fairly and with trespect.

East Boston is a small geographically isolated neighborhood of Boston, with an incredible history of community activism. Over the last two years, I have had the honor of working with an amazing group of dedicated residents, who volunteered countless hours to educate themselves and others about the impacts of a proposed casino at Suffolk Downs.

On November 5, 2013... East Boston VOTED NO!

Remarks to Mass Gaming Commision – 3/25/2014

Hello, my name is Matthew Neave and I'm a resident of East Boston. Thank you commissioners for giving me the opportunity to speak today about the proposed Mohegan Sun casino at Suffolk Downs.

On November 5, my wife and three young children joined me as we walked into the East Boston High School to join the majority of my neighbors in voting NO to a casino in our neighborhood. The neighborhood of East Boston is a special place; it is a family neighborhood. We've had our 3 kids since moving to the neighborhood 8.5 years ago. One of the things we love about the neighborhood is that it is full of families.

There are families who are growing up in the same house that their grandparents bought. There are families who came to our country looking for work and safety and found a welcoming community in East Boston. There are families who want to live and raise their kids in an active, diverse urban neighborhood. Unlike the center of this city or the seaport district we're in now, if you go to East Boston you'll see numerous schools filled with our future leaders, you'll see kids playing on the few playgrounds we have, you'll see families walking hand in hand down our streets. This is all true of Revere as well.

Because East Boston is a family neighborhood, my family joined the fight against bringing an adult entertainment complex to our residential, hard working neighborhood. Since our elected politicians changed their minds and started supporting expanded gaming in the Commonwealth a few years ago, people were only hearing one side of the story. It was up to volunteers to share the well documented problems that casinos bring. Our whole family engaged our neighbors in conversation, joined standouts, and reminded people that we have the final say in this development (at least that is what we were told).

You can imagine our excitement when on Nov 5 East Boston said NO. We said NO because we've borne enough burdens for the state. We host the airport with all of the traffic and pollution it brings. We're only connected to our city by tunnels and we have to pay a toll to travel to our own city hall. We have 2 drawbridges, which gridlock our streets when they open to let oil tankers through; tankers that have spilled oil into our river. We have a lack of greenspace given our dense population. So we said NO.

But does what we said matter? Our vote wasn't even acknowledged during your hearing on Nov 7. You didn't have a plan for what to do if one of the neighborhoods couldn't be bought by Suffolk Downs. To use your football analogy, we stopped them on their final play as time ran out, but then you decided to take the ball from our hands, give it to them, and add overtime since you didn't like the outcome. So I have a question for you. How would you explain to your 6 year old that even though we followed the rules and our community said that we didn't want a casino at Suffolk Downs that they can still put a casino at Suffolk Downs? That shouldn't happen in a democracy!

Should I tell my son that money and power always get what they want? Should I tell him that votes are a charade to make us feel like our opinions matter? I want to instill more hope in him than that and I think you would too.

So I urge you to take the side of the people who will bear the burden, not the few who will reap a reward. The roads to a casino at Suffolk Downs will always go through our neighborhood no matter which side of the track you put it on. East Boston doesn't want to be a driveway to a casino. We said it loud and clear, please listen.

Dear Commission,

My name is Trent Sheppard. I'm a chaplain for college students, and my family and I live in East Boston. My wife and I have two children, with a third on the way in June.

A funny thing happened with our four-year-old recently that made me think of this ongoing journey regarding the proposed casino at Suffolk Downs. I told our daughter, Miréa, that I thought she was funny, and she said, "No, Daddy, I'm crazy."

And to be honest with you, commissioners, that is exactly what I think of when I consider the saga of failed democracy that has led us to this day: *this is crazy*.

Please, *please* consider our journey for a moment...

Before the November 5 vote, we were told by our elected officials that a "No" vote in one community would *stop* the casino at Suffolk Downs, so we put our lives and our jobs and even our families – for a time – on hold, while we gave *everything we had* to rally our friends and our neighbors and members of our congregations to vote "No" on November 5.

It was a thrilling, exhausting and overwhelming ride as religious folks and non-religious folks, old timers and recent immigrants, young professionals and urban hipsters all worked *together* because we were convinced that our vote would count, that it would make a difference in our community, that the rule of law was on our side – and in this case the law was very clear: that Suffolk Downs had to have a "Yes" vote in both communities for a casino to go forward.

So, of course, we celebrated when the people of East Boston resoundingly said "No" on November 5. Because it was *over* – in the ancient words of the Apostle Paul, "We had fought the good fight" – and it was time to take a rest.

Within hours of the vote, though, various voices began to change the narrative, to change the story, to attempt to interpret the law in a way that clearly went against common sense – in a way that simply overlooked our vote altogether.

At first I thought, "Wow, this is funny, they're actually trying to make a serious case out of this, as if our vote could just be overlooked." But it wasn't until I realized that you, the Massachusetts Gaming Commission, were actually seriously considering it, that I thought to myself, "This is crazy."

Commissioners, I'm asking you as a father of three, as a husband, and as a chaplain to a bunch of impressionable college students:

Please do what is right here;

Please do what common sense requires here;

Please uphold democracy here by honoring the clear intent of the ballot on November 5: that a "No" vote in East Boston means that the casino at Suffolk Downs is dead.

One of the reasons I love working with college students is that young people are still somewhat idealistic – cynicism hasn't yet gotten the best of them, and they still believe in the high ideals of a fair and just society.

You have a chance to remind them – and, in fact, to remind the whole of our Commonwealth – that democracy is not for sale, that hardworking communities like East Boston with high hopes for the future aren't simply sold off to the highest bidder, that our vote and our involvement in the democratic system is still worth believing in – that it's still worth fighting for... let *that* be your legacy, not *this*.

Massachusetts Gaming Commission RE: Suffolk Downs Casino

Dear Commission:

My name is Rob Pyles. I'm a resident of East Boston. I'm an entrepreneur, a landlord, and more importantly a husband, and I'm also a dad to two little girls.

I want you for a moment to put aside all the emotion of this evening; and imagine you live in East Boston. You were told clearly by your government a no vote from *one community* would kill the casino proposal. So you and a ragtag band of tired but compassionate neighbors - even though you were outspent 86 - 1, you pulled off one of the most miraculous political upsets in the history of the Commonwealth. Literally people were crying at the celebration, in the basement of a church - immigrants, young professionals, third-generation Italian families - hugging each other, chanting "David beat Goliath!"

That is America at its very best.

But the next day you learn that Goliath isn't dead. He's moving a few hundred feet north. The "fair and transparent" process - the rule of law you trusted in - they were actively allowing it to happen... what would you say if you were in our shoes?

I think there's only one thing you could say: Sorry - we made a mistake.

So I'm here as a messenger. I want you to know this process is creating *serious* disillusionment among so many young people; this is happening under your watch.

As I watch this all unfold, it's confirming my fears about our democracy: that it's for sale. That if you don't like the result of a vote, keep the attorneys coming back until the opposition is exhausted.

In retrospect, the ballot question was misleading at best. The question should not have been "Do you approve of a casino at Suffolk Downs". The question should have been: "You're getting a casino. Do you want it 500 feet to the south - or 500 feet to the north?"

Another point I want to express to the Commission: This process is bleeding us. Don't you see that it's expensive for us to fight? The battle has already drained us: our time, our money, our relationships with spouses, children, bosses. And there's no end in sight.

So I am asking you tonight, and I hope you hear this: Help us. Seriously. *This* is why you were given this responsibility. To listen to the voters. Well, here we are - *East Boston voted...* and we voted NO.

My daughter Alessandra - who's three years old - I took her to rallies and I felt really good as a dad showing her what it means to politically active and fighting for our neighborhood. She loved to say "No casino!". And when we defeated the casino, I was so proud because of the lesson she was learning firsthand. And I've had a difficult time trying to explain what's happened since then.

Which brings me to a simple question - that I want to honestly ask you: why should a young person get involved in the political process? What's the point of getting fighting for a cause - when the rules can be changed *after* the game is over?

Is this the legacy you want? Because that is precisely what is happening.

I ask you - stop the casino at Suffolk Downs. Respect our vote. No one said your job was going to be easy. But it's time to step up and make the tough decision - and defend our democracy.

Good evening Chairman Crosby and members of the MGC:

My name is Gail Miller and I'm an East Boston resident. On November 5th, 2013, I voted no on a Suffolk Downs casino proposal and I don't know why I have to appear here today to plead our position. What transpired by your commission allowing the proposal to go forward by a new applicant with some of the same players from the previous application stretches the intent of the legislature in creating the gaming bill. Our elected officials, Senator Petruccelli, Representative Basil and City Councillor Lamattina all agree that this was not the way it was supposed to be.

We do not accept the process that brings us here today, but suffice it to say we will take this opportunity to offer reasons why we opposed this proposal by the casino proponents.

I will speak on, for the most part, environmental issues. I am a founding member of the Friends of Belle Isle Marsh, an organization formed over 25 years ago to protect, enhance and preserve Belle Isle Marsh Reservation "and it's environs", a DCR property which is a stone's throw from this assault on the environment, a casino at Suffolk Downs property. This reservation, while not entirely managed by the DCR is about 360 acres. I am not speaking on behalf of the organization, however, I am currently a Board member. FBIM did submit comments on the environmental documents which Mohegan Sun conveniently borrowed from the previous casino proposal for East Boston even though it's a new location, different impacts, different applicant (officially). I will add that the two separate documents for the relocated stable area and the casino itself must be reviewed in its entirety together, not separate proposals. In addition to concerns about the "smoke and mirror approach" by way of these environmental documents, they have not fully outlined all the impacts...i.e., no mention at all about the buses alone that will be bringing thousands of folks to the area...where they will park, how many.. impacts on air quality. Some issues they say they will get to later. And so it goes.

Remembering that East Boston and Chelsea is an environmental justice community, it is the human environment that needs elevated attention also.

Belle Isle Marsh Reservation, along with parcels within this casino proposal and abutting this proposal are designated as an Area of Critical Environmental Concern. What does that mean for this Reservation that is the largest remaining wetland in the City of Boston?

It simply means that it should get the "ultimate" concern regarding impacts, including the consideration for a "no build" proposition if impacts cannot be managed. Given the sensitive nature of this natural resource within the confines of East Boston, Winthrop and Revere, we don't believe you can manage the impacts in a favorable manner. Lighting alone, 24/7 will change the nesting and roosting patterns of our bird population which finds Belle Isle to be an important stopover. The proposed site is now considered landlocked tidelands, however it sits on formerly filled tidelands. The site is still surrounded by Sales Creek which Suffolk Downs had been fined for as it allowed pollution to enter the Sales Creek resource. It is also bordered by a manmade wetland that evolved in the midst of the Global and Irving tanks that is home to season\al roosting birds. Impacts from a casino, via noise and pollution will most assuredly affect the nesting and roosting habits of the bird life alone, not to mention the other wildlife the public sees less of.

The "critical corridor" that McClellan Highway is designated as will invite 25,000 projected cars a day to the this site, further fouling the air quality that is already severely compromised. Major transportation improvements such as those proposed by former Transportation Secretaries of the Commonwealth are not even mentioned, such as extending the Blue Line into Lynn. And when the MA Department of Public Health ever releases its' Logan Airport Health Study we will learn about the health impacts we have already been realizing for so many years. This massive proposal in our urban environment will only seek to ramp up these statistics.

While Revere has applied in February for a \$4.8 million grant from the federal government to improve the Sales Creek area, there is not even a bona fide proposal by this casino applicant to contribute in any significant way improvements to this entire site. For the City of Revere to ask the Federal Government for a grant while knowingly entertaining this casino proposal and not mandating some resource improvements by the developer is a travesty. Those that are impacting the area get a pass on this front. Simply wrong!

This casino proposal will also have impacts upon the Chelsea Creek which activists in three communities seek to protect as a natural resource waterway. While Chelsea Creek is industrial in nature, a new park sponsored by Eastern Minerals is set to open soon on the Creek. An urban wild park also sits on the East Boston side of the creek, enjoyed by residents of Eagle Hill and beyond .Madonna Hill is also another urban wild which will be impacted if a casino is allowed to go forward, cutting into the hill with a flyover proposal at Boardman Street in an effort to get customers into Suffolk Downs site more quickly, doing nothing to otherwise improve traffic conditions on McClellan Highway.

With little open space that our urban environment has realized, it is of the utmost important that impacts to them not be allowed. We don't believe that any mitigation can be successful and managed.

Suffice it to say, lest we forget, that we also sit on the back of Logan Airport...so how much more should our neighborhood endure.

We are within walking distance to six elementary schools if this casino is allowed here. the industrial nature of Rte. 1-A goes without saying and the impacts we realize from the trucks carrying ethanol, gasoline and the like.

If open space and our natural environment is supposed to mean something, then this casino proposal does not do it for our community.

The quality of life will take a giant hit.

Do not allow this casino proposal in Revere.

Senator Petruccelli: Put casino legislation in the hands of voters

Citing its Recommend 27 people recommend this potential for job

creation, infrastructure improvements and a solid way to shore up the state's \$250 million thoroughbred industry, Senator Anthony Petruccelli said he would support a plan to construct a resortstyle casino at Suffolk Downs Racetrack, However, in the end, said Petruccelli, the decision will be in the hands of East Bostonians through a host community referendum vote.

"This is far too important to not let the people who are going to be impacted have the final say," said Petruccelli.

For several years now Petruccelli had remained cautiously pessimistic and carefully researched the impacts other casinos have had on local

economies in other parts of the country, weighed the pros and cons but kept his opinion of placing the state's first ever resort-style casino in his backyard close to his vest,


Then, a few months back, Petruccelli bumped into an old friend who had recently lost a good paying job with benefits from DHL. The husband and father of two explained to Petruccelli how the historic downturn in the state and federal economy had hit he and his family very hard.

"It was right there and then I made my decision," said Petruccelli, "I have an inherited task in my capacity as an elected official to help people get jobs and secure work when I can. The story of my friend and the fact that I have a stack of resumes on my desk from out-of-work

constituents tells me we have to do something very soon to create jobs."

In the end and after months of internal debate, Petruccelli said the benefits far outweigh

"Suffolk Downs ownership predicts they could create 2,500 permanent jobs in the opening months of a casino," he said.

However, Petruccelli said his support for a Suffolk Downs casino would come with conditions ... one being a commitment from Suffolk Downs to finance a overhaul of the Route 1A corridor from the Sumner/Callahan Tunnels to Copeland Circle in Revere.

In 2009, an independent study commissioned by Petruccelli showed that regardless if a casino is built at Suffolk Downs costs to improve the infrastructure along the Route 1A corridor from the Sumner/Callahan Tunnels to Copeland Circle in Revere would cost the state almost \$500 million.

Some of the study's findings, conducted by John Vitagliano of Seagull Consulting, have been highlighted by Petruccelli in the Senate Transportation Committee's version of the Transportation Bond Bill.

"I was asking the executive office of transportation to take a good hard look at significant improvements that need to be done along the Route 1A corridor," said Petruccelli. "These infrastructure improvements have been part of the lower North Shore transportation improvement study since 2000 and it's merely a coincidence that now we are talking about the possibility of a full-scale casino at Suffolk Downs which is situated along this strip."

Rush hour traffic has long been a problem on Route 1A and anyone who uses the road during their commute is familiar with the gridlock that occurs southbound in the morning and northbound in the afternoon.

"I want to look at the big picture-whether there is a casino or not-and see if its feasible to make some of the changes first suggested in the 2000 study," said Petruccelli, "We've gotten the ball moving on some of these projects in the past but has not been a major priority of past gubernatorial administrations.3

While the focus of the study expands on the 2000 lower North Shore transportation improvement study it does in

fact include potential traffic impacts a casino might have on Route 1A from Eastie to

"A local casino would have a major traffic impact... because casinos are among the heaviest traffic generators compared to other possible uses (of Suffolk Downs)," wrote Vitagliano in his study. "Casinos generate constant high traffic volumes from 8 a.m. to midnight, seven days a week."

Even before a casino was discussed and like the lower North Shore transportation improvement study suggested back in 2000, traffic along Route 1A needs to be addressed now. Furthermore, Vitagliano suggests that add a casino to the congestion that already exists along Route 1A impacts could be felt as far north as the Route 1A-Route 60 interchange in Revere

In his study, Vitagliano suggested widening Route 1A from Curtis Street in East Boston to Mahoney Circle in Revere. This would include property taking and cost \$40 million; widen Revere Beach Parkway in Revere, Everett and Medford at a cost of \$90 million; perform a Copeland Circle grade separation in Revere that would cost \$75 million; perform a Mahoney Circle grade separation in Revere that would cost \$30 million; perform a Brown Circle grade separation in Revere that would cost \$25 million; install a Route 1A to Route 16 connector on Railroad Ave. in Revere at a cost of \$45 million; construct a haul road in East Boston at a cost of \$20 million; build a Route 1A-Chelsea Street Bridge connector in East Boston that would cost \$40 million; perform a Route 1A/Boardman Street grade separation in East Boston that would cost \$10 million; build a Route 1A-Route 16 interchange that would cost \$15 million; perform a Revere Street grade separation in Revere that would cost \$10 million; improve traffic signalization along the Route 1A corridor at a cost of \$5 million; and finally mitigation for traffic impacts on the local communities would be \$15 million.

The total cost of the improvements would have a price tag of \$420 million according to

It's this reason that Petruccelli said he'd throw his support behind a full scale casino and not a plan to simply put slot machines at Suffolk Downs.
