Dear Commissioners:

George Brown, Chairman of the Massachusetts Thoroughbred Breeders Association has submitted a request for approval to run six restricted Massbred races at Finger Lakes Racecourse in New York this spring. Mr. Brown states that funds have been set aside to race at least nine stakes races at Suffolk and some more restricted races at Brockton. Last year, Massachusetts General Law Chapter 128 (the Agricultural Law) was changed to allow Massbred races to be run outside of Massachusetts, and the Massachusetts Gaming Commission approved these races at their August 20, 2015 meeting.

Recommendation: That the Commission approves the request of the Massachusetts Thoroughbred Breeders Association to run six restricted Massbred races at Finger Lakes Racecourse this spring, with funds set aside to race at least nine stakes races at Suffolk and some restricted races at Brockton.
