Call to Order

10:00 a.m. Chairman Crosby called to order the 9th Agenda Setting meeting. Chairman

Crosby noted the absence of Commissioner Macdonald.

Approval of Minutes

Commissioner Zuniga moved to approve the minutes of the Agenda Setting meeting on March 22, 2017. Motion seconded by Commissioner Stebbins. Motion passed unanimously.

Agenda Planning for Upcoming Commission Meetings

(Potential Commission Meeting on 4/13/17)

<u>Item #1 – Administrative Update</u>. Edward Bedrosian stated that he will have something to report.

<u>Item #2 – Slot Machine Lease Agreements with Revenue Share</u>. Edward Bedrosian reported that we can push this agenda item out to April 27th. He stated that he is working with the Legal Division on this item.

<u>Item #3 – Licensee Outside Director Background Checks</u>. Chairman Crosby and Edward Bedrosian reported that a memo will be drafted on this matter and to leave this item on.

Item #4 - MGC Quarterly Budget Review and Diversity Spend Update. Janice Reilly reported

that this item is on schedule.

<u>Item #5 – PPC Audit and Compliance Committee Briefing</u>. Commissioner Zuniga reported that the audit will be finalized and an update will be provided on this item.

Item #6 – License/Registration Forms. Loretta Lillios reported that this item is ready to go.

<u>Item #7 – 205 CMR 152</u>: <u>Individuals Excluded from a Gaming Establishment – Approval of (Amended) Small Business Impact Statement and Final Draft</u>. Loretta Lillios reported that this item is ready to go.

<u>Item #8 – Racing Medication Emergency Regulations.</u> Todd Grossman reported that this matter will be held off for one more meeting due to the RCI (Racing Commissioners International) conference. They are waiting to see if there are any medication developments that come out of the conference.

<u>Item #9 – Quarterly Licensing Report</u>. Loretta Lillios stated that she will follow up with Karen Wells on this item.

Additional items for 4/13/17:

Edward Bedrosian reported that the Racing Division will have additions that include Plainridge Park Racecourse special events, reimbursement of unclaimed tickets, and quarterly local aid payments.

John Ziemba reported that he would like to add the Foxboro mitigation fund matter to the agenda.

John Glennon reported that he would like to start the regulation process for the adoption of GLI (Gaming Labs International) 3.0 standards. He also requested to start the formal promulgation process for 205 CMR 136 (Gaming Beverage License) and 205 CMR 143 (Transfer of Progressive Jackpots).

Chairman Crosby stated that he would like to add the Eastern Bank discussion to the agenda. The Commission is going to move accounts to Eastern Bank. Elaine Driscoll and Jill Griffin cited Eastern Bank's diversity campaign and values. Commissioner Cameron requested information about their status on women and equal pay.

Chairman Crosby requested a legislative update for items that pertain to the Commission. He suggested that he may request delegation of authority to speak on behalf of the Commission when asked for opinions on legislative matters.

<u>Item #12 – Awardees for Special Population Studies</u>. Mark Vander Linden reported that this item is ready to go. He stated that applications are due Friday and they will conduct a review.

Chairman Crosby requested that Mr. Vander Linden provide an update on the Public Health Trust Fund.

<u>Item #13 – Update on FY2017 Research Deliverables</u>. Mark Vander Linden reported that he will provide an update on research deliverables.

Item #27 - 5 Year Look Back. Commissioner Zuniga stated that they had great input at their meeting. He reported to keep this item under review.

<u>Item #28 – Gaming Economic Development Fund</u>. Commissioner Stebbins reported that he has a meeting today with Senator Lesser, the new chair. He also stated that he has a meeting this week on the formation of a White Paper. He is targeting June for a public hearing with input from stakeholders. Chairman Crosby suggested including the public hearing with a Commission meeting.

<u>Item #29 – Veteran Business Enterprise Recognition</u>. Jill Griffin stated that she wants to recognize subcontractors for their work with Veterans. She stated that this item can be moved to May 25th.

Jill Griffin reported that Senator Kenneth Donnelly passed away and she would like to say a few words about him at a Commission meeting. She stated that he has done a lot of work in the area of workforce development. Commissioner Zuniga suggested including this item in the Administrative Update section at the Commission meeting on April 13th.
