All comments received via email will be made public in their entirety, including the identity of the commenter, and distributed to the Commission for their review prior to the hearing.

Individuals will also have an opportunity to sign up to address the Commission on the day of the hearing prior to its start at the Edward G. Connolly Center. In order to use the available time most efficiently, **the Commission will limit each speaker to 4 minutes.**







The following is the anticipated agenda for the public hearing:


1. Call to order and introductory remarks by the chair

5. Other business – reserved for matters the Chair did not reasonably anticipate at the time of posting.


