Motion seconded by Commissioner Cameron. The motion passed unanimously.

- 12:03 p.m. Motion made by Commissioner McHugh that the Commission deny the objections on grounds of fundamental inconsistency filed by MGM to the award of the arbitrators in the case of the City of West Springfield with the exception of adding the word "reasonable" to the sentence in Section 1 that discusses payments of legal fees and other expenses and with the exception of striking from Section 2 the phrase, "The parties acknowledge that the community shall be free to direct the Annual Mitigation Payment and Annual Study Costs Reimbursement (together, the 'Annual Payments') to any uses it deems appropriate and shall not be restricted to use the funds for any purpose set forth herein." Motion seconded by Commissioner Stebbins. The motion passed unanimously.

Motion seconded by Commissioner Stebbins. The motion passed unanimously.
