Pursuant to the Massachusetts Open Meeting Law, G.L. c. 30A, §§ 18-25, notice is hereby given of a meeting of the Massachusetts Gaming Commission. The meeting will take place:

The Massachusetts Gaming Commission will hold an open public meeting for applicants for gaming licenses and parties interested in becoming applicants for gaming licenses. The meeting will be held at the Sheraton Framingham Hotel and Conference Center on Monday, October 29<sup>th</sup> at 10:00 a.m. The purpose of the meeting will be to provide information regarding the method to be used by the Commission to determine, for each applicant, those individuals and companies whose suitability will be required as a condition of the licensing of the applicant, otherwise known as "qualifiers". At the public meeting, general questions will be taken but no specific determinations will be made. Prior to October 29<sup>th</sup>, applicants and parties interested in becoming applicants are invited to provide the Commission with information outlining their intended ownership and governance structure.
