WHAT:

There are numerous provisions in the Expanded Gaming Act to enable the Commission to adopt regulation and take other actions to mitigate harm which may occur through introduction of casinos and slot parlors. One such strategy is for the Commission to adopt a Massachusetts Responsible Gaming Framework that will guide the development of regulation and assist gaming operators to establish a site-based responsible gambling program.

This educational forum solely dedicated to the topic of responsible gambling is hosted by the Massachusetts Gaming Commission in partnership with the Massachusetts Council on Compulsive Gambling. This forum provides the Commissioners and the community with an understanding of the basic concepts of responsible gaming. Information and research on elements and

characteristics of a responsible gaming program will be discussed amongst a panel of experts. Key components of a Massachusetts Responsible Gaming Framework will be raised for discussion with Commissioners.
