### **Meeting Notification**

#### **The Massachusetts Gaming Commission to hold Public Meeting**

*Topics include Encore Boston Harbor, Region C Status Update, MGC FY2020 Budget, and Horse Racing*

**WHO:** Members of the *Massachusetts Gaming Commission* including **Chair Cathy Judd-Stein** and **Commissioners Gayle Cameron, Eileen O'Brien, Bruce Stebbins,** and **Enrique Zuniga**

**WHAT:** The Massachusetts Gaming Commission will hold public meeting #273 on **Thursday, June 27, 2019.**

The meeting will begin with an approval of minutes, followed by an administrative update from Executive Director Ed Bedrosian, including a status update for Region C (Southeastern Massachusetts). The Commission is also expected to vote on Encore Boston Harbor's Certificate of Operations.
