#### **The Massachusetts Gaming Commission to hold Public Meeting**

*Topics include General Casino Reopening Update, Plainridge Park Casino Relicensing, Working Group on Equity and Inclusion in the Workplace, Independent Monitor*

**WHO:** Members of the *Massachusetts Gaming Commission* including **Chair Cathy Judd-Stein** and **Commissioners Gayle Cameron, Eileen O'Brien, Bruce Stebbins, and Enrique Zuniga**

**WHAT:** The Massachusetts Gaming Commission will hold public meeting #315 on **Thursday, August 13, 2020.**

After an approval of minutes, Interim Executive Director Karen Wells will provide an administrative update on the following:
