The Massachusetts Gaming Commission to hold Public Meeting

Meeting to include a discussion and anticipated vote on Plainridge Park Casino's license renewal

WHAT: The Massachusetts Gaming Commission will hold public meeting #321 on

After the meeting is called to order, Construction Project Oversight Manager Joe Delaney will discuss the License Renewal Process for Plainridge Park Casino's gaming license.
