Massachusetts Gaming Commission Renews Plainridge Park Casino's Gaming License

Sole statewide slots-only gaming facility license renewed for second five-year term

The Massachusetts Gaming Commission today voted unanimously to renew the gaming license of Plainville Gaming and Redevelopment, LLC, d/b/a Plainridge Park Casino (PPC) for a second five-year term, effective retroactively to June 24, 2020. PPC—the state's sole slots-only gaming facility (Category 2 licensee)—opened on June 24, 2015.

"On behalf of my fellow commissioners, I would like to congratulate Plainridge Park Casino on the renewal of their license. This represents an important milestone for both PPC and the Commonwealth, as this is the first casino to be relicensed under the state's Expanded Gaming Act of 2011," said **Chair Cathy Judd-Stein**. "PPC has generated approximately \$381 million in tax revenue for the Commonwealth, 82% of which goes to local aid for cities and towns in Massachusetts. They have created numerous jobs and been a responsible corporate citizen, supporting more than 100 community and charitable organizations in our state."

A gaming license was issued by the MGC to Plainville Gaming and Redevelopment, LLC, d/b/a Plainridge Park Casino for the construction and operation of a Category 2 gaming establishment for an initial term of five years. That five-year term expired on June 24, 2020, and PPC submitted a timely application for renewal. The Commission engaged in a comprehensive renewal process in accordance with procedures established pursuant to G.L. c.23K, including a public hearing convened virtually on September 16, 2020 and written comments submitted to the Commission. Based on that input, there exists widespread support for PPC in the host and surrounding communities.

In making the determination to renew the Category 2 license for a second five-year term, the Commission found that PPC has been in material compliance with all conditions attached to the initial award of its gaming license, as amended by the Commission. "We greatly appreciate the Massachusetts Gaming Commission's decision today to approve the relicensing of Plainridge Park Casino," said **Jay Snowden**, President & CEO of Penn National Gaming. "The Commission has set high standards for the integrity of gaming and racing in Massachusetts, and we pledge to continue to uphold these principles over the next five years and beyond."

As the first casino in Massachusetts, PPC implemented <u>GameSense</u>, a responsible gaming program that met the stringent expectations set forth by the Legislature and the MGC that measures be taken to minimize the effects of gambling harm on individuals, families, and communities while serving the good of the Commonwealth. In partnership with the MGC, PPC became the first casino in the United States to host an onsite responsible gaming information center. PPC is also the first casino in the nation to offer a

During the construction period of the \$250 million facility, PPC surpassed its diversity goals for contracts with Minority, Women and Veteran Owned businesses. More recently, in 2019, PPC exceeded all vendor diversity goals for the procurement of goods and services.

About Plainridge Park Casino

Plainridge Park Casino is a \$250 million integrated racing and gaming facility that includes the only live harness racing track in Massachusetts. When operating at full capacity prior to the COVID-19 pandemic, the gaming area features 1,250 of the latest slot machines as well as video poker and blackjack. In addition, PPC features a food court and an entertainment lounge bar that has featured local and regional bands. 1,620 structured and surface parking spaces welcome visitors to the facility.
