The Massachusetts Gaming Commission to hold Public Meeting

*Topics include: Quarterly Reports for MGM Springfield and Plainridge Park Casino;
Division of Community Affairs; Workforce, Supplier and Diversity Development*

WHO: Members of the *Massachusetts Gaming Commission* including **Chair Cathy Judd-Stein** and **Commissioners Gayle Cameron, Eileen O'Brien, Bruce Stebbins, and Enrique Zuniga**

WHAT: The Massachusetts Gaming Commission will hold public meeting #329 on **Thursday, December 3, 2020**.

After an approval of minutes, Executive Director Karen Wells will provide an administrative update, which will include the following:

- Staffing Update
- On-Site Casino Updates
- Racing Update

Joe Delaney, Chief of the MGC's Division of Community Affairs, will introduce representatives from MGM Springfield and Plainridge Park Casino for the presentations of each property's quarterly report.

Delaney will also ask that the Commission vote on a Community Mitigation Reserve Grant and Workforce Modification.

Members from the MGC's Legal Division and Investigations and Enforcement Bureau will request that the Commission vote on the following:

- **205 CMR 134.01: Key Gaming Employee Licensees.** The proposed amendment will allow the licensee to bring in staff from a sister property in an emergency situation to serve as Key Gaming Employees without requiring licensure – and Small Business Impact Statement, for emergency adoption and approval to move through the formal promulgation process – **VOTE**
- **205 CMR 134.02: Gaming Employee Licensees.** The proposed amendment will allow the licensee to bring in staff from a sister property in an emergency situation to serve as gaming employees without requiring licensure – and Small Business Impact Statement, for emergency adoption and approval to move through the formal promulgation process – **VOTE**
