Appendix D - 2019 Transportation Planning Application

If a Community is requesting funding for a **Transportation Planning Project**, please use the application entitled “**2019 TRANSPORTATION PLANNING GRANT APPLICATION**”. Please fill out the **entire application form**. Joint applicants shall indicate all communities that are applying together for joint projects and the amount of funding requested jointly. Please note that the Guidelines specify the percentage of applications necessary for joint applications. Joint applicants shall also specify whether they are seeking a Regional Planning Incentive Award and the amount of funding requested. **Each community filing a joint application should complete a joint application for submittal**. No community is eligible for more than one Transportation Regional Planning Incentive Award. If a community is filing an application for both a joint Transportation Planning Grant and an individual community Transportation Planning Grant, the community should use one application for each grant.
