Licensing Division Chief Nakisha Skinner will request a Commission vote on a Gaming Beverage License Renewal for Plainridge Park Casino.

Director of Racing Dr. Alex Lightbown and Plainridge Park Casino's Director of Racing Steve O'Toole will request an approval of a Racing Official for Plainridge Park Racecourse.

Commissioner Zuniga and members of the MGC's Finance Division will lead a discussion on the MGC's FY22 budget. A vote on this matter is anticipated.

Director of Diversity and Legislative Affairs Jill Griffin and Director of Research and Responsible Gaming Mark Vander Linden will review drafts of the MGC's Sports Wagering and Responsible Gaming Framework White Papers.
