The Massachusetts Gaming Commission to hold Public Meeting

Topics include: On-site Casino Updates, Massachusetts Gambling Impact Cohort Study, Commission Treasurer, Community Mitigation Fund

WHO: Members of the *Massachusetts Gaming Commission* including **Chair Cathy Judd-Stein** and **Commissioners Gayle Cameron, Brad Hill, Eileen O'Brien**

WHAT: The Massachusetts Gaming Commission will hold public meeting #357 on **Thursday, October 7, 2021**.

After the meeting is called to order, Executive Director Karen Wells will provide an administrative update, which will discuss the following:

- On-site Casino Updates
- Internal Reopening Plan Update

Director of Research and Responsible Gaming Mark Vander Linden, alongside SEIGMA Principal Investigator and UMass Amherst Professor Dr. Rachel Volberg, will present key findings from the Massachusetts Gambling Impact Cohort Study (MAGIC), and will provide public health recommendations.

Chair Judd-Stein and Chief Financial and Accounting Officer Derek Lennon will ask that the Commission vote on the appointment of a Commission Treasurer.

Community Affairs Division Chief Joe Delaney and Senior Program Manager Mary Thurlow will present on the following:
