## Response to Notice of Intent Regarding License for Sports Wagering

The Massachusetts Gaming Commission (MGC) released a Notice of Intent form regarding licenses for sports wagering in the Commonwealth on August 17, 2022. The MGC requested that any entity interested in obtaining a sports wagering license submit this form by August 31, in order for a landscape of interest in sports wagering licenses to come into focus.

42 entities submitted a Notice of Intent to apply for a license to operate sports wagering. Those entities are as follows.
