### **Meeting Notification**

#### **The Massachusetts Gaming Commission to hold Public Meeting**

*Topics include: Ad Hoc Sports Wagering Paper, MGM Springfield Quarterly Report, Casino Updates, Approval of Meeting Minutes, Community Mitigation Fund Boston's 2022 Police Grant Reallocation, & more*

**WHO:** Members of the *Massachusetts Gaming Commission* including **Chair Cathy Judd-Stein** and **Commissioners Brad Hill, Jordan Maynard, Eileen O'Brien, and Nakisha Skinner**

**WHAT:** The Massachusetts Gaming Commission will hold public meeting #391 on **Thursday, September 8, 2022.**

After the meeting is called to order, the commissioners and the Chair will hold two votes on approving meeting minutes for Commission meetings previously held on March 10, 2022 and March 14, 2022.

Following those votes, Executive Director Karen Wells will lead an Administrative Update that will cover Casino Updates.

Dr. Alex Lightbown, Director of Racing for the MGC, will head the Racing Division's portion of the meeting, which will cover Standard Owners of Massachusetts Recognition Request as Breeders' Representative Group ahead of an anticipated vote.

The next portion of the meeting will be led by Mark Vander Linden, the Director of the MGC's Research & Responsible Gaming team. During that segment, an Ad Hoc Sports Wagering Paper will be covered.

Community Affairs Chief Joe Delaney will lead the next part of the open meeting, where the Commission will cover MGM Springfield's Quarterly Report and discuss the Community Mitigation Fund Boston's 2022 Police Grant Reallocation, which is expected to precede a vote by commissioners.

Commissioner Updates are set to follow, rounding out the meeting. There is also time reserved at the end of the meeting for matters the Chair did not reasonably anticipate at the time of posting.
