## **The Massachusetts Gaming Commission to hold Public Hearing on Untethered Category 3 Sports Wagering License Applications**

**WHO:** Members of the *Massachusetts Gaming Commission* including **Chair Cathy Judd-Stein** and **Commissioners Brad Hill, Jordan Maynard, Eileen O'Brien, and Nakisha Skinner**

**WHAT:** The MGC will hold a public hearing on **Tuesday, January 3 at 10 am.**

The Massachusetts Gaming Commission will hold a public hearing Tuesday, January 3, regarding the six applications for untethered Category 3 Sports Wagering Licenses.

Tuesday's Public Hearing is meant to provide the public an opportunity to give comment(s) on the existing applications for untethered Category 3 Sports Wagering Licenses, [which can be found on the Commission's website](#). Those wishing to speak at the hearing should email [MGComments@massgaming.gov](mailto:MGComments@massgaming.gov) in advance to be placed on the list of speakers. Alternatively, written comments may also be submitted to the same email address with **'Category 3 - Untethered public comment' in the subject line**. Written comments are preferred in advance of the hearing but will be accepted on a rolling basis by the Commission.

Six applications for untethered Category 3 licenses have been submitted to the Commission from: **Bally's Interactive, LLC; Betfair Interactive US, LLC (d/b/a FanDuel); Betr Holdings, Inc.; Crown MA Gaming, LLC (d/b/a DraftKings); Digital Gaming Corporation USA; and PointsBet Massachusetts, LLC.**

Meetings regarding those applications are expected to be held in the days and weeks following Tuesday's hearing. More information on those meeting dates, times and schedules is soon to follow.
