The Massachusetts Gaming Commission to hold Public Meeting

Topics include: Sports Wagering Regulations, Annual Report, Commissioner Updates, and more

WHO: Members of the *Massachusetts Gaming Commission* including **Chair Cathy Judd-Stein** and **Commissioners Brad Hill, Jordan Maynard, Eileen O'Brien, and Nakisha Skinner**

WHAT: The Massachusetts Gaming Commission will hold **public meeting #439** on **Wednesday, March 1, 2023.**

After the meeting is called to order, the Legal Division will lead a discussion on whatever remaining, if any, regulations are set to be covered following public meeting #438 on Tuesday, February 28, 2023. Those regulations may include:

- 205 CMR 138: Uniform Standards of Accounting Procedures and Internal Controls for Gaming
- 205 CMR 238: Uniform Standards of Accounting Procedures and Internal Controls for Sports Wagering
- 205 CMR 247: Uniform Standards of Sports Wagering
- 205 CMR 248: Sports Wagering Account Management
- 205 CMR 254: Temporary Prohibition from Sports Wagering
- 205 CMR 234: Sports Wagering Vendors
- 205 CMR 256: Sports Wagering Advertising

Following that, Sports Wagering Business Manager Crystal Beauchemin is set to lead a discussion on the Commission's Annual Report.

Commissioner Updates are set to follow, rounding out the meeting.
