The Massachusetts Gaming Commission to hold Public Meeting

WHAT: The Massachusetts Gaming Commission will hold **public meeting #445** on **Monday, March 27, 2023.**

After the meeting is called to order, the Commission will hear an update from the Investigations and Enforcement Bureau regarding an assessment of civil administrative penalty under G.L. c 23K.

- 205 CMR 256: Sports Wagering Advertising
