Meeting Notification

The Massachusetts Gaming Commission to hold Public Meeting

Topics include: Massasoit Greyhound Association Application for Category 2 Sports Wagering License, FY24 Research Agenda, Legal, Commission Approval of House Rules, and more

- WHO: Members of the *Massachusetts Gaming Commission* including Chair Cathy Judd-Stein and Commissioners Brad Hill, Jordan Maynard, Eileen O'Brien, and Nakisha Skinner
- WHAT: The Massachusetts Gaming Commission will hold **public meeting #446** on **Thursday, March 30, 2023**.

After the meeting is called to order, the Commission will consider an application for a Category 2 Sports Wagering License by the Massasoit Greyhound Association, Inc. and review the applicant's operating lease agreement with Caesars Sportsbook.

The Commission anticipates that it may meet in executive session in conjunction with its review of the Massasoit Greyhound Association, Inc. application.

Following that, the Commission will turn to a disclosure by Betr Holdings, Inc. relating to an SEC matter.

The Sports Wagering Division will then follow with a discussion on potential approval of House Rules.

The Legal Division is then set to cover the withdrawal of Pointsbet Massachusetts, LLC's application for a Category 3 Sports Wagering License followed by a determination as to whether or not wagering on horse racing may be included in the Sports Wagering Catalog approved by the Commission.

The Racing Division will lead the following portion of the meeting, where they will discuss a request by FanDuel for approval to enable access points to FanDuel Racing within the FanDuel Sportsbook.

Following that, the Research Division will head a discussion on the FY24 Research Agenda, before Commissioner Updates are expected to round out the meeting.
