Meeting Notification

The Massachusetts Gaming Commission to hold Public Meeting

Topics include: Noncompliance matters, an update to house rules, and more.

WHO: Members of the *Massachusetts Gaming Commission* including **Chair Jordan Maynard** and **Commissioners Paul Brodeur, Brad Hill, Eileen O'Brien, and Nakisha Skinner**

WHAT: The Massachusetts Gaming Commission will hold **public meeting #575** on **Thursday, December 4, 2025.**

Once the meeting is called to order, the Commission will review the meeting minutes from the previous Commission meetings held on January 24, 2023, November 30, 2024, January 18, 2024, and November 6, 2025. This will be followed by an administrative update from Executive Director Dean Serpa.

The Investigations and Enforcement Bureau will then review a recommendation of an assessment of a civil penalty regarding noncompliance related to wagers on an unauthorized event involving a Massachusetts collegiate team by FBG Enterprises Opco, LLC, d/b/a Fanatics Betting and Gaming.

The Sports Wagering Division will follow with an update to DraftKings' house rules.

Commissioners then expect to hear from the Legal Division for a discussion on several regulations, including 205 CMR 247.07 and 205 CMR 248.10: *Acceptance of Sports Wagers and Account Deposits*, 205 CMR 141.06: *Notice to the Commission of Changes*, and 205 CMR 152.03: *Criteria for Exclusion*.

The meeting is then expected to enter into an executive session to review minutes from previous executive sessions on July 15, 2025, July 22, 2025, July 31, 2025, and August 14, 2025.

Commissioner Updates are expected to follow, rounding out the meeting.

There is time reserved at the end of the meeting for any other business the Chair did not reasonably anticipate at the time of posting.
