This form is being requested for informational purposes only and to aid the MGC in understanding potential interest in licenses for sports wagering. This notice of intent is not to be construed as an application or request for a temporary license and does not bind the MGC in any way.

ATTACHMENT 1

Affiliate company BlueBet Pty Ltd is licensed to conduct business of sports bookmaker pursuant to section 90 of the Racing and Betting Act 1983 NT in the Northern Territory of Australia and this licence is currently valid.

Subsidiary LLC, BlueBet Iowa LLC (d/b/a Clutchbet) is licensed to conduct advanced deposit sports wagering pursuant to the Iowa Code 99F.9(4)(6) and this license is currently valid.

ATTACHMENT 2

General

1. The entity, BlueBet USA Inc has not applied for any license or authorization to conduct sports wagering in its own right.

Colorado

2. BlueBet USA Inc's wholly owned subsidiary BlueBet Colorado LLC (d/b/a Clutchbet) has applied for a Colorado sports betting business license and this application is currently pending.

Arizona

3. BlueBet USA Inc's wholly owned subsidiary BlueBet Arizona LLC applied as designee for an event wagering operator license in 2021. As the Arizona Department of Gaming received more applicants than the number of licences permitted to be allocated, BlueBet Arizona was not allocated a licence.

Virginia

4. BlueBet USA Inc's wholly owned subsidiary BlueBet Virginia LLC (now renamed BlueBet Colorado LLC) applied for a sports betting permit in the Commonwealth of Virginia in 2021. At the time, 18 applications were submitted for five permits. Upon receipt of information concerning the over subscription of applications, BlueBet Virginia LLC withdrew its application without prejudice and obtained a refund of its \$100,000 application fee.

ATTACHMENT 3

BlueBet USA Inc is part of the wider BlueBet group. BlueBet is an online wagering company currently operating under licenses in Australia and the USA (trading as Clutchbet in USA). BlueBet USA Inc (or most likely a wholly owned subsidiary) will seek to conduct online sports betting on all permitted bet types within the Commonwealth of Massachusetts.
