<p>The marketing capabilities of the gaming establishments, like Encore, may put other competing local businesses and business associations at a disadvantage. Gaming establishments also attract a large group of patrons and employees to their establishments that would not otherwise be present in the area. This provides opportunities for local communities and business groups to attract casino patrons and employees to their communities to promote local events and entertainment opportunities, and help communities compete with gaming establishments for business.</p>

<p>In late 2024 the City of Cambridge began a Post Pandemic Commercial District Study that identified that in recent years Cambridge has lost the number of unique visitors to our major business corridors and squares. Some of the tentative recommendations by the consultant include marketing Cambridge as a fun destination with nightlife and events, and supporting commercial districts with placemaking activities. The City of Cambridge sees the Encore casino as an opportunity for Cambridge where several cross-marketing and promotions can be tapped into to increase visibility of local Cambridge events. In 2025-2026, Cambridge will support events such as the Taste of Cambridge, East Cambridge Rib Fest, and other arts and culture events through marketing assistance required to increase visitors.</p>

<p>The City of Cambridge seeks funding to develop a plan and schematic design for wayfinding signage for its commercial corridors and districts. Developing wayfinding signage for the City’s major mixed-use areas has been a long-time planning goal for the City, and has been included in several City plans as a key recommendation:</p> <ul style="list-style-type: none"> • Envision Cambridge (2019) – “Moving within and through Cambridge should be easy and enjoyable for all, with street designs and wayfinding that help people choose the most safe, effective, and pleasant route.” (p. 160) • East Cambridge Planning Study (2001) – “Use streetscape elements such as trees, benches, signage, and lighting to support active pedestrian uses and to reinforce the character and identity of each district.” (p. 63) • Kendall Square K2 Study (2013) – “Develop [a] wayfinding strategy to help orient people to the Square and its surroundings.” (p. 62) • Central Square C2 Study (2013) – “The Committee affirms the City recommendations designed to amplify Central Square’s public realm by...augmenting signage and making use of real-time transit information to improve convenience.” (p. 12) • Our Cambridge Street (2022) – “Encourage access to the new Green Line Station from Cambridge. While Webster Ave has had recent enhancements, consider enhancing additional routes to the station through measures such as crosswalk striping, street trees, and wayfinding signage.” (p. 57) <p>The existence of the gaming facility creates both positive and negative impacts which could be appropriately mitigated by the creation of a cohesive wayfinding plan for the City’s key commercial districts:</p>	

Positive Impacts

- 1) Business attraction – the gaming facility brings a high volume of visitors and consumers who may otherwise not visit the area. Finding opportunities to combine a visit to the gaming facility with broader economic activity within neighboring municipalities, such as Cambridge’s commercial districts, could help support local businesses and create a symbiotic spending effect.

Negative Impacts

- 1) Economic competition – the presence of the gaming facility hurts consumer service and hospitality uses within Cambridge’s commercial districts by reallocating time and spending from visitors to the area. The City’s post-pandemic retail study shows that these effects have been compounded by lower day-time population and retail spending within the City. Wayfinding signage helps to establish local district brand identity and improves navigability and convenience for visitors to the area.

The Community Planning Grant award from MGC will allow the City to implement its planning recommendations and appropriately mitigate the impacts from the gaming facility. Developing commercial district wayfinding signage will help to position the City as an attractive and convenient side trip to visitors to Greater Boston and the gaming facility, and in doing so help to support local consumer service, retail and hospitality uses which otherwise have to compete with the gaming facility for visitor dollars. Marketing Cambridge’s commercial districts in this way could also help to create a symbiotic effect where mutual benefits accrue to both the gaming facility and the City through the establishment of longer-duration trips to the area and a greater overall spend-per-person.

In order to complete this project, the City would issue a Request for Proposals for professional services to assist the City in developing a plan and schematic design for its wayfinding signage. Alongside City staff, the consultants would engage with residents, the local business community, and other stakeholders to develop a plan that details the number of signs, tentative locations, sign type, sign content, and an overall design that reinforces the identity of Cambridge’s commercial corridors and districts. The deliverable from this project would be the wayfinding plan and design details for which construction drawings could be developed and sent out to bid for production and installation.

Vehicular trips through the eastern part of the City of Cambridge are increased because of trips to and from the Casino. Per Gaming Commission and permitting information, we are aware that vehicles use the Prospect St/Washington St corridor, as well as the intersection of Land/O’Brien boulevards. Many trips also likely filter through other city streets in eastern Cambridge, particularly at peak times to avoid congestion on major corridors. Trips for workers and guests also likely originate in Cambridge and use city streets.

- The following impacts defined by the MGC FY 2026 guidelines are relevant to the proposed Learn-to-Bike and Beginner Urban Cycling Workshops:
- Increased traffic associated with the gaming establishment may cause increased congestion on the major routes leading to/from the gaming establishment.
 - Increased traffic associated with the gaming establishment may result in increased vehicular accidents on major routes leading to/from the gaming establishment.
 - Increased traffic associated with the gaming establishment may result in increased vehicular/bicycle/pedestrian conflicts.
 - Increased traffic associated with the gaming establishment may cause localized increases in air pollution due to congestion.
 - Increased visitation to the gaming establishment area may place a strain on public transit services.

Cambridge is requesting funds to establish an education program to teach adults how to ride a bicycle safely and be more comfortable riding on urban streets, and particularly between Cambridge and the casino in Everett. In 2025, the Gaming Commission funded e-bikes for the Bluebikes system to enable guests and employees to ride between Cambridge and the Casino more easily. There are 42 Bluebikes public bikeshare stations east of Prospect Street and north of Massachusetts Avenue in Cambridge. Everett also has a network of Bluebikes stations, including at and around the casino. In addition to privately owned bikes, the public bikeshare system provides a non-vehicular option for people to travel more easily to that location without adding congestion and localized air pollution to Cambridge. These new riders will need education to minimize conflicts between vehicles, bicycles, and pedestrians.

To further reduce congestion and vehicular trips in the Eastern Cambridge/North Point/Cambridge Crossing area—identified in previous funding applications to be impacted by the increased traffic to and from the casino—we are proposing to launch an adult Learn-to-Bike-Safely program to increase the number of people riding between Cambridge and the casino. The program will include on-bike trainings and workshops for beginners to become comfortable in riding in a city environment and will end with a group ride from Cambridge to the Encore Riverwalk, using a combination of purchased bicycles, Bluebikes, or private ones if participants prefer. In addition to reducing congestion, such a program, which has been requested in our prior outreach efforts, will give the opportunity for workers and visitors to the casino to bike when other transportation options are not available to them, or don't work with schedules. We also see this class as a way to reduce crashes and conflicts with people on bicycles, and those driving and walking.

These two locations are among the highest for vulnerable road users (bikes and pedestrians) in the City. Separates bike laned provide the greatest protection for cyclists and will leave us enough room to “protect” left turns in the signal cycle, a strategy which is proven to reduce the frequency and severity of crashes.</p>

The fire blanket technology allows for rapid extinguishment with minimal water or extension to other vehicles or buildings.</p>

The training we will be able to provide will keep our medics at the same training level as the team they are imbedded with regularly. Everett is a community within UASI (Urban Area Security Initiative), and Cambridge Fire is on call to respond to this location for Tactical Medic support.

The Cambridge Police Department would like to use these funds to address the increase in commuters resulting in increased congestion on the roads. This congestion leads to increased risk-taking behavior by commuters, resulting in collisions between motor vehicles/pedestrian/bicyclists.

CMF FY25 Funds used in 2024 dedicated to addressing these public safety concerns resulted in over 400 documented stops and interactions with commuters violating traffic laws on the roads in Cambridge designated as Sector 1.

The overall goal of utilizing these grant funds is to reduce harm to those commuting within the City of Cambridge. These grant funds would be used for Traffic Enforcement Unit (TEU) officers and a TEU supervisor to perform high-visibility education and enforcement in the areas most traveled by commuters going to and from the Encore Casino.

This high-visibility education and enforcement would be conducted by the TEU, which was responsible for over 54% of the Department’s documented interactions with commuters within Cambridge in 2024. TEU currently performs high-visibility education and enforcement of the traffic laws when not on other assignments such as school crossings, dignitary escorts, or addressing various other public safety issues in the City.

The roads used in Cambridge to commute to and from the Encore Casino are within an area designated by the Cambridge Police Department as Sector 1. This includes Cambridge Street, Prospect Street, and Hampshire Street and all the intersecting streets which lead to either Route 28 or roads in Somerville which take people to Route 99. Cambridge Street, Prospect Street, and Hampshire Street are all utilized by motorists and bicyclists, with each street having a designated bicycle lane. The intersecting streets, which also have steady commuter travel, are Third Street, Second Street, and First Street, as each road leads to Route 28.

Available traffic data for 2024 shows the most citations in the Department were issued within Sector 1, with 2,517 citations being issued to commuters. Additionally, post 2019, the number of collisions each year has increased city wide. In 2024, there were 1,689 collisions in Cambridge, versus in 2019, the year the Encore Casino opened, there were 1,455 collisions within Cambridge.

The City of Cambridge is committed to Vision Zero, which strives to reduce all traffic related fatalities and severe injuries, while increasing safe, healthy, equitable mobility for all. Currently the Department commits approximately twenty hours a week to motor vehicle, pedestrian, and bicyclist safety.

TEU officers would utilize these funds to conduct high-visibility traffic education and enforcement during the peak operational hours of the Encore Casino. This is to address congestion, contributed to by workers/patrons visiting the casino on the streets of Cambridge which can lead to increased risk-taking behavior by commuters, resulting in collisions between motorists, pedestrians, and bicyclists.

The Department plans to use these funds on Thursday and Friday evenings, during the afternoons and evenings on Saturdays and Sundays, and when major events occur at the Encore Casino. We will have one to four officers conducting enforcement with a supervisor available to approve tows and approve criminal complaints.

Traffic enforcement on Thursdays and Fridays would be between 2:00PM and 6:00AM. For Saturdays and Sundays, traffic enforcement would be conducted between 12:00PM and 6:00AM. Officers/supervisors can work no less than two hours and no more than sixteen consecutive hours between the designated time frames.

The areas of enforcement would focus on the roads people commute on to access the Encore Casino, this would include Cambridge Street, Prospect Street, Hampshire Street, and the roads which connect Cambridge Streets to Route 28, which would include First Street, Second Street, Third Street and Sciarappa Street.

The Cambridge Police have not trained at this level in active shooter training for a number of years and the new national standard, ALERTT training, can be trained to allow for an enhanced response in the event of any active shooter event that will draw a multi-jurisdictional response.</p>

<p>The City of Cambridge seeks funding to provide active shooter training to the police department that would benefit not only Cambridge but all regional partners. In the event of any large-scale public safety event</p>	

regional partners would be called on to assist in any way necessary. The Cambridge Police Department is one of the few Departments in the area that has its own special response team and is therefore uniquely positioned to provide mutual aid should there be an active threat at the Casino. A mutual aid agreement between the Cambridge Police Department and the Everett Police Department ensures assistance to the Casino in any way necessary. Furthermore, the Cambridge Police Department has worked with the Everett police Department on numerous other coordinated training courses before, to ensure an organized response to any event.

The Casino has become of the area’s premier locations for visitors for not only gaming but also entertainment and dining. The attractions offered by Encore Boston bring over eight million visitors annually to the area and these same visitors make their way to Cambridge, only 2.7 miles away, for attractions such as Harvard University, MIT, and historic sites as well. The proximity of so many attractions throughout the area guarantees an increase of visitors throughout Greater Boston. As a result of the influx in visitors it is critical to provide public safety to ensure all visitors feel protected to enjoy themselves.

The most recognized and research based active shooter training in the nation is Advanced Law Enforcement Rapid Response Training (ALERRT), designated as the National standard by the FBI in active shooter response training. The Massachusetts Municipal Police Training Committee also recognizes ALERRT as the standard to be taught at all police academies throughout the state. ALERRT provides in-depth after-action lessons through partnerships between agencies to enhance the overall understanding and response to active shooter events and assists with improving best practices. This is a two-day training that includes classroom work where trained ALERRT instructors go over material pertinent to response protocols for an active shooter situation. Practical hands-on training also occurs to reinforce classroom material and ensure a proper foundation for responding to active shooter situations. Officers are trained in coordination between responding units for an immediate response to neutralize and stop the threat at the same time communicating with responding first responders to provide an adequate response to the aftermath of an event. The grant would fund all patrol officers (including the special response team) to be trained in ALERRT and allow for any future critical event at the encore Casino to have a seamless multi-jurisdictional response. The Cambridge Police Department currently has 6 officers who are certified ALERRT instructors, and they would be instructing six, 2 day trainings to ensure all officers being certified. This would allow for class size to be restricted to 30 officers per course to allow for a 1 instructor to 5 officers ratio. At the end of the grant 180 Cambridge Police Officers will be ALERRT certified. The Department has chosen to focus its request on those officers who would typically be the first responding units called to assist in any event that may occur at the Encore Casino.

The ability for an officer to safely and successfully de-escalate a situation is beneficial to all parties involved. To assist with this goal, we would like to conduct de-escalation training through the use of simulation equipment. Officers engage the simulation, a 10-foot high 12-foot wide screen, and depending on their responses the simulation can adjust to be compliant or non-compliant. Officers are then de-briefed about how they performed and how they may be able to de-escalate a situation better in the future.</p>

The City of Cambridge seeks funding to provide de-escalation training to officers, a vital component of	

former President Obama’s 20th century policing initiative. The Encore Casino attracts over 8 million visitors a year. These visitors will undoubtedly explore the area, to include Cambridge only 2.7 miles away, and visit a number of attractions including MIT, Harvard University, world-renowned museums, and the vast number of historical sights.

De-escalation training significantly reduces the risk of violence, protects both the safety of officers and civilians, builds community trust, and minimizes the need for excessive force by using proven tools to slow down and diffuse the situation through verbal communication and non-confrontational tactics. These tactics include providing officers with resources to offer to individuals as well as verbal persuasion, warnings, slowing down the pace of an incident, waiting out a person, creating distance between the officer and a threat, or requesting additional resources that may assist with the situation. Most calls for service are not related to crime but issues that require a multi-disciplinary approach. Officers should be able to direct individuals to resources and help them in any way they can. Officers are also trained in verbal cues that may increase hostility and are able to identify them and use their knowledge to diffuse the situation to bring a peaceful resolution when necessary.

This training will be delivered using a simulation program. The officers will interact with the program, 3 side by side 10 ft high by 12 ft wide screens, by talking to a simulation screen. They will be given basic information routinely provided by dispatchers while officers are in route to a call. They will then be presented with the call and an instructor will be able to control the simulation, either making the artificial individual compliant if the officer is using proper de-escalation techniques or non-compliant if the officer is struggling to diffuse the situation. The Cambridge Police Department has several officers trained in ICAT, Integrating Communications, assessment, and Tactics. This is a nationally recognized training platform that trains officers to de-escalate situations of crisis through critical decision-making model. Officers are instructed to change tactics in the event their current method isn’t working and to go as far as calling other officers who may have a better understanding of the current situation if needed. Officers are trained to try different methods in the event they are not successful. The funding would allow 2 officers to be dedicated instructors for 8 hours a week. Each shift they work will allow for 8 to 10 officers to be trained. Each training session lasts for 1-2 hours with a debrief at the end to encourage officers to realize where they may be able to improve. Each session allows an officer to experience 3 scenarios and adjust as needed.

We have outlined an intervention which seeks to address each area of the above mentioned recommendations.

The Cambridge Public Health and Arts Department will provide a program to address addiction and harm reduction through harm reduction videos, social media clips, brochures, pamphlets, and artist-led workshops for storytelling, story sharing, and creative expression.

This collaboration aims to support gambling harm reduction efforts by humanizing the experiences and impacts of gambling through real-world stories of individuals and families/care providers. Informed by research that identified vulnerable populations, community perceptions, the social, economic, and environmental concerns of gambling, etc., we will produce four (n=4) person-centered video stories and four (n=4) 30-sec social media clips (e.g., one therapist and three community members from the racial and ethnic groups highlighted in the research, such as Black, Latinx, and Asian populations) filmed in Cambridge, MA. For accessibility, the videos will have closed captioning in English, Spanish, and an Asian language (TBD). Lastly, our project includes linguistically responsive brochures/pamphlets (in English, Spanish, and an Asian language - TBD).

Six two-hour workshops will take place in Fall 2025 and Spring 2026. Open to all. We anticipate an audience from teens to adults. Each workshop would be self-sufficient so that a participant could drop in on one or several without needing to attend in sequence. If participants become engaged and attend multiple times, their experience will build and deepen over the course of however many workshops they attend.

Lead Artist and Workshop Design: Workshops will be led by artist Ben Cunningham, a Boston-based storyteller and educator. Ben has experience with audiences of all ages. He weaves his own storytelling with activities that draw participants into their own storytelling and story-sharing. He uses musical instruments and other props for sound effects and a multi-sensory experience. His workshops will be paired with artmaking, offering participants activities using art materials that are tactile and expressive. In addition, participants could choose to record their stories to be shared digitally or turn stories into written or graphic formats. The workshops will be designed to be open-ended, flexible, supportive, and inclusive while also providing inspirational prompts, guidance, and opportunities to connect with others.

The storytelling/art workshops are geared to the underlying psychological/emotional realm, or personal histories, that might make someone choose gambling, and to the benefit of telling personal stories when one is living with or vulnerable to an addictive pattern. The arts often provide a way of tapping internal issues (sometimes subconsciously) that do not reveal themselves through common means of communication. Expressive arts can bypass conventional ways of communicating which are often intimidating (e.g. being asked to fill out

a questionnaire or being asked if one needs help). As such, a participant can experience a path to harm reduction through an open-ended activity in a self-directed way.

There is a lot of material that addresses the benefit of participating in the arts to health and wellness in individuals and communities, and this proposal is grounded in that research. A very recent [example](#) from the UK studied consuming arts. Active participation has additional power to tap underlying causes of external behaviors.

Research shows the use of art specifically for gambling related issues. In research studies, art was used to help people identify cues that trigger gambling behaviors. A pilot study suggests that art therapies can help women with gambling problems. The COVID-19 exacerbated the need for arts in treating addiction. Here's a few articles.

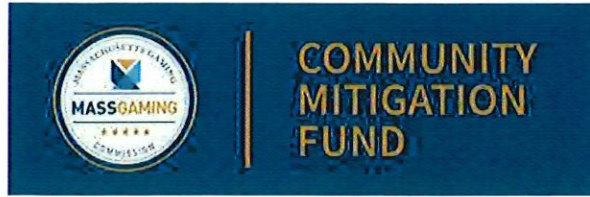
