# **III. Detailed Project Description & Mitigation**

The Massachusetts Gaming Commission's Section 61 Findings pursuant to the Encore Casino describes: "When adjusted for mode share, the3 Project is estimated to generate approximately 17,550 average daily trips ("adt") on a Friday and 20,566 adt on a Saturday." Also, "Assuming no further improvements to Orange Line service and operations prior to 2023, if the Project is built and becomes operational, Orange Line service is expected to be beyond the MBTA's Service Delivery Policy capacity standards for four hours a week, including three weekday non-peak hours... and a fourth hour on Saturday..."

With the project's Supplemental Environmental Impact Report of 2015, estimated trips generated by the Casino were significantly increased: "According to the Trip Generation Summary table, the project is expected to generate a total of 53,228 person trips on an average Friday and a total of 63,332 person trips on an average Saturday." Of these trips, "...43,930 are expected to be made via automobile."

The MEPA filing for the Encore Casino stated that some 70% of the traffic generated by is projected to go through Sullivan Square.

The project addresses the significant increase in trips by single-occupancy vehicles attributed to the operation of the Encore Casino, as well as the excess burden on the Orange Line. During peak riding months, Bluebikes accommodates more than 20,000 trips per day. Stations in the Charlestown area, including at Sullivan Square and Bunker Hill Community College, experienced nearly a 50% increase in trips in 2022 compared with 2021. The Boston Transportation Department proposed to grow the network of available stations and docks in Charlestown to better meet this demand for bike share, and provide a reliable alternative for thousands of people to travel to and from the Sullivan Square area.

3) Please describe what the Applicant is proposing and how the mitigation request will address the impact indicated.

The Boston Transportation Department (BTD) is proposing the expansion of the Bluebikes bike share network in Charlestown. The expansion will include two 19-dock stations near the Sullivan Square Rotary (funded by CMF support), and two 19-dock stations in other parts of Charlestown (funded by BTD). Together, these new stations will help reduce travel by single-occupancy vehicles, by providing convenient, reliable, and affordable transportation by bike to residents, workers, and visitors traveling to and from the Sullivan Square area.

The Bluebikes bike share system is an important part of the transportation network in the communities surrounding the Casino, including Boston (Charlestown), Everett, and Somerville. In 2022, Bluebikes riders took more than 144,000 trips that started or ended at stations in Charlestown. During the peak riding season (July-September), these stations averaged nearly 700 trips per day, (see attached spreadsheet), providing a meaningful share of trips to and from the neighborhood. Users took 43.5% more trips from the Charlestown stations than they did in 2021, demonstrating the significant demand on the system. By expanding the Charlestown Bluebikes network, particularly near Sullivan Square, BTD will help increase capacity to meet this rising demand, and improve the reliability of bike share a transportation option for residents, workers and visitors.

#### Scope of Work

a. *Site planning for two CMF-funded stations* (January – March 2023): BTD staff will survey locations for new Bluebikes stations (tentatively near the Schrafft's Center in Sullivan Square, and on Medford Street in Charlestown).

b. **Site planning for two local match stations** (January – March 2023): In coordination with BPDA PLAN Charlestown team, BTD will identify locations for two additional stations to expand access to Bluebikes in other parts of the Charlestown neighborhood.

c. **Permitting and license agreements** (March – April 2023): BTD staff will secure permits for stations on City-owned property, and if necessary, license agreements on third-party property. d. **Site preparation** (April – June 2023): As necessary, BTD staff will select a vendor and oversee the installation of any hardscape necessary for the installation of new station(s). e. **Station installation** (July – August 2023): BTD staff will oversee vendor (Lyft Bikes and Scooters, LLC) in the planning, scheduling and deployment of the new Bluebikes stations.

The funding limit in this category is \$500,000 per Community. The City of Boston is submitting applications for two separate and distinct uses of funds for Special Impact Grants. Those requests total \$613,500.

The first is the Partner application with Boston Chinatown Neighborhood Center, justified by the Guidelines, to wit: "Where demonstratable gambling related harms exist or have been identified in previous research studies, the Applicant may wish to apply for Community Mitigation Funding under the Specific impact Category." This is exactly the case made in the Partner application, and in a meeting with the Gaming Commission staff on January 19, 2023, which contributed to a more responsive application than the one submitted in 2022. The request is \$493,500.

The second is the Boston Transportation Department application for Active Transportation in Charlestown. This is a request to install two bike-share docks at the Sullivan Square rotary that would accommodate 38 BlueBikes. This work will be matched by City of Boston funds to install two additional BlueBikes docks there. The immediate benefit would be reduced traffic congestion in this area, as well as a low-cost and environmentally friendly alternative to single vehicle travel to and from the Encore impact area. The request is \$120,000.

We believe these two requests fit the purpose of the Community Mitigation Fund to help offset costs related to the operation of the gaming establishment. As there are no other categories of funding that fit these projects, we respectfully request a waiver of the funding limit.
