1. IMPACT DESCRIPTION

The Wynn Resort Casino will be a major tourist generator for the region. Despite being within Everett, there is not a comprehensive wayfinding system to guide visitors to explore and enjoy other parts of the community. The lack of a system will be a lost opportunity to retain visitor dollars within the city. This impact was not significantly highlighted nor thoroughly planned previously.

Wayfinding is a natural extension of existing city and regional efforts to encourage more walking and bicycling by creating a clear and attractive system that is easy to navigate. Whether advertising directly to people traveling by foot, bicycle or indirectly to passing vehicles, the system will encourage use by being both attractive and effortless to follow and understand.

Effective wayfinding assists users alike in traveling between destinations, and will help them discover new destinations and services on foot and by bicycle, car and transit. Wayfinding has the capacity to improve local economic wellbeing by encouraging users to utilize services within their own neighborhood or community. By reflecting local values, wayfinding can also cultivate a sense of pride in one's community, resulting in a deeper connection to place.

Wayfinding signage should not only help visitors find their way around the community, it will also serve as marketing for the community's assets and amenities. Pointing the way to different attractions not only helps people find them - it helps newcomers to the community learn that they exist in the first place. Additionally, the design of wayfinding signage will reflect the character and aspirations of the community, so that the signs themselves become instruments of place-making. Furthermore, we will give careful consideration to the routes chosen to be indicated by signage, in order to present themselves in the best light and promote our neighborhoods and business districts.

Planning:

The cost of initial planning includes the design brief, planning scope and conceptual design.

Design:

The cost of designing the full program including prototype development, approvals, documentation and bidding.

Generally the financing of wayfinding systems is divided into four major areas: Planning, Design, Fabrication/Installation, Ongoing Management.

The costs below are provided by the Sign Research Foundation's Urban Wayfinding Planning and Implementation Manual (2013).

Planning: the cost of initial planning includes the design brief, planning scope and conceptual design. The estimated cost for similar sized communities is approximately **\$30,000**.

Design: The cost of designing the full program including prototype development, approvals, documentation and bidding. Typical design fee **\$150,000**.

Fabrication and Installation: The final cost of shop drawings, fabrication and installation for a community of similar size is approximately \$300,000.

Ongoing Management: Wayfinding systems require changes, maintenance and expansion. Management is typically financed through a range of approaches including destination fees, business levies, city capital budgeting, financing districts, community development block grants, institutional and corporate grants.

As a general rule, maintenance for the system will usually cost the city 10 percent of the total project cost annually - this is only to maintain what is in place. If the city considers future phases, it is likely that these will be planned for at the outset; however, enacting the subsequent steps requires more than planning. Just as all of the city's planning projects have a linear connection to the ensuing stages of development, subsequent phases of the wayfinding system need to consider changes in the city's branding and economic development vision.

This request will give us a comprehensive plan and design guide to construct the signage, site locations and long-term framework for expansion and revisions.

3. CONNECTION TO GAMING FACILITY

As stated, the Wynn Resort Casino will generate thousands of visitors each day. This request will assist the City to expand tourist dollars beyond the boundaries of the gaming facility and into the small businesses and destinations within the community. Presently, there is not a comprehensive wayfinding system to guide visitors beyond lower Broadway.

The City's internal control structure regarding all grants have been designed to ensure compliance with the federal Office of Management and Budget circulars A-87 "Cost Principles for State, Local, and Indian Tribes", and A-102 "Grants and Cooperative Agreements with State and Local Governments" regardless if the grants are not federal. The control structure ensures all transactions are properly recorded and accounted for, and all transactions are executed in compliance with Laws, regulations, and the provisions of contracts and grant agreements. Some examples of these controls include, but are not limited to: The City's accounting system records all grants and the related grant activity in separate funds, and does not comingle grant activity between grants.

The City utilizes a requisition and purchase order system within the accounting system to ensure expenditures are sufficiently authorized for their intended purpose and adequate funding exists prior to procuring goods or services.

The City individual responsible for the management of the grant will be the only individual allowed to authorize expenditures to the grant, ensuring that only legitimate grant activity is charged to the grant. The City's accounting system automatically controls this process, which is then manually reviewed by the City Auditor's office during the payment processing.

Grant records maintained by the City individual responsible for the management of the grant will be reconciled with the City Auditor's office on a quarterly basis. Any discrepancies identified during this process will be researched and corrected within 15 days from the date identified.
