III. Detailed Project Description & Mitigation

1) Please describe in detail the impact that is attributed to the operation of a gaming facility. Please provide documentation or evidence that gives support for the determination that the operation of the gaming facility caused or is causing the impact (i.e. surveys, data, reports).

Springfield, Massachusetts is the cultural and commercial center of the Pioneer Valley region. It is the third largest city in the Commonwealth of Massachusetts, and combined with the surrounding communities, constitutes the fourth largest metropolitan area in New England. Five of the Pioneer Valley region's twenty largest employers are located in Springfield, including the Baystate Health System, the Massachusetts Mutual Life Insurance Company, Solutia, Inc. (Division of Monsanto Chemical Co.) and the Smith & Wesson Company. The City's strong partnership with the business community accounts for the revitalized Central Business District.

Since the opening of the MGM Springfield Casino the Metro area has seen an influx of visitors with both pedestrian and vehicular traffic. MGM has also brought high profile events, drawing larger than normal crowds due to the MGM Sponsorship in connection with each event. With the creation of a 24-hour tourist attraction, one which people frequent to spend money, the homeless population has also increased its presence in and around the casino, primarily targeting the major intersections of the metro/downtown/casino area. A 2020 published Public Safety Impact Report, commissioned by the Massachusetts Gaming Commission, identified several areas of concern worth consideration when identifying and addressing impact. At the time of the report, the MGM Springfield location had become the top area in the region for crimes and calls for service. The report states "in the first year after MGM opened, the most conclusive evidence of effects on public safety has been in certain calls for service related to traffic and visiting population numbers, such as traffic collisions, traffic complaints, and disabled vehicles". The report also identifies micro locations in the surrounding area of the casino to have seen increased activities. Utilizing the Springfield Police Departments Record Management System in collaboration with the Crime Analysis Unit, Springfield has identified that this impact remains true. The attached Call Report generated through the Crime Analyst Unit has shown, within 500 ft of the MGM property, there has been nearly a 53% increase in calls for service between 2021 and 2022. These calls for service are recorded separate from the calls for service occurring directly on the MGM property and handled, primarily, by the Gaming Enforcement Unit. Most notably, the calls for disturbance, trespassing, property damage, business alarms, larceny and accident with injuries have all seen increases.

The increase in traffic also has an assumed negative impact on "hidden crimes". At the time of the Public Safety Impact Report, it had been identified that "police statistics are a poor measure of "hidden" crimes like human trafficking, and thus we must look to more creative ways to blend information and intelligence from a variety of sources". The Springfield Police department has added additional efforts around Anti-John Deployments in the Metro/Casino area but with limited resources it cannot expand these efforts to make a continual identification of the problem.

The Springfield Police Department continues to provide measures, efforts and resources above and beyond what was anticipated with the opening of the MGM Springfield Casino. Another demonstration of this would be dedication of two cruisers from the pre-casino fleet. At the time of opening, it was determined necessary to keep one marked and one unmarked cruiser at the casino property. These vehicles have been paramount to successful, necessary and crucial operations for the Gaming Enforcement Unit. During the 2023 Gaming Enforcement Unit (GEU) Budget Request, the City

of Springfield identified the need to replace the existing cruisers due to them being at end-of-life. The City was instructed to apply for the cruisers as part of their 2023 Community Mitigation Fund request as it was communicated to be the more appropriate funding source for the request.

In complement to the Gaming Enforcement Unit, the Metro Unit is a community-based, problem-oriented C3 policing unit with an area of patrol responsibility for the downtown (Metro Center), South End area. The Metro Unit serves to address quality of life issues in the area surrounding the MGM Casino resort, such as petty thefts, aggressive panhandling, drug use and rampant homelessness. Using a problem-oriented policing strategy, the unit assertively acts to prevent crime and proactively manages conditions that erode livability, breed disorder, and create a climate of fear. The Metro Unit's area of responsibility annually generates the highest number of 911 behavioral health calls for service. In addition to the area surrounding it, the Metro Unit also serves the MGM Casino area as reinforcement to the Gaming Enforcement Unit.

The City of Springfield was fortunate to see an overall normal-to-low crime volume throughout 2020 and 2021 but these numbers have been increasing with the reduction in COVID restrictions and business going back to "normal". Again, this has been demonstrated through the calls for service report previously mentioned. As numbers continue to increase it is crucial for the City of Springfield, in collaboration with the Massachusetts Gaming Commission, to remain vigilant in our efforts to provide a positive experience to the residents and patrons alike surrounding the MGM Springfield Casino.

2) (If applicable) Please explain how this impact was not anticipated in the Applicant's Host or Surrounding Community Agreement.

Per the Host Community Agreement (HCA), the City of Springfield receives a fixed Community Impact Payment of \$2.5M per year plus the CPI Adjustment Factor. These funds go directly to the City's \$755.7M+ budget which provides casino mitigation support such as police and fire protection, administration, housing and public works services, and gambling outreach/education. Although the \$2.5M Community Impact Payments support casino mitigation efforts, it does not cover for all of them. The request outlined in the 2023 Community Specific Impact / Mitigation Fund Application would not be funded by MGM's Community Impact Payment.

- 3) Please describe what the Applicant is proposing and how the mitigation request will address the impact indicated.
 - 1. Specific Overtime Deployments
 - a. Traffic Deployments
 - i. The Springfield Police Department is requesting overtime funding that will allow for approximately thirty-four (34) 4-hour deployments, comprising of (2) two officers each, that will focus on traffic control and high visibility patrols in and around the MGM garage. The patrols will assist in releasing traffic from the MGM Parking Garage after the ending of large venue events.

As of September of 2022, MGM has reported an increase in vehicles parking at the MGM garage when large venue events are occurring at the Mass Mutual Center. MGM staff has requested the Metro Units assistance with traffic control after such events to assist exiting vehicles onto surrounding streets and prevent patrons from being stuck in the parking garage for hours at a time, unable to exit. There are a minimum of 34 large venue events that

are expected to take place over the course of 2023 that will require assistance in expediting the flow of traffic out of the MGM garage and onto surrounding streets and intersections, which is when these deployments would occur.

In 2021 there were over 1,100 calls for service within 500 feet of MGM, and in 2022, there were over 1,900 calls for service, an increase of 600 calls for service. These calls included disturbances, gun calls, stolen vehicles, breaking and entering motor vehicles, shots fired, and robberies. In 2022, there were also 6 illegal handguns recovered from vehicles parked in the MGM garage. It is clear that the MGM Gaming Unit would benefit from reinforcement during these occasions where there is increased patronage at the MGM garage, and as such the requested deployed officers will also focus on high visibility patrol in and around the garage.

b. Anti-John Deployments

i. The Springfield Police Department is requesting funding that will allow for approximately four deployments of 4 hours each, comprising of (20) Twenty officers, (2) Sergeants, (1) Lieutenant, and (1) Captain, to conduct "John" Sting Operations in the immediate vicinity of the MGM Casino.

Over the past two years the Springfield Police Department has conducted "Sting Operations" targeting individuals who were seeking prostitution services in Metro Division area of Springfield. In 2021, there were 7 such deployments that resulted in 52 arrests of individuals who were attempting to solicit sex and in 2022 there were 4 deployments that resulted in 34 arrests. These deployments have historically been paid for by City funds and as such are limited by the funding available for them, which resulted in the drop from 2021-2022. Springfield would like to increase the number of deployments back to at least 7. Funding received by the Community Mitigation Fund for these deployments would be used to complement rather than supplement the City's budget for these deployments and would result in a direct increase in the number of planned "Sting Operations". With these proposed deployments, it is anticipated that the resulting arrests will cause a reduction in the demand for such activities and an overall reduction in prostitution activity in the immediate vicinity of MGM.

c. Homeless Outreach Deployments

i. The City of Springfield is requesting personnel funding for two (2) Patrol Officers and 1 Supervisor, for 60 deployments of 4 hours each to assist in Homeless Outreach.

The Metro Unit's catchment area features the highest and most visible concentration of homeless persons and illicit substance users, many of whom suffer from mental health issues. Per the City of Springfield's Office of Housing, Hampden County reported 427 chronically homeless individuals in FY22, with the vast majority located in or coming through Springfield due to the number of social service agencies and since it serves as a central location for people seeking illegal drugs. In FY22, Springfield had identified 37 unsheltered individuals, an increase of 21 persons over the FY21 number (16). To address the City's mental health issues, four (4) BHN Co-Response crisis

clinicians are based out of the Metro Unit substation – a block away from the MGM Casino resort. As such, the Metro Unit is uniquely qualified to help deliver, with BHN clinicians and other stakeholders, wraparound services to members of underserved populations. This initiative will vastly reduce the number of problem engagements with the homeless/co-occurring mental health/addicted population in and around the MGM Casino resort.

The Metro unit will deploy officers, along with clinicians from the Behavioral Health Network, to locate and identify homeless individuals who are in need of mental health, addiction or housing support services. The Metro Unit will leverage its long-standing partnership with the Behavioral Health Network to direct targeted outreach to homeless and other disenfranchised persons in the area of whose addiction and/or mental health issues put them at risk for entry into and sustained engagement with the criminal justice system. With the twenty-four hour operational window, the MGM Casino resort attracts disenfranchised persons who lack adequate shelter and stability. Rather than trying in vain to issue arrests related to the public health problem that homelessness, addiction, and mental health issues have become, the Metro Unit proposes to use this funding opportunity to holistically divert underserved populations in the Metro Unit catchment. This will redirect the homeless population away from the never-ending cycle of the criminal justice system they are all too often exposed to, and will offer a more long-term solution that will benefit the homeless individuals and the MGM Casino area and its patrons.

An average deployment will be twice a week, four (4) to five (5) hours long and consist of (1) or (2) teams of two officers and (1) supervisor on an overtime basis. Metro Unit officers will deploy to known locations (public, open-air, and/or quasi-public "right of access" spaces) in the downtown and riverfront area used as living or gathering places for unsheltered persons, with a focus on MGM Casino and the immediate surrounding area, which receives a higher population of unsheltered individuals due to their hours of operation. Unsheltered persons will be referred to our Office of Housing's Continuum of Care 'CoC' program service providers and additionally supported by SPD Hub+Cor and Co-Response initiatives. Through intentional engagement and intensive supports to the target population, we will identify those persons whose mental health/addiction issues have left them acutely destabilized and at risk to themselves and others, and direct them to support services. Deployments will be responsive to CoC manager and provider partners to address emergent and other situations involving unsheltered persons as directed by the CoC manager. Metro Unit officers will generate and supply the CoC manager with a general activity report following each deployment (in addition to completing all other grant required reporting as specified). We believe that this funding opportunity supports innovative program that has the potential to substantially improve the lives of our most vulnerable community members and help pave the way for sustainable change.

2. Police Cruisers

a. The City of Springfield Police Department would like to request funding for two cruiser replacements. When the Gaming Enforcement Unit (GEU) was implemented, the Police Department utilized two of the existing cruisers from the fleet in 2018; one marked and one unmarked. SPD would like to replace the severely outdated vehicles that have been dedicated to the GEU. The existing unmarked cruiser is from 2008 and the marked cruiser is from 2014; both vehicles will likely be out of commission in the near future. While the City of Springfield did note this need during the FY23 GEU Budget Request, it was communicated that the Specific Impact grant would be a more appropriate source of funding, due to the direct impact that the Casino has on cruiser usage.

At this time the GEU use their cruisers on a daily basis. In a 24-hour period, each shift does 2-3 property checks at the Casino and use their cruisers on all levels of the Casino parking garage. They also do perimeter checks and use their cruisers when necessary. They use their cruisers to travel to Boston for any training made necessary by the Mass Gaming Commission. In 2022, members of the Springfield GEU made 65 arrests where their cruisers were utilized for transports to and from the Springfield Police Department headquarters located at 130 Pearl Street. In addition, officers traveled to and from 130 Pearl Street to use computers for 50 Criminal Complaint requests that could only be entered from this location. These criminal complaints are over and above the 65 arrestees that were transported to 130 Pearl Street. They also use their cruisers to assist any heavy equipment operators entering from the public way onto MGM properties. The replacement of the cruisers will ensure continued daily operations.

3. Sexual Assault Training

 a. The City of Springfield would like to request funding to provide five (5) officers with Sexual Assault Investigator Training and backfill staffing to cover attendee's responsibilities.

Between January 1, 2022 and January 1, 2023, two dozen various types of sexual assaults were reported and documented to have occurred in the Metro Unit's patrol area. The overwhelming majority of victims of sexual assault are statistically women and children. Many of these occurred in residences, schools, hotels, bars/nightclubs, and other entertainment venues. Others occurred in public spaces or vacant structures. The fourteen-acre MGM – Springfield resort and hotel is centrally located in the Metro Unit catchment area and spans three downtown city blocks between Union Street to State Street and East Columbus Avenue to Main Street. Factors exacerbating these types of incidents are the large number of entertainment and lodging venues in the Metro Unit catchment area and its established drug-trade; elemental to the victimization of women patrons of these establishments and the volume of sexually-trafficked, drug-addicted women settled here. With an inside-out design and integrated gaming space and hotel, the troubles effecting Main Street regularly are often casted upon MGM-Springfield. For MGM-Springfield, this perception has sometimes unfairly become reality in the form of diminished patronage and guest confidence.

Given that timely and comprehensive investigation is paramount to the successful investigation of sexual offenses, Metro Unit officers are often tasked as the first responder to and chronicler of these incidents. During the stated time period, Metro Unit officers have been the first reporting officers to roughly ten of these incidents. Because offenses involving sexual assault and other deviant behavior are among the most complex and difficult types of crimes to investigate and prosecute, MPTC -Sexual Assault Investigator training will allow Metro Unit officers to best assist the victims of these traumatic events and help hold accountable those persons who commit such heinous acts. The Metro Unit proposes to utilize FY 2023 Specific Impact Grant funding to send up to five (5) officers to the MPTC – Sexual Assault Investigator Course, as training opportunities permit. To maintain operational readiness, backfill staffing will be utilized to cover attendees' positions.

4. Interlocking Galvanized Steel Barricades

a. The City of Springfield would like to request funding to purchase interlocking galvanized steel barricades to be used in and around MGM Casino. The Police Department has identified a need for metal barricades to help with crowd control and pedestrian safety during large scale events that occur in and around the MGM Casino. Events like the Fourth of July Fireworks Display and The World's Largest Pancake Breakfast, both of which attract over 100,000 attendees, and Springfield Thunderbirds Hockey at the Mass Mutual Center, which can attract up to 5000 attendees per game, often create a significant traffic control and pedestrian safety problems. These issues have been exacerbated through MGM sponsorship along with provided parking via MGM. Sturdy, interlocking metal barricades will assist the Police Department in pedestrian traffic control enforcement efforts during these events by effectively constraining pedestrian traffic to sidewalks and directing the traffic to crosswalks, thus preventing large crowds from spilling out of the sidewalk area and onto busy streets and intersections. The use of these barricades will be utilized in maintaining pedestrian safety for visitors of the MGM Casino and MGM Sponsored events occurring downtown and at the Mass Mutual Center and the Springfield Symphony Hall.

5. Metro Division Drone

a. The City of Springfield would like to request funding for a Metro Division Drone to assist in surveillance and recon where on-the-ground operations are limited.

Since the opening of the MGM casino, the Metro area has seen in influx of visitors and both pedestrian and vehicular traffic. MGM has also brought with-it, high-profile events, which draw even more visitors during the time it has been open. The use of a drone can provide invaluable surveillance and recon of these large events without having to use more on the ground officers. Drones can quickly and easily be tasked with updating traffic issues, which is a current ongoing issue with events in the downtown metro area, specifically the MGM parking garage and MGM sponsored events at Symphony Hall, allowing officers to deploy to exact locations and ease traffic concerns. Drones can also surveil large outdoor gatherings, parades, and events to add an extra layer of security by watching for any would-be persons with malicious intent, or locate individuals whom are behaving in a way requiring expulsion from the event and/or arrest. Recently a call from MGM for an Active Shooter

occurred. Had this been an actual active shooter, a drone could be used to safely locate and then direct police personnel to the subject in a timely manner potentially saving lives. Another factor is the homeless population that has been drawn to the area surrounding MGM. This vulnerable population tend to camp in hard to locate and remote locations on the riverbank and elsewhere close to the casino. There is also a higher amount of drug use amongst this population. A drone would make it possible to expedite the location of any persons in need of life saving medical help and direct responding personnel, potentially saving lives. The requested amount will cover the cost of the purchase of the drone and equipment such as the camera with night vision and thermal capabilities, and the training of two officers and all FCC certificates needed for a drone program in a department.

6. Mossberg 85360 DS 12GA Tactical Shotgun with Sling/Optic

 The City of Springfield would like to request funding to upgrade their tactical gear shotguns.

With the casino bringing new and increased criminal activity to the city, it is important that our officers are prepared to respond with the most effective and tactical gear. In order to protect our officers while responding to dangerous situations that require the highest level of equipment reliability, the Metro Unit is looking to replace outdated pump action shotguns with semi-automatic shotguns. In 2023, the Springfield Police Department will upgrade their inventory of Mossberg pump action shot guns to Mossberg semi-automatic shotguns. In order to maintain adherence to Springfield Police Department Policy on the use of department approved weapons, it is necessary to replace Metro Divisions four (4) shotguns, previously purchased with mitigation funds in 2021. The current pump action Mossberg shotguns will be traded in for the appraised value of \$300.00 each (\$1,200.00 Total), which will be applied to the balance of the purchase of the replacement shotguns, which are valued at \$769 per rifle (\$3,076 Total).

In consideration of this, the City of Springfield would like to formally request a waiver as we believe it to be consistent with the purposes of M.G.L. c. 23K, it will not adversely affect the public interest and not granting the waiver could cause a substantial hardship to the City.






