#### Call to Order

10:00 a.m. Chair Cathy Judd-Stein called to order the 65th Agenda Setting meeting.

### **Approval of Minutes**

Commissioner Stebbins moved to approve the minutes from the Agenda Setting Meeting of October 30, 2019, subject to correction for typographical errors or other nonmaterial matters. Commissioner Cameron seconded the motion. The motion passed unanimously.

### **Agenda Planning for Upcoming Commission Meetings**

(Scheduled Commission Meeting on November 21, 2019, at 10:00 a.m.)

<u>Item #1 - Administrative Update</u>. Ed Bedrosian will have an administrative update.

<u>Item #2 – Regulations</u>. The Legal Division will bring two sets of amended regulations for the final phase of the promulgation process, regarding junkets and licensing. There is a public hearing scheduled to take place at 9:30 a.m., prior to the Commission meeting on

November 21. The Chair noted that she would like to discuss putting regulation hearings as an agenda item for Commission meetings in the future.

<u>Item #3 –MGM Springfield Quarterly Report</u>. Mr. Ziemba stated that he should have all materials by Friday, and this report will be ready to present, with MGM staff present.

<u>Item #4 – Encore Boston Harbor Quarterly Report</u>. Mr. Ziemba will have this report ready to present, with Encore staff present.

<u>Item #5 – GameSense Procurement Update</u>. Commissioner Zuniga will have this item ready for a discussion and vote to ratify the procurement of a GameSense program manager. Mr. Bedrosian noted that a Public Safety meeting would need to occur prior to the ratification. He would like to include a Q&A and have Commissioner Zuniga review the process and provide/hear substantive recommendations.

<u>Item #6 – MA Gaming Commission FY20 1st Quarterly Report and Vendor Diversity Update.</u>
This item will be ready to present. There will be a PowerPoint presentation featuring VeriCloud for the Vendor Diversity Update.

<u>Item #7 – Litigation and Federal Legislation on Region C</u>. Mr. Bedrosian recalled a memo from two meetings ago that covered potential next steps in the process. He noted that some of the items have been changed after the GPAC meeting yesterday. Mr. Bedrosian requested extra time on this until December  $5^{th}$  so that he can present the litigation update and add an update to potential draft RFI questions.

Added item: Jill Griffin would like to add an update item called, "Build a Life Campaign Update." Ms. Griffin would like to update the Commission on the campaign's efforts and celebrate its anniversary.

Added item: Karen Wells would like to add an item to discuss policy clarification on how the IEB is to use sealed records. She would like to review with each commissioner individually. There would then be a discussion at the November 21st Commission meeting with a memo provided by Ms. Wells, and a potential vote at the December 5th Commission meeting. 2x2 meetings with commissioners will be scheduled on this. Ms. Griffin will then post for public comment to obtain feedback from stakeholders.

(Potential Commission Meeting on December 5, 2019)

<u>Item #8 – Community Mitigation Fund Final Guidelines</u>. Mr. Ziemba will have this item ready for a vote. He will bring all public comments to the meeting, as well as feedback from the regional Local Community Mitigation Advisory Committee (LCMAC) meetings.

<u>Item #9 – Licensee Sexual Harassment Policies</u>. Commissioner Cameron's working group have drafted a regulation on this, and may have an updated draft ready, with comments received for the December 5<sup>th</sup> Commission meeting.

<u>Item #10 – Review of MGC Enhanced Code of Ethics</u>. Commissioners will submit comments to Deputy General Counsel Todd Grossman. This item may be rescheduled to a later date.

<u>Item #11 – Encore Boston Harbor 90-Day Commitments</u>. Mr. Ziemba will have this item ready to present.

<u>Item #12 – Minority Equity Participation</u>. This presentation can be moved up to the November 21<sup>st</sup> Commission meeting, and Commissioner Stebbins will also provide an update.

<u>Item #13 – Local Community Mitigation Advisory Subcommittee on Addiction Services</u>
<u>Strategy.</u> Mr. Ziemba stated that the team is still working on recommendations. Mr. Vander Linden confirmed that this item will be ready for December 5<sup>th</sup>. He will be able to update the Commission with a full report on the Public Health Trust Fund at the next meeting.

Item #14 - MGC 2019 Annual Report. This item will be ready to present.

<u>Item #15 – Social and Economic Impact Research Procurement Update</u>. Mr. Vander Linden will have this presentation ready. He is drafting a third round of questions and will be ready to move forward with a recommendation for the Commission that will require a vote.

Item #16 - Quarterly Report Review. Mr. Ziemba stated that this item should be ready.

<u>Item #17 – New England Gaming Market Update</u>. Commissioner Zuniga is currently monitoring this and collecting data.

<u>Item #18 – GameSense Update</u>. Mr. Vander Linden and Teresa Fiore will have this item ready to present with GameSense advisors at the December 19<sup>th</sup> Commission meeting.

<u>Item #19 – Gaming Economic Development Fund White Paper Update</u>. This item is currently under review.

There was discussion around writing a draft letter to the legislature regarding the racing bill for the Commissioner's review. This draft will be submitted as soon as possible.
