RE: Postponement of Live Racing Opening at Plainridge

Dear Commissioners:

Due to the COVID-19 pandemic, on March 16<sup>th</sup>, 2020, Steve O'Toole, Director of Racing for Plainridge Park Casino; Gayle Cameron, Commissioner for the Massachusetts Gaming Commission; and I met by phone to discuss the opening day of live racing at Plainridge. The opening was originally scheduled for April 6, 2020. On March 15<sup>th</sup>, Massachusetts Governor Charles Baker issued an order prohibiting gatherings of over 25 people through April 5. The Center for Disease Control recommendation at the time of our call was for cancelling events of more than 50 people for the next eight weeks throughout the United States. As everyone is aware, State and Federal guidelines are being adjusted as needed. Horsemen gathering in the paddock with their horses would exceed both numbers, putting themselves and personnel from Plainridge Park Casino and the Massachusetts Gaming Commission at risk.

Once the risk of COVID-19 is over, the horsemen must prepare their horses for racing, and the track and the Division of Racing must also be able to prepare. With this in mind, Mr. O'Toole and I are proposing that, out of an abundance of caution, and with the best interests of the participants, employees, patrons and horses, the opening day of live racing at Plainridge be postponed until June 1, 2020, with a status update around May 1, 2020. Then it could be determined if Qualifying races could take place on May 25, 2020.

Mr. O'Toole has discussed this with Robert McHugh, President of the Harness Horsemen of New England. I have discussed this with Alice Szpila Tisbert, Managing Director of the Harness Horsemen of New England. Please see the letter Ms. Szpila Tisbert submitted, detailing their position.

This is a very fluid and rapidly changing situation and will be re-evaluated as needed.



**Recommendation:** That the Commission postpone the April 6, 2020 opening of Plainridge Racecourse to June 1, 2020.

I am sending this to you as a follow-up conversation on the afternoon of March 16, 2020 where you wanted to move opening day from April 6<sup>th</sup> to June 1<sup>st</sup>. I preliminary agreed with your recommendation given the seriousness of the corona virus which has yet to peak. I concurred with your thoughts since my understanding is the delay would be in line with the opening of the casino. You also believed as a former horseman, it would be best for trainers to have a known start date so they could get their horses ready.

After contemplating this issue further and reviewing the situation, many trainers have been jogging and getting their horses ready to race since January. When the Governor of the Commonwealth determines that businesses are safe to open, I think it is more than fair to expect racing to commence on or when the Casino opens, and you can be sure the trainers will have their horses ready to race. The Federal Government is providing a stimulus to assist people that are not receiving pay checks; for every lost day after April 6<sup>th</sup> that the track is idle, the horsemen and women are not able to earn purse money that will never be recovered and there has been no racing since the end of November which results in many individuals being in a desperate financial situation. There is no stimulus available to assist these horse men and women.

On behalf of the HHANE, this is to request that Plainridge open as soon as it is clear to open the Casino. Thanks in advance for your review and understanding.

Dear Dr. Lightbown,

Thank you for your call regarding the potential date to open the harness racing season in Massachusetts, which may be delayed from April 1, 2020, given the COV-19 coronavirus flu emergency. In order to guide the Massachusetts Gaming Commission, this letter will serve to document the Association's position on that topic.

In essence, the Association states that if the casino is able to open for the public, that the racetrack should also open at that same time. The Harness Horseman's Association of New England, Inc. (HHANE) fully supports all decisions by our Governor, the MGC, our local, state and federal officials. To that end, we feel when it is safe for patrons to return to the Casino, so will conditions be safe for horse racing and the betting public. The lead time in announcing the opening of the Casino is sufficient time for Trainers to have their horse ready, as they and the track were prepared for the first qualifier that was scheduled for next week. Trainers are willing to maintain the fitness and safety of horses for that opening date as soon as it is appropriate to do so.

Many people think of the race tracks as the only business entities involved in the operation of racing, but the truth is that there are hundreds of small businesses throughout the state, owned and operated by Massachusetts horsemen and women, including jobs associated with the racing division of the MGC.

We will continue to keep members informed as new information comes forward and look forward to working with the MGC and PNG on implementing a successful live racing meet whenever that might be possible.
