Call to Order

Chair Judd-Stein called to order the 344th public meeting of the Massachusetts Gaming Commission. She noted that given the unprecedented circumstances resulting from the global Coronavirus pandemic, Governor Baker issued an order to provide limited relief from certain provisions of the Open Meeting Law to protect the health and safety of individuals interested in attending public meetings, and that in keeping with the guidance provided, the Commission would conduct this meeting utilizing remote collaboration technology.

All four commissioners were present for the meeting.

Chair Judd-Stein noted that in light of the new guidelines from the Center for Disease Control (CDC) and the Massachusetts Governor's office concerning COVID-19 provisions, the Commission will be holding a special public meeting on May 26th during which the Commission will discuss new plans for gaming licensees, racing, and simulcasting operations with representatives for each.

She also noted that the agenda was amended to reflect that the Commission will not be addressing a particular horse racing item but will do so at a later meeting.

Administrative Update

Executive Director Karen Wells and Research and Responsible Gaming Director Mark Vander Linden noted that Research and Responsible Gaming Program Manager Teresa Fiore will be leaving the organization. Director Vander Linden acknowledged and thanked her for her years of service and success with the Commission. The Commissioners thanked her for her excellent work and wished her the best of luck.

On-Site Casino Updates

Director of the IEB Loretta Lillios updated the Commission on the operations at the gaming establishments. She stated that the licensees have continued to enforce the health and safety measures put into place by the Commission and the Governor. Director Lillios recounted the various measures and adaptations that the licensees' have made during the pandemic and reiterated that the licensees have complied with pandemic provisions the whole time. She commended the State Police and enforcement agents who have been on-site during the pandemic. She noted that Encore and MGM have implemented incentive programs for employees to encourage vaccination and that Plainridge Park Casino (PPC) also has encouraged employees and patrons to get vaccinated.

Gaming Agents Division Chief Bruce Band noted occupancy levels have been in compliance and corroborated Ms. Lillios' statement that licensees have been encouraging and incentivizing employees and patrons getting vaccinated.

Director of Racing Dr. Alexandra Lightbown noted that Plainridge had started live racing and simulcasting and that employees, horsemen, and spectators have been complying with pandemic measures. She noted that racing employees have been working in person since last summer.

Licensing Division

Licensing Division Chief Nakisha Skinner presented three positions to be considered for exemptions from service and employee registration requirements.

Commissioner Cameron moved that the Commission exempt the fry cook, expediter, and board and window positions at Wahlburgers at MGM Springfield from the registration requirements in accordance with 205 CMR 134.03(1)(b) for the reasons discussed today and as described in the Commissioners' packet.

Racing Division

a. Update on Horse Racing Testing Process

Dr. Lightbown updated the Commission on the race horse testing process. She noted that the lab that is used for testing is accredited by the Racing Medication and Testing Consortium and ISO. She explained the classes of horse-related drugs that are forbidden from use and those that are permitted. She also explained that there are regulations for drugs administered by horse racing veterinarians, universal drug testing standards, test barn, and split-sample testing protocols. She noted that these best practices have been helpful.

Commissioner Cameron mentioned that RCI listed the Commission's racing program as a top model agency for the country. Commissioner Zuniga asked whether there were practices recommended by the new horse racing act that the Commission has not implemented that it should consider. Dr. Lightbown mentioned that the Horse Racing Integrity and Safety authority would be new and has not worked on promulgation of regulations yet, but much of what is written in the statute is already in effect.

b. Update on Horse Racing Integrity and Safety Act

Dr. Lightbown informed the Commission of the Horse Racing Integrity and Safety Act, which was recently signed into law and which recognizes the Horseracing Integrity and Safety Authority (HISA), a private entity, for the purposes of developing and implementing a horseracing anti-doping and medication control program and a racetrack safety program for thoroughbred racing. She noted that other racing breeds of horses may be included in the developed program if the individual state Commission or breed governing organization opts in. She further noted that questions exist as to how this will be funded, whether the Commission should pay lab fees to the authority, and whether the standardbred racing industry should be opted in. Chair Judd-Stein asked Dr. Lightbown to confirm that the Commission will have plenty of time after the bill is enacted to discuss and gather public comment on whether the standardbred industry should opt into its regulations, to which Dr. Lightbown answered that they would have sufficient time.

c. Standard Owners of Massachusetts (SOM) Recognition Request as Breeders' Representative Group

President of Standardbred Owners of Massachusetts (SOM) Chip Campbell requested that the SOM be recognized as the organization to administer the standardbred breeding and sire stake program. He noted that the

racing secretary writes races that give preference to Massachusetts-bred and owned horses, giving more local horsemen incentive to stay in the Commonwealth and contribute to racing revenue. Commissioner Cameron noted that the breeding numbers were impressive considering last year's pandemic-related difficulties. Dr. Lightbown recommended that the SOM be appointed the representing organization for the breeding program and sire stakes races of 2021.

Commissioner O'Brien moved that the Commission approve the SOM, Inc as representative organization of Standardbred breeders and owners referenced in Chapter 128, § 2J. Commissioner Cameron seconded the motion.

d. 2021 Harness Meet Update

Dr. Lightbown presented an update of the 2021 meet and introduced Plainridge Racing Director Steve O'Toole. Director O'Toole noted that there were 68 racing days in 2020 and 108 days in 2019 and provided details on purse amounts as well as special events being held at Plainridge. The Commission thanked Director O'Toole for his report.

e. Massachusetts Thoroughbred Breeders Association Request for Consultation

Dr. Lightbown explained that the Massachusetts Thoroughbred Breeders' Association is in a consulting role under G.L. Chapter 128 with respect to how they are able to use their breeders money. Dr. Lightbown noted that a meeting was previously held with herself, Chair Judd-Stein, Commissioner Cameron, General Counsel Todd Grossman, Executive Director Wells, and individuals from the Association to discuss plans and how those plans might reconcile with the statute. Dr. Lightbown noted that the packet includes a letter memorializing what was discussed at that meeting and providing recommendations. Dr. Lightbown highlighted portions of the plans noted in the letter, including paying out races to the sixth place rather than the third place, providing a 5% bonus increase for various owners, and creating breeders incentives.

Commissioner O'Brien asked if there is an additional step to this consultation or if this letter will be the conclusion. General Counsel Grossman noted that it will depend on the response to the recommendations and that it may warrant an ongoing conversation. Chair Judd-Stein noted that The Breeders Association also have a statutory obligation to consult with the Department of Agriculture.

Executive Administration

a. Regulation Review Update

Executive Director Wells presented a summary of the proposed regulatory review process. She noted that she has been working with Commissioner Zuniga and Associate General Counsel Carrie Torrisi to develop the proposed regulatory review goals, including ensuring regulations are clear, well-written, and understandable; eliminating duplicative or contradictory requirements; eliminate unnecessary and minimize overly burdensome requirements; ensure reporting requirements are necessary and provided information is used by the agency; and eliminate barriers to equity and inclusion. Executive Director Wells explained that these goals will allow ease of navigation, will ensure that the regulations are fair, and will reduce unnecessary regulatory burdens. She noted that a proposed review process includes receiving Commission feedback on the proposed goals, developing a form for the review process, identifying a set of regulations to begin the review, developing a timeline for the review, developing a process for stakeholder input, finalizing any regulatory revisions, and presenting proposed changes to the Commission through normal regulatory approval process.

Commissioner Zuniga noted that this type of review is best practice and converges with the Equity and Inclusion Working Group's goals. He noted as well that there are certain regulations that the legal department has already identified as needing review and updates and that those changes will be addressed in conjunction with the regulatory review.

Chair Judd-Stein recommended the addition of the goal that a regulation be consistent with and not in conflict with state and federal law. Commissioner O'Brien recommended that the goals be modified to include removal of obsolete regulations.

Community Affairs Division

a. Community Mitigation Fund Application Reviews

Chief Joe Delaney presented the Community Mitigation Fund Transportation Planning, Transportation Construction, and Community Planning grant applications.

Chief Delaney first presented the Transportation Planning applications. The City of Boston requested \$200,000 to redesign Sullivan Square, through which much of the casino traffic travels. Chief Delaney noted that the Commission has funded this project for the last three years and that the City indicated that this should be their last request for design funds. Chief Delaney noted that both Encore and MassDOT were in support of this application. The review recommended awarding a grant in the amount of \$200,000 to the City of Boston. Commissioner Zuniga emphasized that Sullivan Square has a serious need for redesign. Chair Judd-Stein reminded the Commissioners that they had previously voted on the Specific Impact category applications.

Chief Delaney presented Malden's request for \$200,000 for design improvements to their Broadway corridor. Chief Delaney noted that while the review team noted that there is an impact on Broadway, it is relatively minor. Chief Delaney further noted that the review team found that the requested funds were proportionate to the impact. The review team recommended awarding a grant in the amount of \$200,000 to the City of Malden.

Chief Delaney presented West Springfield's request for \$147,600 to design complete streets improvements to Elm Street area and to purchase traffic-counting equipment. Chief Delaney advised that the review team did not support this project. Chief Delaney explained the history related to this project and noted that the review team could not identify an impact of the casino that is associated with the expansion of the project or the need for traffic-counting equipment. Chief Delaney noted, as well, that MassDOT and MGM expressed reservations with this project. Commissioner O'Brien noted that she and Chief Delaney had discussed whether the amount could have been broken down to determine if there were a segment that was the result of casino impact; Chief Delaney explained that the applicant was not able to provide a breakdown. Commissioner Cameron asked if it were the case that that traffic counting at this stage would not provide much useful data given that they had not established a traffic baseline before construction of the casino and Chief Delaney confirmed.

Chief Delaney noted that the Commission had discussed Transportation Planning applications from Chicopee, Everett, Malden, Lynn, Boston and West Springfield thus far.

Commissioner O'Brien moved that the Commission approve the award of the following grants from the Community Mitigation Fund specifically pertaining to transportation planning, namely: to Boston for \$200,000 for Sullivan Square/Rutherford Avenue, to Chicopee for \$200,000 for center streetscapes, to Everett for \$200,00 for the Mystic Riverwalk, and to Malden for \$200,000 for the Broadway improvements. These grants are for the purposes described in the memos in the Commissioners packets and submitted applications as discussed here today as well as on May 6, 2021, and that further Commission staff be authorized to execute a grant instrument commemorating the awards in accordance with 205 CMR 153.04. Commissioner Zuniga seconded the motion.

Commissioner O'Brien moved that the Commission deny the following applications to the Community Mitigation fund for transportation planning,

namely Lynn for design improvements and West Springfield for Elm Street improvements. Commissioner Zuniga seconded the motion.

The motion passed unanimously.

Moving on to the Transportation Construction applications, Chief Delaney presented the City of Boston's request for \$239,000 for geometric changes to Brighton Street and Cambridge Street in Charlestown to create safer crossings and better lines of sight for turning vehicles. Chief Delaney explained the history of this project. Chief Delaney explained that communities may request a waiver for the Community Mitigation Fund requirement that the fund not pay more than 1/3 of the total construction costs, and that the City of Boston did request that waiver. Both MassDOT and Encore were supportive of this project. Chief Delaney explained that the review team did not make a recommendation on this application as it seems to present a policy decision for the Commission as to whether or not the applicant met the necessary threshold for a waiver. Commissioner Zuniga noted that this project is part of a larger effort to improve traffic, which compels him to support it. Commissioner Cameron expressed that she believed the waiver was warranted. Commissioner O'Brien agreed with Commissioner Cameron's statement. Chair Judd-Stein expressed her agreement with these statements. General Counsel Grossman advised that there was no need to explicitly approve the waiver request as it is tacitly approved with the approval of funding for the project.

Chief Delaney presented the Revere/Saugus joint request for funds to improve Route 1 North. Chief Delaney explained that they requested a waiver for the required June 2022 construction start deadline. The review team recommended awarding a grant of \$800,000 to Revere and Saugus for the Route 1 North improvements with the stipulation that none of these funds can be expended until MassDOT awards a construction contract for that project and further recommended granting a waiver from the June 2022 deadline and extending it until June 2023.

Chief Delaney summarized that the review team recommended approval of the Transportation Construction applications, namely applications from Everett, Revere and Saugus, Springfield, and Boston.

Commissioner O'Brien moved to approve the award of the following grants from the Community Mitigation Fund pertaining to transportation construction, namely a grant to Boston for \$239,000 for the Lost Village project, a grant of \$135,000 to Everett for the Northern Strand trail lights, a grant of \$800,000 to Revere and Saugus for Route 1 North improvements subject to both the conditions and the

waiver in the memo discussed today, and a grant of \$200,000 to Springfield for Dwight Street improvements. These grants are for the purposes described in the memos in the Commissioners packet and the submitted applications as discussed here today and on May 6, 2021, and further the Commission staff be authorized to execute grant instruments commemorating these awards in accordance with 205 CMR 153.04. Commissioner Cameron seconded the motion.

Chief Delaney moved on to the community planning grant applications. Chief Delaney presented Lynn's request for \$100,000 to develop a marketing campaign to promote Lynn business and to better compete with Encore's marketing capabilities. The review team recommended awarding a grant in the amount of \$100,000 to Lynn. Commissioner O'Brien pointed out that Lynn had provided information about specific incidents that point to a casino impact. Commissioner Zuniga noted that the Commission previously discussed reviewing the impact on live entertainment venues generally.

Chief Delaney presented Malden's request for \$50,000 for zoning improvement analysis of the Broadway corridor. He noted that the current zoning is not complementary to the nearby casino, so it is very plausible there's a lost opportunity cost to the city. The review team recommended awarding a grant for this project.

Chief Delaney presented Malden's request for \$100,000 to perform a feasibility study to redevelop the Malden District Court building into an art center that will be an anchor institution to help support local businesses. Chief Delaney explained that the review team was not convinced that the city made an argument for an appropriate nexus to the casino. Additionally, Chief Delaney noted that the city does not yet own the building that they intend to repurpose. The review team believed that the application was premature and did not recommend awarding a grant for this project. Commissioner Cameron expressed agreement that this application was premature. Commissioner Zuniga agreed that the fact that they did not own the building made the application premature. Commissioner O'Brien agreed that the application was premature given that they did not have access to the building.

Chief Delaney summarized that the review team recommended approval of the Community Planning applications, namely applications from Lynn, Malden (related to Broadway zoning), and Northampton; and that the review team did not

recommend approval of the Community Planning application for the Malden arts center.

Commissioner O'Brien moved to approve the award of the following grants from the Community Mitigation Fund pertaining to community planning: to the City of Lynn for \$100,000 for a marketing campaign, to Malden \$50,000 for the Broadway zoning improvement analysis, and to Northampton \$75,000 for the Northampton Live initiative. These grants are for the purposes described in the memos in the Commissioners packet and the submitted applications as discussed here today and on May 6, 2021, and further the Commission staff be authorized to execute grant instruments commemorating these awards in accordance with 205 CMR 153.04. Commissioner Cameron seconded the motion. Commissioner Zuniga seconded the motion.

b. Encore Boston Harbor Quarterly Report

Encore Boston Harbor (“EBH”) Senior Vice President and General Counsel Jacqui Krum and Executive Director Juliana Catanzariti presented their latest quarterly report. Commissioner Cameron asked if there were any identifiable reason for the slight drop in the lottery. Ms. Catanzariti responded that there was no identifiable reason. Commissioner O'Brien asked for the breakdown of minors under 18 as opposed to minors 18-20 on the gaming floor, and Ms. Catanzariti said that she could provide the breakdown. Commissioner O'Brien also asked if there are initiatives to recruit more women into certain types of roles. Ms. Krum responded that gender in various types of positions is balanced. Chair Judd-Stein asked if the compliance numbers with respect to minors were higher than last quarter, and Ms. Krum responded that they were a bit higher. Chair Judd-Stein

recommend that Encore look into possible causes for that increase. The Commission thanked Ms. Krum and Ms. Catanzariti for their presentation.

Problem Gambling Initiatives to Serve Asian American and Pacific Islander Communities

Massachusetts Department of Public Health
Massachusetts Gaming Commission



Background

The 2011 Massachusetts Expanded Gaming Act established the Public Health Trust Fund, which was created to mitigate gambling's negative health effects on communities in the Commonwealth. The Public Health Trust Fund is overseen by the Executive Office of Health and Human Services (EOHHS) and a strategic plan was adopted in 2016, which is implemented primarily by the Massachusetts Department of Public Health (MDPH) Office of Problem Gambling Services (OPGS) and the Massachusetts Gaming Commission (MGC). OPGS provides relevant public health programs and services and MGC conducts relevant research and responsible gaming activities.

Problem Gambling and Public Health

Problem gambling is a public health issue. Research demonstrates that some communities are disproportionately impacted by gambling, including individuals with mental health and substance use disorders and communities of color^{1,2,3}, such as Asian American and Pacific Islander (AAPI) communities. For example, recent research demonstrated that residents of Boston's Chinatown neighborhood at times depend on gambling as a source of recreation and relief from social isolation and concentrated poverty.⁴

OPGS and MGC: Working Together to Mitigate Harms

Together, the OPGS and MGC provide research, programs and services that provide a comprehensive public health approach to prevent and mitigate problem gambling in MA. Outlined below are initiatives particularly relevant for AAPI communities.

1 Research and Engagement

Community Engagement and Assessment (OPGS)

- **Everett Community Level Health Project:** Led by Boston Chinatown Neighborhood Center, this project develops a plan with community partners to address a gambling-related health inequity that builds off a Community Health Improvement Plan from the greater Everett communities.

Community-Engaged Research (MGC)

- **Talking about Casino Gambling: Community Voices from Boston Chinatown:** Examined the casino gambling practices of residents and workers in Boston Chinatown to learn about the trajectory and life context of individual participants' gambling activity. Report translated into Traditional and Simplified Chinese.
- **The Asian CARES (Center for Addressing Research, Education and Services):** Community-engaged research to address problem gambling among Asian ethnic communities through research, community education, and culturally relevant service provision.

2 Direct and Community-Based Services

Helpline Services (OPGS)

- **The Massachusetts Problem Gambling Helpline** provides support and referrals to those impacted by problem gambling. Offers translation services in over 100 languages, including Mandarin and Cantonese, and is increasing capacity to enhance culturally appropriate services for AAPI communities.

Programmatic Support and Evaluation (OPGS)

- **Outpatient problem gambling treatment providers** are available across the Commonwealth and the **Massachusetts Problem Gambling Treatment Technical Assistance Center** supports providers through training and technical assistance, including a focus on strengthening language and treatment services for AAPI communities.

2 Direct and Community-Based Services (continued)

Workforce and Training Supports (OPGS)

- **The Project Build Up** grant program to strengthen capacity of outpatient treatment agencies to provide gambling treatment services. Activities during FY21 focus on increasing clinical capacity for AAPI workforce by training AAPI clinicians to provide problem gambling treatment services.

Community-Based Services (OPGS)

- **AAPI Empowerment Initiative** works alongside AAPI communities in Greater Boston to provide problem gambling prevention education and awareness at the local level through material dissemination and community engagement.

Public Awareness (OPGS)

- **Translation:** A general problem gambling brochure was translated into simplified Chinese and traditional Chinese and is being disseminated widely by community organizations.
- **Communications Campaign:** A campaign focused on AAPI communities, currently in the planning stage, will be released in FY22.

3 Direct and Casino-Based Responsible Gambling Services

GameSense Program (MGC)

- **GameSense** is an innovative and comprehensive responsible gaming program that encourages players to adopt and/or maintain positive behaviors and attitudes that reduce risk of gambling related harm. Each casino offers an on-site GameSense Info Center. GameSense staff, known as Advisors, represent diverse cultural and ethnic groups and possess various linguistic backgrounds, including Cantonese, and Vietnamese. Brochures are available in Traditional Chinese, Simplified Chinese, and Vietnamese.
- **GameSense Community Education:** Designed to bring responsible gaming information and resources to the community, with a focus on communities at greater risk for experiencing gambling-related harm, including AAPI communities.
- **GameSenseMA.com:** Website dedicated to promoting responsible and problem gambling resources. Offers digital brochures on responsible and problem gambling which are available in Vietnamese, Simplified and Traditional Chinese.

Voluntary Self-Exclusion Program (MGC)

- **Voluntary Self-Exclusion** allows persons who struggle to control their gambling behavior the ability to voluntarily exclude from the gaming floor of all Massachusetts casinos. Brochures and required documents available in Traditional Chinese, Simplified Chinese, and Vietnamese.

Casino Employee Training Initiative (MGC)

- **Casino Employee Training** provides education and support on how to respond to casino guests who are in distress and may be struggling with their gambling behavior. In the Spring of 2021, all Encore Boston Harbor staff will receive training on responsible gaming, gambling risk factors and culturally appropriate support resources specific to the AAPI community.

Next Steps

Looking forward, OP GS and MGC will continue to enhance existing services and research and collaborate – all while engaging AAPI communities – in order to further advance the goal of supporting communities disproportionately impacted by gambling.





1st Half of 2021 Operating Spend



Timeline

June 9, 2016, PlayMyWay (PMW) was launched at PPC as a benefit to their player card members.

December 2017, the MGC voted to extend PMW to MGM Springfield and Encore through a cooperative agreement

October 2018, The MGC entered into an MOU to launch PMW by September 2020.

March 2020, MGM and Encore jointly requested to delay implementation. Under the revised agreement MGM will launch in September 2021 and Encore in September 2022.

Since 2019, MGM, Encore/Wynn Resorts, IGT, MCGH and the MGC have worked cooperatively to meet the technical requirements agreed upon and plan a successful launch

Background

What is Pre-Commitment?

"A decision taken in the present in order to limit options in the future"

- Promote PlayMyWay as an innovative and voluntary pre-commitment budgeting tool of GameSense
- Increase awareness of MGC and MGMS's commitment to responsible gaming via the GameSense brand and its programs
- Update PMW branding by incorporating Pos Play messaging in marketing and materials, including pre-planning, pre-commitment, personal responsibility, and honest/accurate beliefs.



Communication Strategy

- Introduce the PlayMyWay to M life Rewards players via highly-targeted branding and marketing initiatives
- Educate MGMS Casino employees about the availability and functionality of the play management system through a series of communication outreach methods
- Increase general awareness of PlayMyWay by developing and executing a strategic advertising campaign targeting visiting patrons, employees, and various stakeholders
- Highlight the availability of this budgeting tool and MGC's commitment to innovative responsible gaming strategies to the general public by launching a comprehensive traditional and social media campaign

PMW Evaluation Plan

Lead by Carleton University, funded by ICRG

Goal

- To build the evidence base for pre-commitment oriented play management systems by examining the uptake, selection of a mandatory (versus voluntary) limit adherence option, and behavior change.

Methods

- Recruit regular EGM players (N=600) to complete a survey prior to the introduction of PMW at MGM (**Phase I**), 3 months post-launch (**Phase II**), and 6 months post-launch (**Phase III**).
- Recruitment via the M-Life rewards program.
- Request permission to access the player account data.

On November 2, 2017 Governor Baker signed a statutory amendment which granted the Massachusetts Gaming Commission the authority to exempt certain "Gaming Service Employee" level job positions from the mandatory registration process. At the January 18, 2018 meeting, the Massachusetts Gaming Commission provided staff with a process for considering any potential exemptions. Additionally, the Commission endorsed the following factors for consideration when making exemption determinations:

¹ Access level "N" is described as: "No access to secure casino back-of-house without security escort."



- Work performed on the gaming floor
- Managerial responsibilities in any department
- Supervisory responsibilities in Human Resources, Sales and Marketing
- Responsibilities for alcohol sales, distribution, service, and/or storage
- Access to secure casino back-of-the house areas (including executive offices) without security escort
- Responsibilities for accounting and/or finance relating to the gaming establishment
- "Write" access to gaming-related casino databases
- Responsibilities that potentially impact the integrity of gaming operations, including access to confidential or sensitive information

MISSION STATEMENT

The mission of the Massachusetts Gaming Commission is to create and maintain a fair, transparent, and participatory process for implementing the expanded gaming law passed by the Legislature and signed by the Governor in November, 2011.

The Commission strives to ensure that its decision-making and regulatory systems engender the confidence of the public and participants, and that they provide the greatest possible economic development benefits and revenues to the people of the Commonwealth, reduce to the maximum extent possible the potentially negative or unintended consequences of expanded gaming, and allow an appropriate return on investment for gaming providers that assures the operation of casino-resorts of the highest quality.

The Massachusetts State Racing Commission (“SRC”) was a predecessor agency created by an act of the General Court in 1934. The State Racing Commission, pursuant to Chapter 4 of the Acts of 2009, was transferred to the Division of Professional Licensure (“DPL”), on January 1, 2010. Effective May 20, 2012, all State Racing Commission functions were further transferred to the Massachusetts Gaming Commission, pursuant to Section 89 of Chapter 194 of the Acts of 2011. DPL continued to manage all racing operations through an inter-agency service agreement through the end of calendar year 2012. The Division of Racing of the Massachusetts Gaming Commission assumed control of the fiscal and operational activities of the old State Racing Commission on January 1, 2013.

2020 MILESTONES

Due to the COVID-19 pandemic, in mid-March of 2020, the Massachusetts Gaming Commission voted to temporarily suspend operations at the casinos, racing, and simulcasting venues. Because of its on-line nature, account deposit wagering at Plainridge and Suffolk was not suspended, bringing in much needed revenue to the venues, purse accounts and the Division of Racing. The casinos, racing and simulcast venues were allowed to re-open as part of Phase 3 of the Massachusetts reopening plan of the Baker-Polito administration and state public health officials. Consistent with this, the Commission voted to allow casino and racing operations to re-open in July of 2020.

The Commission worked with the licensees and horsemen to form extensive COVID-19 protocols. This paved the way for live racing, originally slated to begin in April, to open on July 13, 2020. A few weeks later, Plainridge was able to successfully host the \$250,000 Spirit of Massachusetts Trot and the \$100,000 Clara Barton Pace, welcoming horsemen from many states. Later in the season, approximately \$720,000 was distributed as purses in the finals of the races for Massachusetts bred horses, the Sire Stakes. The Division of Racing thanks Plainridge, Suffolk, Raynham, the horsemen and women and other licensees for their cooperation during an unprecedented pandemic for their help in a safe, sustainable re-opening.

One of the Commission's foremost responsibilities is the issuance of occupational licenses to every person who participates in racing, and to associations who operate the Commonwealth's racetracks and simulcast facilities. Licensing Coordinators supervise the operation of the Commission's field offices located at Suffolk Downs, Raynham Park, and Plainridge Park Casino. They work closely with Judges, racing officials, track security, the State Police unit and the Gaming Commission to ensure that operations at each track are efficient and effective.

APPLICATIONS FOR LICENSURE

The licensing process requires that every person who participates in racing complete an application. The application is reviewed for completeness by licensing staff who then forward the application to the Massachusetts State Police Gaming Enforcement Unit, who conduct a background check of the applicant.

Once the background check is completed, the application is sent to the Board of Judges at each track. The Board reviews the application to determine if the applicant has the required integrity, ability, and the eligibility for the license for which the applicant has applied. The Commission also has access to the Association of Racing Commissioners' International (ARCI) files in Lexington, Kentucky and the United States Trotting Association's (USTA) database for violations. These files maintain a record of every racing related offense attributed to an applicant anywhere in the country. The Commission provides reciprocity to other jurisdictions and their licensing decisions.

If the Judges recommend licensing an applicant, the licensing staff collects the required fee and enters the appropriate information in the Commission's computer network. The applicant is issued a license card that entitles him to a photo identification badge. No person may enter any restricted area of a racetrack without a photo identification badge. Occupation's license includes jockeys, drivers, trainers, assistant trainers, owners of racing animals, blacksmiths, racing officials, vendors, stable employees and pari-mutuel clerks. License and Badge Fees. Occupational licenses expire annually on December 31.

In 2020, the Division of Racing issued 1,377 occupational licenses and badges to persons participating in horse racing and simulcasting in the State, collecting a total of \$45,605.

The Commission's goals of protecting racing participants and the wagering public as well as maintaining the public's confidence in para-mutual wagering are achieved through the Commission's licensing, revenue collection, and investigative activities.

The Gaming Commission applies to the Department of Public Safety for an assignment of a compliment of police officers. In the performance of their duties, the State Police Investigative Unit investigates violations of the rules of racing and the Massachusetts general laws. The Investigative Unit's extensive responsibilities and activities have resulted in a major improvement in the Commission's regulatory/policing functions.

INVESTIGATIONS | BACKGROUND CHECKS

The State Police Investigative Unit committed itself to maintain a constant presence at each racetrack, especially during live racing, working closely with the Judges and other Commission and racing officials to help ensure that each track operated with honesty and credibility. Investigations and inspections are conducted by officers assigned to the State Police Racing Unit and aid in preserving the integrity of racing.

The State Police Investigative Unit conducts stable inspections that focus on the detection of safety violations, the presence of unlicensed persons in restricted areas, and the possession of illegal medications, drugs, and contraband. The State Police Investigative Unit conducts investigations relating to hidden ownership of racehorses, larceny, conduct detrimental to racing, and other administrative inspections. The Unit also conducts background checks and fingerprint submissions pursuant to Massachusetts Racing Licenses. These include Gaming Commission Employees, Racing Officials, and all occupational licensees, who participate at Massachusetts Race Tracks.

State Police Racing members work in conjunction with Gaming Enforcement members stationed at Massachusetts casinos, and the Commission headquarters in Boston. Racing Members are often first to arrive on assistance calls ranging from, medical, arrests, ejections, and altercations.

In 2020, The State Police Investigative Unit performed 1,377 background checks for the Division of Racing.

VETERINARY SERVICES

VETERINARIANS

The Commission Veterinarians play an indispensable function in ensuring that the quality and integrity of racing within the Commonwealth remains strong by protecting the health and welfare of the equine athletes in Massachusetts.

EQUINE DRUG TESTING

A Commission Veterinarian supervises the testing areas in order to ensure proper collection and continuity of evidence for blood and urine samples collected from the racing animals.

Commission Veterinarians also testify at hearings and meetings on medication use, drug violations, animal care, new policies and procedures, etc.

LABORATORY SERVICES

INDUSTRIAL LABORATORY

In 2016, Massachusetts changed its testing laboratory to Industrial Laboratory in Colorado. Industrial Laboratory is ISO 17025 and Racing Medication Testing and Medication Consortium accredited. They perform testing for several racing jurisdictions. Testing protects the health of the animals and the integrity of races and contests.

Industrial is committed to improving their ability to detect new drugs of abuse. They work closely with the Association of Official Racing Chemists (AORC), Association of Racing Commissioners International, Inc. (ARCI) and Racing Medication Testing Consortium (RMTC). As a result, Industrial Laboratory is a driving force in the application of new technology for the drug testing industry.

In addition to testing urine and blood samples for the presence of drugs, Industrial analyzes syringes, vials, powders and a variety of materials seized as evidence. They also test for drugs in a variety of nutritional supplements.

INTEGRITY OF SAMPLES ENSURED

Special precautions are taken at all Massachusetts racetracks when post-race blood and urine samples are collected to ensure that no tampering can take place. In order to assure the continuity of evidence, every winning horse and all designated horses are under the surveillance of a Gaming Commission employee from the finish of the race until the specimens are obtained.

SAMPLES TAKEN AND ANALYZED

2020 marked the eighth year that the Massachusetts Gaming Commission's Division of Racing participated in the Controlled Therapeutic Medication Program.

There were 708 Paired Urine/Blood, 844 Blood Samples Analyzed, and 1584 TCO2 Blood Samples Analyzed.

At Plainridge Park Casino, there was 1 adverse finding for Altrenogest, 2 for Testosterone, 1 for 7-nor-7 Carboxycannabidiol, 1 TCO2 violation, 1 overage for Dexamethasone, and 1 overage for Phenylbutazone.

Items confiscated in the course of investigations are also submitted for analysis. These items may include feed preparations, vitamins, liniments, antibiotics, other pharmaceuticals and medical devices such as needles and syringes.

ENFORCEMENT OF RULES & REGULATIONS

Enforcement of the rules and regulations of racing begins with the investigation of complaints and prosecution of alleged violations by the Board of three Judges at the racetrack. One Judge is appointed by the racetrack and must be approved by the Gaming Commission and licensed as a racing official. Two Judges are appointed by the Gaming Commission.

The Judges are responsible for reviewing all occupational license applications and recommending or not recommending the applicant for a license. The Judges are present at the racetrack each day on which there is live racing and they oversee everything from drawing of post positions to making official the results of every race. In addition, the Judges preside over all hearings conducted at the track and report their rulings and findings to the Gaming Commission.

Before post time of the first race, the Judges review the daily program of races to approve any changes or report errors. Changes are reported to each department that might be affected by the change (i.e., mutuels, paddock judges, patrol judges, starters, clerk of the course, clerk of scales, program director, TV department and announcer). All changes are also reported promptly to the wagering public.

After observing every live race, both live and on television monitors, the Judges mark the order of finish as the horses cross the finish line. They give the first four unofficial finishers to the Mutuel Department, and when necessary, they post an inquiry, review an objection and request a photo finish. If there is an apparent violation of the rules, the Judges review the videotape and then make a decision before making the results of the race official.

If a violation of the rules occurs, the Judges notify all the parties involved in the violation. Sometimes only a warning will be issued but other times the offending horseman may be fined and/or suspended from participating in racing for a certain amount of time. If any party involved contests the decision of the Judges, then a hearing will be scheduled. After conducting the hearing, the Judges determine if any penalty such as a fine or suspension, purse redistribution, or other sanction should be imposed.

If any licensee disagrees with a decision of the Judges, they may appeal to the Gaming Commission, through its designated hearing officer. The Commission affords appellants adjudicatory hearings on the merits of their appeals. If appellants are dissatisfied with the decision of the Gaming Commission, they may appeal to the Superior Court of the Commonwealth in accordance with Chapter 30A of the General Laws.

ADMINISTRATIVE HEARINGS

The Plainridge Park Board of Judges issued 70 rulings in 2020 resulting in 69 fines and 3 suspensions.

APPEALS

In 2020, there was one appeal of Judges' Rulings. It was dropped.

COMMISSION BUSINESS

MEETINGS AND HEARINGS

As required by Chapter 128A of the Massachusetts General Laws, the Commission held a public hearing in the fall of 2020 for the one application for a 2021 harness racing meeting. The Commission approved the application of Springfield Gaming and Redevelopment, to conduct harness horse racing in 2021 at Plainridge Park Casino.

DECISIONS APPEALED TO THE DIVISION OF RACING

The Gaming Commission, sitting as a quasi-judicial body pursuant to the Massachusetts Administrative Procedures Act, adjudicated 1 appeal, which was denied. The Commission has taken extensive precautions to ensure licensees due process throughout the appeal process. The Commission has a Stay-of-Suspension process. These permit licensees suspended by the Judges for a minor violation of the rules that does not compromise the integrity of racing to continue to participate in racing until the licensee has been provided a hearing by the Commission and a decision made. Procedural safeguards were adopted to prevent licensees from abusing the Stay privilege. Hearings are conducted as soon as practicable from the time of the granting of a Stay, thereby preventing a licensee from participating while on a Stay status for an extended period of time.

DUE PROCESS AFFORDED ALL LICENSEES

Licensees charged with a violation of the rules that may result in the loss of a license are entitled to a hearing pursuant to the Administrative Procedures Act (APA). Formal disciplinary hearings held by the Racing Division follow the requirements established in the Massachusetts APA. These requirements include issuing timely notice of hearings, providing the opportunity for an appellant to confront witnesses and to be represented by counsel.

COMMISSION DECISIONS APPEALED TO SUPERIOR COURT

In addition to hearing appeals, the Racing Division must prepare a complete record and legal decision for each case that is appealed to the Superior Court. When the record is completed and certified, it is forwarded to the Government Bureau of the Office of the Massachusetts Attorney General and is assigned to an Assistant Attorney General who defends the case in court. The Commission and the Attorney General work closely together to present the best possible case in Superior Court.

The Division of Racing takes this opportunity to thank the Office of the Massachusetts Attorney General for the diligent, professional and expert defense of Commission cases.

PARI-MUTUEL AUDITING AND COMPLIANCE

Responsibilities of the Commission’s auditors include assessing liabilities owed to the Commission and overseeing the calculation of take-out from handle. The handle is the total amount of money wagered at each performance and the take-out percentage of handle is determined by statute.

All money wagered on a horse race goes through the equipment of one of the two Totalisator companies; namely, AmTote and Sportech. These are private companies who sell their services to racetracks. Both Suffolk Downs and Raynham Park use the services of AmTote whereas Plainridge uses Sportech. These companies provide the machines for wagering, those used by the tellers and the self-service terminals. The “tote” system accepts wagers and based on those wagers, it calculates the odds on each betting interest, displays them, produces and configures the payouts following the race and later cashes the tickets given to the bettor. This is all accomplished through very sophisticated computerized equipment that has the ability to combine all wagers placed, no matter where they are coming from, including those placed via computer, live at the track where the race is being conducted and at all guest sites that have contracted to wager with the host track. All these wagers go into a common pool. The term “host” is the track where the race is being run and the term “guest” means any other location where wagers are made on a live race.

Before the start of a race card, all tote companies at the sites that will take wagers on the live product, connect with the tote at the host site. At the start of each individual race, the Steward/Judge at the Host track presses a key/button that locks all the wagering machines. This stops any betting after the start of any race. At the conclusion of a race, the Stewards/Judges determine the order of finish and notify their mutuel department who is linked to the Tote system that the race is going “official” and the numbers of the first 4 finishers are posted along with the payouts for all the different wagers; i.e., win, place, show, daily double, exacta, trifecta, superfecta, or any wager that is offered on the race by the Host track. Printouts from the tote system are audited by the Racing Commission Auditors for accuracy and compliance with current statutes.

A summary sheet, detailing the breakdown of the statutory take-out is prepared by Commission Auditors for each individual racing performance. For live racing, the information is provided by the on-site tote system. For imported simulcast races, a report from the host track is faxed to the guest track. This report is used in conjunction with on-track reports to complete the summary sheet. This activity ensures that the public, the Commonwealth, purse accounts, and all designated trust funds are properly funded. The Commission Auditors prepare a handle reconciliation report on a daily, weekly and monthly basis. This report shows the handle broken down as to live, signal exported and signal imported. Further, the balance of all current unclaimed winning tickets and the liquidity of the mutuel department are audited by the Commission Auditors.

MASSACHUSETTS GENERAL LAWS CHAPTER 23K SECTION 60.

The Race Horse Development Fund shall consist of monies deposited under subsection (c) of section 55. The Commission shall make distributions from the Fund to each licensee under chapter 128A. Funds received shall be distributed between Thoroughbred and Standardbred accounts, as approved by the Commission. 2020 is the sixth calendar year that monies have been distributed from the Race Horse Development Fund accounts.

MASSACHUSETTS GENERAL LAWS CHAPTERS 128A and 128C

In addition to licensing racetracks and participants, the Racing Division of the MGC has a primary responsibility to collect revenue in accordance with Chapters 128A and 128C of the General Laws. Each licensed racetrack pays a commission as determined by law in addition to license fees and other assessments. Racing Division Inspectors collect occupational license fees, badge fees and fines. The Racing Division collected \$2,652,070 from Massachusetts racetracks in 2020. All Commission activities are revenue driven as Commission expenditures come from Commission revenue and are made in a priority order in accordance with Section 5(h) of Chapter 128A.

RACING TERMINOLOGY

OUTS

Outs are the unclaimed winning wagers at each horse track. If the tickets haven't been presented for payment by 90 days after 31 December of the year following the year of the actual wager, they will be distributed to the commission. Subject to the rules and regulations established by the Commission, the Commission shall deposit the unclaimed live wagers into the purse accounts of the racing meeting licensees (Suffolk and Plainridge) that generated those unclaimed live wagers. When the outs come from Wonderland and Raynham, they go to the Racing Stabilization Fund.

BREAKAGE

Breakage – the difference in the rounding off of the pari-mutuel payoffs. The difference in cents between the winning payouts and the nearest dime or nickel is called the Breakage. These breaks shall be paid to the commission on the day following each day of a racing meeting. The commission then dispenses the breaks as follows: The breaks from Suffolk and Plainridge go to their respective Capital Improvement Funds whereas the breaks from Wonderland and Raynham go to the Racing Stabilization Fund.

PURSES

Purses are the monies that the horses earn for racing. Each race has a purse amount assigned to it before the race is run. How much each horse earns of that purse depends on where the horse finishes and the amount of the purse. The actual money wagered on the race does not have an immediate impact on the amount of the purse. However, a percentage of every dollar wagered makes its way into the purse account for races at a later date. The average daily purse is the amount of the total purses awarded during a race meet divided by the number of days of racing for that meet.

SIMULCASTING

Simulcasting is when a racetrack sends a closed-circuit transmission via satellite of its live racing to another location, either in the same state or out of state and sometimes out of the country. The track where the racing is being contested is called the Host and the location where it is viewed is called the Guest. People at the guest site bet on these races in real time. The Guest site customers receive the same payoffs as the customers at the Host track. All the money wagered by both the Host and Guest sites are merged and the odds are computed on the total amount of money wagered into these combined wagering pools. To view their races, the Host charges the Guest a certain percentage of the guest site's handle. This percentage is based on the quality of the racing and by agreement between the Host and Guest.

HANDLE

Handle is the total amount of money wagered at a specific location, by individual race/ day/month or by year.

Notation

The following terminology is used in reporting simulcast events:

“Signal Received” is categorized as “Imported” as this signal is sent from a remote track being received locally.

“Signal Sent” is categorized as “Exported,” as this is the local signal being sent to a remote track.
