Call to Order

10:00 a.m. Chair Judd-Stein called to order the 60<sup>th</sup> Agenda Setting meeting.

#### **Approval of Minutes**

Commissioner Stebbins moved to approve the minutes from the Agenda Setting Meeting of August 7, 2019, subject to correction for typographical errors and other nonmaterial matters. Commissioner Zuniga seconded the motion. The motion passed unanimously.

#### Agenda Planning for Upcoming Commission Meetings

(Scheduled Commission Meeting on September 9, 2019, at 10:00 a.m.)

<u>Item #1 – Administrative Update.</u> Ed Bedrosian will have an administrative update.

<u>Item #2 – Regulations.</u> There will be one draft regulation up for approval to begin the promulgation process. Ms. Wells asked the Commission for feedback regarding the junket regulation that was drafted by counsel for an initial vote. There will be a discussion with a potential vote.

<u>Item #3 – Region C – Motion for Reconsideration.</u> Ms. Blue will have materials to the Commission regarding what the legal division will put in the Commissioner's packet. Attorneys from both the Commission and Mass Gaming & Entertainment (MG&E) will make presentations, with a discussion at the end, with a potential vote.

<u>Item #4 – Encore Boston Harbor Update on Suitability Decision Condition – Executive</u> <u>Coach.</u> This item will be combined with agenda item #6.

<u>Item #5 – Licensee Policies on Switching Jackpots.</u> Commissioner Stebbins and Bruce Band will have this update ready.

<u>Item #6 – Encore Boston Harbor Quarterly Report</u> This item will be combined with item #3. Mr. Ziemba stated that there will be a separate item to reflect the completion of the 90day construction commitments deadline. This will be the construction final quarterly report and transportation plans. Mr. Delaney will provide the construction update entitled, "90-day Commitment Update" that will require a vote in case an extension of days is needed.

<u>Item #7 – Plainridge Park Casino License Renewal</u>. Commissioner Zuniga stated that Mr. Grossman will give a presentation that will lead to a discussion regarding jurisdictions.

<u>Item #8 – Gambling Behavior, Risk Factors for Problem Gambling and Public Health</u> <u>Recommendations: A Pilot Study in Boston's Chinatown.</u> Mr. Vander Linden anticipates this item to be ready for October 10.

<u>Item #9 – MA Gaming Impact Cohort Study Wave 3</u>. Mr. Vander Linden will have this presentation ready.

(Anticipated Commission Meeting on September 26, 2019, at the Mass Mutual Center in Springfield)

<u>Item #10 – MGM Springfield Quarterly Report.</u> Mr. Ziemba will have this report ready. There will also be an enhanced discussion of 31 Elm street to determine if there is further need for Commission action regarding the residential requirement. Will discuss a potential vote on this issue.

<u>Item #11 – Springfield Real Estate Research Report.</u> Mr. Vander Linden will have this report ready. There will be a speaker on this report.

<u>Item #12 – Racing Update.</u> Dr. Lightbown will have this update ready. Chad Borque will be away so this will be moved to the following meeting. She noted that racing applications will be ready to present at the first meeting in October, and suggested moving everything to that meeting, as Mr. Borque will be back then.

<u>Item #13 – Racing 2018 Annual Report.</u> See above Item #12.

<u>Item #14 – FY21 Community Mitigation Fund Application Guideline Review.</u> Mr. Ziemba will have this presentation ready for the Commission.

<u>Item #15 – Construction Diversity Best Practices Report.</u> Ms. Griffin will have this item ready.
