Please offer a brief description of the entity's business, including the type of business it will likely seek to conduct in the Commonwealth of Massachusetts.

Crown MA Gaming LLC (DraftKings) is not presently operating any sports wagering business. Upon approval of licensing by the Massachusetts Gaming Commission, the entity intends to conduct mobile sports wagering business in the Commonwealth of Massachusetts to all eligible patrons in accordance with Massachusetts law. The main goods and services to be offered is the DraftKings platform, which consists of different components, including the Player Account Management System, Trading Platform and Front-end user experience.

The Player Account Management System is the user wallet, the user location, identity, KYC and responsible gaming systems, the trading platform is our wager processing and risk management systems, and the front-end user experience is the DraftKings Sportsbook mobile wagering apps, the DraftKings Sportsbook website.
