Interim Chairwoman Cameron asked for a motion to enter into executive session pursuant to M.G.L. c.30A §21(a) (3) for the purpose of discussing litigation strategy in the case of Stephen A. Wynn vs. Karen Wells, the Massachusetts Gaming Commission, and Wynn Resorts, when a discussion in an open session would have a detrimental effect on the litigation position for the Commission. Interim Chairwoman Cameron stated that the Commission would reconvene in public session after the executive session. The Commission entered into executive session.

In addition to the Commissioners, Attorneys Melissa Allison and David Mackey from Anderson & Kreiger, Executive Director Ed Bedrosian, General Counsel Catherine Blue and Deputy General Counsel Todd Grossman were present.

Attorney Mackey described for the Commission what had taken place since the last executive session. Over the last 3 weeks, Mr. Mackey and Attorney Allison were speaking with the parties to the litigation in an effort to see if the parties could come to an agreement on whether certain information listed as privileged in the Judge Gonzalez' minute order could in fact be used by the Commission in its report and if the parties could agree to a resolution that resulted in a dismissal of the case against all parties. Mr. Mackey and Ms. Allison indicated that all parties were open to such a discussion.

Since Mr. Mackey and Ms. Allison are SAAGs (Special Assistant Attorney Generals) and represent the Commission in the same manner as the Attorney General's office would, they were reporting as required on the litigation to the Attorney General's office. They had several calls with the AG's office regarding the attempts by the parties to resolve the litigation through a stipulated order signed by the parties. The Attorney General raised On January 30 Mr. Mackey, Ms. Allison and Catherine Blue met with members of the Attorney General's staff. The Attorney General's staff expressed concern Mr. Mackey and Ms. Allison agreed to provide a copy of the draft order The stipulated order would take the place of the preliminary injunction order. On the day following the meeting with the Attorney General's staff, the Attorney General's staff reached out to Mr. Mackey and Ms. Allison The Attorney General's staff advised that it needed to further consider the issue and would promptly advise the Commission on the matter.

The briefing did not request any action on the part of the Commission; rather it was an update on the status of the litigation. The Commission will not be voting on any matter today. Commissioner Cameron further stated that the Commission expects the Nevada Court to issue an order shortly and that the Commission will review the order carefully.
