fuboTV (NYSE: FUBO), the parent company of Fubo Gaming Inc., is the world's only sportsfocused live TV streaming service with top leagues and teams, plus popular shows, movies and news for the entire household, including more than 30,000 live sporting events per year and 60,000 TV episodes and movies every month. After initially launching as a streaming soccer service in January 2015, fuboTV has quickly evolved into the top independent virtual MVPD in the U.S. and became the first U.S. virtual MVPD to enter Europe. fuboTV is growing exponentially and recently reported sequential revenue and subscriber growth for the first time in any first quarter, despite past seasonality trends. fuboTV, allows customers to access content through connected TV devices and on SmartTVs, Roku, Apple TV, Amazon Fire TV, Chromecast, mobile phones, tablets, and computers.

fuboTV's platform allows customers to access content through streaming devices and on SmartTVs, mobile phones, tablets, and computers.
