Hi,

I watched the meeting tonight.

Wow, you did a really poor job of making regular Everett residents aware of this meeting. You didn't hear from the real Everett except for three or four people. We have serious concerns about traffic, money, and further strain on our public services (police and fire) but you didn't get to hear much about that because Encore was real slick about packing the room. If you have been commissioners for any length of time, you know about that kind of thing and probably aren't swayed by it.

I'm not clear about how much the MGC can do to prevent further harm to the existing residents and businesses of Everett and the surrounding area, but urge you to pay attention. Councilor Lattanzi was dead flat wrong when he told you that this expansion is what people envisioned when the casino was proposed. No, the casino was what people voted for, not a whole "entertainment district." We DO need a referendum, as well as additional money if you allow the expansion. We were told that allowing the casino in was going to be a boon of jobs and revenue. All we've gotten is more traffic, more police and fire calls, and higher tax bills. You heard the Encore presentation. Only 14% of their employees are Everett residents and if the sample of them tonight is representative, we only get cleaning or gardening jobs. Big whoop. Can any of our high school students in the culinary arts program even hope to get a job at Encore when they graduate? I doubt it.

Yes, it would be a good thing to get the polluted areas cleaned up, but not at the expense of the rest of the city. Just look at a map. There's a whole lot of Everett that's not even remotely near the temple to gaming.

Encore hasn't succeeded in ruining Everett, but if the MGC allows it to expand gambling without paying its fair share, it will. (I am aware that there are meals and room taxes paid.) Long-time residents are being forced out because of tax increases. Neighborhoods are breaking down. Police and fire are overstretched, schools are overcrowded, traffic is unbearable already, and instead of getting the kind of revenue Everett residents were led to believe would be incoming, we got a paltry \$30MM for FY2023 from the community agreements. That didn't even cover our public safety budget! Yes, of course that is partly due to poor management on the part of the mayor who negotiated the host community agreement but that doesn't change two things: 1) Encore is trying to include the expansion in the original agreement and continue paying Everett next to nothing; and 2) our PILOT payments go up by 2.5% per year. 2.5%. Encore had revenues of \$62MM in one month (October, 2022) and it wants to build sports betting and a theater for the same low, low price?

And the "Everett residents" you heard from that were all rah-rah expansion are false coins. They're developers who, along with Encore, are doing their best to make Everett unlivable, just another sad place for moneyed transients instead of the vital, hard-working, vibrantly-diverse community that we are now. I was just saying yesterday how it cracks me up to hear the Vietnamese store owner at my corner store speaking Spanish, which he's picked up because he has so many Spanish-speaking customers. That is who we are now. Sure, we want to be spruced up a little, but we don't want the whole character of our city changed, like V-10 (Belliveau) and the others want. Just look at The 600 on Broadway. Totally wrong site for that building; wrecked the Fairlawn Street neighborhood.

I hope it falls within your purview to prevent Encore from doing us further harm. Personally, I don't get any benefit from it. Is it really nice behind the casino? I don't know. What am I supposed to do, take a bus down there to go walk around? Does that make any sense to you? Oh, and the expansion will gobble up greenspace; I have the documentation on that. They didn't tell you that part, now did they (Councilor Costa did)? I tried to use the shuttle. It didn't come. But I did see it at Market Basket, so I have stopped calling it the "Unicorn Shuttle."

If Encore wants to partner with Everett instead of just being a glitzy attraction for outsiders, it should give some real consideration to building a police substation and a fire substation and funding them for a while. It should make a donation to make or improve greenspace in other parts of Everett, not just where the hotel guests can take a nice stroll by the river. It should consider setting up a pipeline with the high school, maybe scholarships, for students to go on to study management, accounting and other white-collar jobs; it kind of feels like it considers us a good source of low-skill workers. Ick.

I hope you will do whatever is allowed within the parameters of your commission to ensure that Encore will be a contributor to Everett and surrounding communities, not the boondoggle it is now.

Greetings Commissioners,

My name is Samantha Lambert, resident at 20 Peirce Ave in Everett, MA. I found out about the public hearing held at Everett City Hall yesterday afternoon and was able to go to the chamber, however I had a work commitment at 7 PM and due to the meeting beginning late, was unable to stay to make my comments as intended.

Thank you for hosting the meeting in Everett. It is important and commendable. I am disappointed in the lack of communication from the City of Everett and Encore Boston Harbor (EBH) regarding the meeting. I actually learned about the hearing from a student at Everett High School who had heard about it in a meeting with a City Council member regarding a different topic. The student asked me and we looked together to find the information, but there was nothing on the city calendar, website, or social media channels that are typically used for resident communication. It was only when we went to the Mass Gaming Commission website that we were able to find the details.

I will reiterate my comments submitted to this body in February. Expansion of gaming to the East of Broadway development is a decision that belongs to the voters. It is we, as residents, that truly know the full cost of the Encore Boston Harbor casino. We, as residents, understand the impacts to our city. We have no financial investment, our investment is to our families and our neighbors.

It is often stated that Encore makes for a beautiful "front door" to our city, but too often, we see it as a "no exit" sign. It has literally become the other side of the tracks, a place where we are only welcome for employment and though employment is a benefit, I heard my union brothers and sisters last night when they expressed their concerns, and I stand with them. Too often, Everett has been exploited in the name of jobs. This has happened with manufacturers that were poisoning our air and water, yet the allure of good jobs and ability to provide for our families was too strong and the return on investment for those in power was too great. I see this expansion in a similar vein.

Community based organizations have been actively working to engage with Encore Boston Harbor and pushing their legislative representatives to have good faith conversation and implement a Community Advisory Board that would help build the relationship between the community and Encore Boston Harbor. As a resident, I strongly advocated for this and saw this as a mutually beneficial opportunity for both our community and EBH. Expansion of gaming to the East of Broadway site creates one more inaccessible space, increased traffic in a city already plagued with poor air quality and high asthma rates (https://mass-

eoeea.maps.arcgis.com/apps/webappviewer/index.html?id=1d6f63e7762a48e5930de84ed4849212), reduced opportunities for jobs for our young people under 21, a strain on our public safety, and a disappointed community who thought they were welcoming a partner that would lift our city, not facilitate the displacement of its residents.

I have heard from many of our young people, those that chose the hospitality pathway at Everett High School, who felt they were making a smart and strategic decision that would allow them and their families to be supported by quality jobs upon graduation from high school. The reality is, these jobs have an age requirement of being 21 years of age. There is no pipeline for our young people. If the East of Broadway expansion is entertainment only, it would serve to be the opportunity they were promised and would support the retention of those that have, and would like to continue to, call Everett home.

The largest benefit of the original agreement with Encore Boston Harbor was the land swap that gave us Rivergreen, previously inaccessible and polluted waterfront. The underutilized parking lot for Encore Boston Harbor is also adjacent to this space, with walking trails, playgrounds, and playing fields. Encore Boston Harbor recently dedicated a large area of that parking lot very near to the river and playground to a construction staging area with piles of asphalt and large trucking now part of the environment. This is yet one example of a disregard for the people who allowed this company to call Everett their home. This is a company that has a significant budget and makes a tremendous profit, that would allow for ample, effective marketing to the community and the ability to bring our community together to hear how they can be a better partner, but instead they disregard and dismiss the people of Everett. The bare minimum necessary to check the box on regulatory applications is done. We want and demand more.

This brings me to my final comment. This is our home. I have been an Everett resident and renter for over 30 years. It is my home. My only investment is in our community. It pains me to hear the promises and sales tactics that for-profit developers, those that have the time and resources to dedicate to marketing, advocacy, and lobbying, continually claim while seeing the pain in my own community, the hours dedicated to commuting instead of with their family, the housing and health burdens, the feeling that our city has been put up for sale. Encore Boston Harbor should open the host agreement, create a community advisory board with members nominated from both the city and from community based organizations, keep gaming on the original site, and make a good faith effort on being a good partner and neighbor to those that make Everett their home. The decision to expand gaming should be left to the voters of Everett.

Hi, it has become increasingly clear to me that EBH wants you to think that the pivotal point in the discussions about Encore expanding to east of Broadway is whether or not the voters contemplated it when the referendum was held in 2013. I believe they're trying to mislead you. Whether or not the voters knew about something a lawyer had to go back to 1921 dig up is not the important issue.

The issue is what the voters thought the agreement was. It was promoted to them as the casino being a benefit to the city. It has not been. So, another referendum is necessary.

Even if the infamous John Tocco* (related to Richard Belliveau) did not explicitly say as much, he implied that the casino would bring enough money to the city that the residents could feel as if the city had a stable commercial base, that their taxes need not go up. It was touted as being a place that would provide jobs to people already living here. It has done neither.

Irrespective of the fact that a good part of the reason EBH doesn't contribute more to Everett's economy is because the mayor made a bad deal, the fact remains that EBH does not pay much in return for what it gets. Of its 2022 GGR of \$729,724,772, it paid Everett in FY2022 a mere \$600,000 (approx.) in meals taxes, approximately \$600,000 in rooms taxes, a pathetic \$21,012,500 in lieu of taxes, and \$5,253,125 as a host-community payment. That totals about \$27.5MM.

Everett had to increase property taxes, from 10.36 to 11.78. Residents THOUGHT, when they voted for the casino in 2013, that they wouldn't be facing tax increases of \$800/year on average. Imagine a Senior on a fixed income having to come up with another \$800 for their taxes. I know one. She's not sure where she's going to find the money. She's a second-generation Everett resident who says her children can't afford to live here. That is not what SHE thought she was voting for in 2013. I will try to get her to email you herself.

You heard from EBH on 4/25/23 that 14% of its workforce is Everett residents. If EBH is such a great contributor to Everett, why don't more Everett residents choose to work locally? I sincerely doubt that all of the professionals who live in Everett are ethically opposed to working for a gambling establishment. Maybe EBH wouldn't hire them. Maybe EBH sees Everett as a source only of cleaners and gardeners. Opening more establishments across the street from the casino is not going to change that.

You have heard from many residents about the horrific traffic increases since 2019. Traffic is not backing up to I93 in the afternoon because of so many people wanting to cross Broadway at 1 Broadway, so a pedestrian bridge is not going to be a significant contributor to traffic mitigation. I think the expansion would only add to our traffic woes. It would be nice if our mayor cared about things like that, but he doesn't.

So again, the issue is not whether the residents foresaw Encore expanding onto property owned by the Monsanto predecessor, Merrimac Chemical Company. It is whether or not they voted to allow the casino because they thought it would benefit the city. They thought so. They were wrong.

Greetings, Mayor DeMaria's self proclaimed "Campaign Financier" Jamie Russo was the Broker on the Casino Land Deal according to the Press.

In 2009, Everett City Officials threatened the Ethiopian and Brazilian Residents of the property with arrest before making them homeless.

In 2010, Greg Antonelli's predictions came true and he brought the house.

In 2010, the City of Everett Defaulted in District Court. In 2012, the City of Everett Defaulted in Superior Court.

The City of Everett had made the Residents homeless and hired Gennaro Angiulo's Action Emergency Services to board the property as the Victims were piling their belongings on the sidewalk.

Gennaro Angiulo charged the property owner over \$10,000 which the Owner disputed. At a Jury Trial, Gennaro's Attorney Earl Miller walked away from the \$10,000 even though he had threatened to bury the Defendant in Legal Fees.

Good Morning,

I am writing to voice my objection to the gambling and expansion to lower boardway!

In the original referendum question, "Monsanto plant" was specifically noted. The argument by Wynn lawyer that a map back in 1921 shows a company that was part of Monsanto on the other side of Broadway - who knew?

I along with 87% voted to approve the casino on the Monsanto site because we were promised cleanup of the site, jobs, tax relief, road improvement and the reinstatement of the MBTA stop in Everett! What we got was traffic! Drugs! and Greedy Developers!

Good afternoon Commissioners,

Thank you to the Chair and Commissioners for allowing the residents of Everett, like myself, to voice their concerns and support.

Other public officials, including Everett's Ward 6 City Councilor, were asked if there should be a referendum vote for the expansion of the Encore Casino for the proposed East of Broadway Project. I support the idea that Wynn LLC would continue to expand its footprint in Everett's "Entertainment District". Wynn has been a partner in cleaning toxic land, but there is more to be done. Everett came up short in the first negotiation of the Host Agreement. I would vote No until Everett had an agreement that represents the best interest of the residents of Everett. There have been minimal conversations between the Everett's City Council and Wynn LLC. During a aAaCIty Council meeting Wynn LLC acknowledged and committed to a negotiation, in good faith, that represents current economic conditions and beyond.

Wynn LLC requires affordable housing solutions, not just an impact fee. Everett needs a commitment to deliver a strategy for solving Everett's affordable housing crisis. The City of Everett alone does not have the capacity to manage the necessary programs that will drive solutions. Don't just promise the City of Everett funding, guarantee a solution.

Our schools and students would benefit greatly from a more formal partnership that requires compliance, annual reporting and obligations, beyond what's offered today. Additional community involvement to deliver broader career development opportunities for students, Wynn LLC programming on site at schools, and promote student led civic enhancements.

I do not support the three above ground parking garages. It is well documented, Everett's issues with the urban heat island effect and lack of, which continues to be worsened by large developments in process. Everett needs underground parking. Additions such as community solar on their extensive rooftop space would serve to reduce the impacts of energy burden on our environmental justice community.

The plans include minimal open air space and public accessibility to community space. An average Everett resident may never benefit from the Wynn LLC facilities, but Everett demands public benefit. As a densely populated gateway city, Everett is in need of more public space and greenery to offset the urban heat island effect.

There needs to be open and inviting outdoor access to the overhead walking path over Broadway. The current renderings appear closed off, requiring a resident to enter the building to cross Broadway. This public walkway should be well announced and welcoming to our residents. An example may be the TD Banknorth Garden's integrated entrance with the MBTA.

Everett demands more effective community engagement. The relationship would benefit greatly from sponsoring City events and participating at events that draw residents, such as the 4th of July, Easter, Halloween etc. For example, I attended the Encore East of Broadway open house on April 11th. It was a wonderful event that took place at the Encore Casino; however, it was poorly attended. Meanwhile, Everett's Rec Center draws hundreds of residents and students daily.

Everett needs a Wynn LLC shuttle expansion. Our residents require more routes and more frequent services to connect commuters to local rail stops where the MBTA falls short.

The Wynn LLC water taxi to Long Wharf should expand its service to weekdays and better promote its usage as a commuting option into Boston for Everett residents.

As you establish your extended footprint, please advocate for Infrastructure improvements. For example, Everett has a deteriorating overpass in Sweetser circle. We also lack any vision for building MBTA tracks in our City, while the orange line runs right behind the Encore Casino.

Everett and Wynn LLC need to renegotiate the original Host Agreement, given the material increase in the Encore Casino's gaming footprint and operations, including sports gaming. Per the Host Agreement, section 1B items 1 & 2, requires the need for an open negotiation of the Host Community agreement between the City of Everett and Wynn LLC in its aggregate, not in pieces.

For the public, the Encore property was sold for \$1.7B, which would generate \$42M in property taxes. It's currently assessed at \$1.3B, which would generate \$32M of property taxes. In reality Encore paid approximately \$22M as a payment in lieu of taxes (PILOT) and a community impact fee of approximately \$5M, which covers public safety, other municipal services and offset negative impacts to a community due to gambling and drinking. Wynn LLC is a member of our community and I will be encouraged when I hear more details in regards to our ongoing negotiations as promised in the original Host Agreement.

Please include me when you follow up with members of the public that expressed concerns, including Local 26 and other union members who spoke. I support fair wages and working conditions in Everett with a preference for hiring Everett residents.

Thank you for the opportunity to comment in writing as part of the Gaming Commission's review of the first phase of the proposed development East of Broadway in Everett by Wynn Resorts and its subsidiaries.

As I stated at the Gaming Commission's public hearing at Everett City Hall on April 25, 2023, I believe the development's first phase should be considered part of Wynn's Encore Boston Harbor (EBH) Gaming Establishment and thus fall under the Commission's jurisdiction. This seems logical, since the development will have an 18,700-square-foot gaming area, as well as be connected to the existing casino site by a pedestrian bridge that will link the new game facility as well as its 3,092-space parking garage, which is intended to serve visitors to both sites.

As I also stated at the public hearing, I think it is important that the Gaming Commission ensure that the anticipated impacts of the new development are addressed and mitigated by the developer through the creation of new or amended agreements with the communities and stakeholders most affected.

As required by the 2011 Massachusetts Gaming Act legislation, the casino license holder was required to enter into agreements with the host and surrounding communities, as well as officially designated Impacted Live Entertainment Venues (ILEVs).

These agreements are now nine years old, and were specific to the features of the original Encore Boston Harbor facility. The proposed new development would add a vast amount of gambling, entertainment, and food and beverage infrastructure, as well as the large parking garage — all of which should be factored into what their impacts will be on the affected communities and stakeholders, and address in new agreements with those parties. Chief among them are transportation infrastructure and public safety impacts by the anticipated volume of additional visitors to the complex 365 days a year.

In addition, unlike the current EBH complex, the new site also will have a 977-seat live entertainment venue that will host a full schedule of events booked by an independent event management company. Bolstered by revenue from casino operations, this facility will have the advantage of operating under a much different business model than independent live entertainment venues, and municipally owned venues such as Medford's Chevalier Theatre. Just as the 2014 community and ILEV agreements attempted to address the impacts of the original Encore Boston Harbor facility, new agreements should be established governing the new development.

Encore Boston Harbor's adherence to the 2014 community and ILEV agreements has been spotty as best. The new development provides an opportunity to evaluate the effectiveness of those agreements, and where and how they can be improved.

Lastly, there are new crucial transportation improvement projects with which Encore Boston Harbor should be closely engaged — MassDOT's Wellington Circle Study in Medford (https://www.mass.gov/wellington-circle-study) and the Department of Conservation and Recreation's study of a new pedestrian and bicycle bridge over the Mystic River connecting Everett, Somerville, and Charlestown (https://www.mass.gov/wellington-circle-study).

While Wynn/Encore contributed to small-scale improvements at Wellington Circle as part of its 2014 Surrounding Community Agreement with the City of Medford, it has not been represented at any of the first five Wellington Circle Study working group meetings, which began in September 2020. And the Mystic River Bridge, which would be an asset to the casino and to the regional transportation system, has languished since the state officially approved the project in October 2021.

I encourage the Gaming Commission to do what it can within its authority to make new community and stakeholder agreements a requirement of its approval of phase 1 of the East of Broadway development.
