#### - Plainridge -

Two letters from Mr. Steve O'Toole dated June 14, 2012 requesting permission to send and receive LIVE racing signals from listed outlets in 2012, pending receipt of executed contracts and appropriate horsemen's approval.

# - Suffolk Downs –

A letter sent by Mr. Sam Elliott dated June 6, 2012, advising of the change to post time at Suffolk Downs on Belmont Stakes Day, Saturday June 9, 2012 from 1:15PM to be 1:45PM. (ACKNOWLEDGEMENT).
