GLOSSARY

CURRENT & FUTURE WAGERS SETTLED

Total amount wagered on approved sporting events that occurred in the month of the report; also known as the handle. MGL C. 23N requires taxes to be based on the accrual basis of accounting, which means revenue cannot be realized until after the event the wager is placed on is completed.

REVENUE HOLD %

Accrual Win by Licensee divided by Current and Future Wagers Settled; that figure is then multiplied by 100 in order to be represented as a percentage.

TABLE GROSS GAMING REVENUE

The revenue generated by table games supported by live dealers in Massachusetts casinos.

TAXABLE GAMING REVENUE

The amount of the Accrual Win by Licensee that is taxable. This is defined, in part, as "the total gross receipts from sports wagering [minus] the sum of: (i) the total of all winnings paid to participants; and (ii) all excise taxes paid pursuant to federal law," in MGL Chapter 23N section 3.

ADJUSTED GROSS FANTASY WAGERING RECEIPTS

The total gross receipts from fantasy contests as defined in section 11M1/2 of Chapter 12, less only the total of all cash prizes paid to participants in the fantasy contests; provided, that the total of all cash prizes paid to participants shall not include the cash equivalent of any merchandise or thing of value awarded as a prize.

TAXES COLLECTED

The total taxes collected by the Commonwealth in a given month from taxable revenue.

SLOTS GROSS GAMING REVENUE

The revenue generated by slot machines and electronic table games in Massachusetts casinos.

TABLE & SLOTS GROSS GAMING REVENUE

The combined revenue generated from slot machines, electronic table games and table games supported by live dealers in Massachusetts casinos.

TOTAL TAXABLE GAMING REVENUE

The combined revenue generated in Massachusetts from Sports Wagering Taxable Gaming Revenue and Casino Wagering Table and Slots Gross Gaming Revenue.

ACCRUAL WIN BY LICENSEE

Current and future wagers settled minus payouts to patrons from those wagers.
