1. Call to Order

In Chair Maynard's absence, Commissioner Eileen O'Brien called to order Agenda Setting Meeting #177 of the Massachusetts Gaming Commission ("Commission").

Quorum was confirmed for the meeting by roll call. The following Commissioners were present for the meeting:

2. Approval of Meeting Minutes

Commissioner Skinner moved to approve the minutes from the August 22, 2024 and September 4, 2024 agenda setting meetings, subject to necessary edits for typographical errors or non-material matters. Commissioner Hill seconded.

The motion passed unanimously 3-0.

<u>Item #7 – Community Mitigation Fund Guidelines</u> – Chief of the Community Affairs Division, Joe Delaney confirmed discussion of the draft Community Mitigation Fund Guidelines for 2025 on September 26, 2024.

<u>Item #8 – IEB – Non-Compliance Matters</u> – IEB Director Monahan requested an agenda item to provide an update to the Commission regarding discission of two sports wagering non-compliance matters.

<u>Add-on Item – Research and Responsible Gaming – Section 97 Update</u> – Director Vander Linden requested an agenda item for discussion of the Division's collection of player data for an upcoming research project.

<u>Add-on Item- IEB - Change of PPC Sportsbook Name</u> – IEB Director Monahan requested a brief agenda item for the discussion of the name change to the PPC Sportsbook.

<u>Add-on Item – Legal Division and IEB – Public Safety Executive Session</u> – General Counsel Grossman requested an executive session to discuss a request from a gaming licensee in response to a recent public safety initiative by the Commission.
