

# Massachusetts Gaming Commission Meeting Minutes

The Commission conducted this public meeting remotely utilizing collaboration technology. Use of this technology was intended to ensure an adequate, alternative means of public access to the Commission's deliberations for any interested member of the public.

#### 1. Call to Order (00:00)

Chair Judd-Stein called to order the 393<sup>rd</sup> Public Meeting of the Massachusetts Gaming Commission ("Commission"). Roll call attendance was conducted, and all four commissioners were present for the meeting.

#### 2. <u>Community Affairs Division</u> (00:38)

a. Community Mitigation Fund 2022 Boston Police Grant Reallocation

Community Affairs Division Chief Joe Delaney presented a request by the City of Boston to repurpose funds from their public safety grant. He explained that due to the City of Boston's internal controls, the city could not apply the grant to a training that took place prior to the grant being awarded. He stated that the City of Boston wanted to reallocate the training funds and an additional \$2,125 of their authorized overtime to purchase \$12,000 of ballistic vests for their human trafficking unit. Chief Delaney recommended that the repurposing of funds be allowed. The *Community Mitigation Fund 2022 Boston Police Grant Reallocation Request* was included on pages 3 through 4 of the Meeting Packet.

Commissioner O'Brien moved that the Commission approve the City of Boston's request to reallocate funds from its 2022 public safety grant to provide \$12,000 for the purchase of ballistic vest carriers as included in the Commissioner's Packet and discussed here today. The motion was seconded by Commissioner Hill

The motion passed unanimously.

- 3. Discussion of Temporary Licensure for Sports Wagering (4:12)
  - a. Discussion of Requirements for Temporary Licensure under G.L. c. 23N, §6(c)

Chair Judd-Stein stated that a potential outcome of implementing temporary licensing under G.L. c. 23N could require a dismantling process of ongoing betting operations who would not receive full operator's licenses, which could result in a destabilization of the new industry.

General Counsel Todd Grossman introduced Deputy General Counsel Caitlin Monahan and Attorney Mina Makarious from Anderson and Krieger. Deputy General Counsel Monahan and Attorney Makarious presented on the Commission's statutory and regulatory responsibilities related to sports wagering. The topics included an overview of the Commission's regulatory responsibility to regulate sports wagering; the responsibility to determine eligibility for licensure; the responsibility to deny or revoke a license; the licensee's responsibilities; temporary licensure per G.L. Chapter 23N; and the potential regulatory framework for temporary licensure. A memorandum regarding Discussion of Requirements for Temporary Licensure was included on pages 5 through 9 of the Meeting Packet.

Deputy General Counsel Monahan noted that the presentation combined this agenda item with other pre-launch considerations. Chair Judd-Stein expressed an interest in a more detailed discussion regarding technology issues. Commissioner O'Brien stated that she wanted more detail regarding the interplay between G.L. Chapter 23K and Chapter 23N. She stated that looking at G.L. Chapter 23N § 5(b), it seemed that temporary operators would have to be full operators, and that she was interested in further discussion regarding house rules. Deputy General Counsel Monahan stated that the Commission had discretion in determining which operator requirements temporary operators would need to abide by, but every operator requirement need not apply to temporary operators. Chair Judd-Stein stated that the definitions in the statute might need to be clarified, as she considered the term operator to refer to those with an operator's license and not a temporary license. Commissioner O'Brien stated that viewing statutory analysis would be necessary to address the operator's requirements in a temporary license setting.

Commissioner Skinner stated that the discussion related to temporary licenses felt premature as the temporary license operators would not be able to engage in sports wagering until operational requirements, such as house rules and technical standards, were met. She stated that she did not see utility in issuing temporary licenses without a process in place for creating a house rules model. Chair Judd-Stein stated that this meeting was to become educated on the temporary licensure process. Commissioner Skinner questioned whether operational requirements should exist before discussing temporary licensure. Chair Judd-Stein stated that operational requirements would be discussed. Attorney Makarious stated that operational requirements needed to be in place before any operations could commence. He stated that applicants would need to have their operational requirements reviewed, and there would be a step between being licensed and operating. Deputy General Counsel Monahan stated that operational requirements and the temporary licensure process could proceed on parallel paths.

Commissioner O'Brien stated that there is a distinction between a license and a certificate of operation present in the statute. Commissioner Skinner asked how the sections outlined in the presentation could be structured to align.

In response to Chair Judd-Stein's request for more information regarding the technology aspects, Executive Director Karen Wells stated that it is important for the public and operators to understand industry best practices. She stated that the technical aspect is enormous in sports wagering and is core to sports wagering's function. She explained that the current setup required potential operators to contract with certified independent test labs to ensure compliance with Massachusetts' technical standards. She stated that there was a temporary basis for reciprocation, where the potential operators could comply by providing technical compliance with a jurisdiction with similar regulations, and later file a GLI letter conforming to Massachusetts' standards within thirty days.

Executive Director Wells stated that there was also a technical standard for geofencing to ensure any sports wagering occurs within the boundaries of Massachusetts. She stated that there were issues of responsible gaming compliance related to Massachusetts directives. She stated that there was additional internal controls testing for sports wagering kiosks at retail sportsbooks. Chair Judd-Stein stated that the Commission should emphasize the acceptable expectations and model for temporary licensure and full operating licenses in the future, in addition to the expectation of suitability.

Commissioner O'Brien stated it would be helpful to receive more detail about the technology requirements for launching mobile sports wagering applications. Chair Judd-Stein noted that even in temporary licensing constructs there was still an expectation of suitability from potential operators. Executive Director Wells stated that the statute directive related to temporary licensure in G.L. Chapter 23N differs from G.L. Chapter 23K where there was not a directive to implement temporary licensure. She stated that casino gaming utilized a temporary process for suitability of primary vendors, and a similar process could be utilized for temporary sports wagering licensure instead of a complete nine-month suitability investigation.

Director of the Investigations and Enforcement Bureau Loretta Lillios stated that the process for temporary or provisional licensure with respect to gaming was not only used for primary vendors, but secondary vendors, key employees, and gaming employees as well. She stated that there was an interim process for REIT transactions. She explained that it was a truncated security review intended to balance operational needs with the need to review for integrity purposes. She explained that it was a risk-based approach, and staff would develop criteria for this review to present to the Commission.

Executive Director Wells stated that internal controls and responsible gaming measures were critical due to the Commission's focus on protecting vulnerable individuals. She stated there would need to be a discussion related to the differences between mobile operators and retail operators, and that gaming agents were working with casino licensees regarding the location of their sportsbooks. Chair Judd-Stein clarified that the temporary licensing process is limited to mobile sports wagering operators. Executive Director Wells stated that all three categories of sports wagering operators could receive temporary licensing, but the specific provision in G.L. Chapter 23N § 6(c) related to mobile operators.

- b. Discussion regarding potential impacts of temporary licensure (46:24)
  - 1. Impacts on mobile/digital sports wagering operators

Executive Director Wells stated that operators tethered to category one and two licenses were different from untethered category three operators. She stated that upon review of the statute she identified significant potential impacts from implementing the temporary licensure of sports wagering. She explained that the statute allowed the Commission to award up to seven untethered category three licenses, but that there was not a cap on the number of temporary licenses the Commission could award.

Executive Director Wells stated that the Commission received a robust response from potential category three applicants and they might expect thirty entities to compete for the seven untethered category three licenses. She explained that each temporary license applicant was required to pay \$1 million, and that if a temporary licensed operator was awarded for a permanent operator's license that \$1 million would apply to the \$5 million license fee. She stated that there was not a mechanism to return the \$1 million to those who are not granted a full license. She stated that if each potential applicant was awarded a temporary license, 76% would be required to shut down operations once the Commission made the final determination on who would receive full sports wagering operations licenses. Executive Director Wells stated that the Commission would require a regulatory process for the shutdown of operators who were not rewarded a full operation license, and that there are concerns related to consumer protection during the shutdown period.

Executive Director Wells presented potential issues including money remaining in consumers accounts being returned upon shutdown; that the Commission's regulatory authority would be limited as the former operators would no longer be licensed; wagers placed for the future where the operator may shut down prior to the event; how entities ensure patrons are aware of the risk the platform may shut down; potential bonds or insurance to pay wagers in event of a shutdown; and what happens to the operator's patron list and personal financial information after shutdown. She stated that it would be beneficial to hear from potential applicants regarding how to proceed.

She stated that she was unaware of other jurisdictions who utilized this potential structure and did not have the benefit of other jurisdiction's experience.

Commissioner O'Brien stated that, in terms of temporary licensure, her interpretation of G.L. Chapter 23N § 6(d) was that prior to receiving an operator's license, the applicant's suitability would be investigated. She noted that the final number of untethered mobile sports wagering operators was up to seven, but could be zero. She stated an interest in protecting the public from the issues that occur in dismantling temporary operators.

Commissioner Hill stated that there was a potential issue of a temporary operator suing if they were not granted a full operational license and were forced to shut down, and stated concern that a lawsuit could stall the industry. Deputy General Counsel Monahan stated that while anyone could file a claim in court, the claim may not be valid. She stated that she did not believe there was a strong claim in the scenario presented by Commissioner Hill. General Counsel Grossman stated that a plaintiff would have to demonstrate a likelihood of success in order to stall the industry as a whole, and that it was unlikely as the Commission would have assured their processes were in accordance with Massachusetts law. Executive Director Wells stated that a creative claim may not be anticipated.

Commissioner Skinner stated that she wanted to avoid a scenario where a majority of the operators would close down, and that she was interested in exploring the legal authority of the Commission to limit temporary licenses to seven. She stated that given the general authority of the Commission in G.L. Chapters 23K and 23N, there may be room to interpret the authority of the Commission to limit the issuance of temporary licenses to prevent having to shut down operators. General Counsel Grossman stated that it was dependent upon how the Commission interpreted the language in G.L. Chapter 23N that discussed temporary licensure to understand the purpose of the process. He stated that the Commission would need to establish the purpose of the provision before limiting the temporary licensure, and that a competitive process was required. He stated that a competitive licensing process was lengthier than otherwise.

Chair Judd-Stein stated that the language in G.L. Chapter 23N mentioned timeliness, and that narrowing the potential temporary licensees down to seven would require the same suitability process required for full operator's licenses. Chair Judd-Stein stated that suitability could be included but it would add time. General Counsel Grossman stated that the process could be done in a truncated fashion that would not require full suitability. He also noted concern that if the number of temporary licenses was reduced, those who received temporary licenses would have advantage over others when applying for full licenses. Chair Judd-Stein stated that would likely result in duplicative efforts if there was a competitive process for temporary licensure. General Counsel Grossman stated that there would be overlap but overlap was not a dealbreaker, and that while it would extend the process it would only be a little longer, but not lengthy.

Commissioner Skinner expressed she would be comfortable with a truncated suitability review for a reduced number of seven temporary licensees, but would want more in-depth suitability if there was a larger number of potential temporary licensees. Executive Director Wells stated that the Commission would have to review and determine criteria for the competitive temporary process.

Commissioner Maynard raised concern about implementing a licensing construct that would saturate the market with temporary operators that would not ultimately receive category three licenses as it would create instability. He expressed interest in having category three licensure implemented as soon as possible to provide stability and focus on the long-term. Commissioner O'Brien stated she was worried about the lack of a sunshine provision, and that the Commission would need to address potential consequences of shutting down temporary operators. She stated that she had more confidence in the suitability of category one and two operators.

Chair Judd-Stein stated she struggled with the complexity in the statute that the temporary licensing pool was not limited by the legislature in the same way full operational licensing was. She stated she was unsure if the Commission had the legal authority to limit the number of entrants for temporary licensure. She stated that there would be a delay in conducting a competitive review at this stage, but the outcome of having to shutdown potential temporary operators and the potential fallout to customers was untenable. She stated that the operator's input at the roundtable the following week would be beneficial.

Commissioner O'Brien stated that she shared concerns, but there are options that mitigate the risk even if they are not perfect prior to a legislative fix. Chair Judd-Stein stated that customers would need to understand the potential that temporary operators may need to shut down at a later date. Chair Judd-Stein inquired if there was a possibility to reduce the group of potential operators without reducing it at the onset. General Counsel Grossman stated that the operators would require disclaimers or notifications to consumers regarding that status of each of the operations. He stated that linking the temporary licensing process with the permanent licensing process would be more fluid.

Lon Povich, Attorney from Anderson and Krieger, stated that the Commission has broad powers in the area. He explained that if there is a process for an untethered temporary license, part of the application process could require recipients to mitigate issues raised here. He stated that having to shut down temporary operators would be disruptive, but issues can be addressed by incorporating mitigation factors into the application.

Commissioner Skinner stated that it was reasonable to have the legal division research and analyze risks associated with limiting the number of temporary licenses granted to potential operators.

#### c. Discussion on simultaneous vs. staggered launch (1:31:43)

Executive Director Wells stated that an early competitive process for untethered mobile operators also affected whether the launch would be simultaneous or staggered. She stated that if there is added time to the licensing component, the Commission would have to address the issue of allowing parties to launch when ready or wait to launch at the same time. She stated that different jurisdictions have done both staggered and simultaneous, and there is precedent for each way. Chair Judd-Stein stated that the Commission would likely be more informed on the issue after the operators' roundtable in the following week.

Commissioner Hill asked approximately how long consumers would anticipate waiting for mobile sports wagering after the category one and two retail sportsbooks were allowed to operate. Executive Director Wells stated that the initial issue with a timeline was how truncated the suitability review would be for temporary licensure. She stated that significant work would be required in evaluating proposals which may take months if the competitive process was used to reduce temporary licenses granted. She stated that there was also the issue of allowing mobile sports wagering operators tethered to category one and category two licenses to operate prior to temporary licensure of category three operators, as they were two similar categories competing for the same market.

Chair Judd-Stein stated that the timeline can not be addressed due to the number of potential applicants for category three licenses, and additional input from operators regarding the temporary licensing procedure would be required. Commissioner Hill stated that while the Commission can't provide a timeline at this juncture, an expected timeline should be provided to the public soon as the Commission was facing criticism due to not releasing a general timeframe. Commissioner O'Brien stated that part of the reason a timeline had not been formed was due to the topics discussed in this meeting.

Executive Director Wells stated that some of the issues would be resolved by the cooperation and ideas presented by the potential licensees in the operators' round table on September 22, 2022. She stated that a relationship between the regulator and licensee can be helpful for understanding. Chair Judd-Stein stated that there might be more comfort amongst the potential operators regarding shutting down than the Commission anticipated. Commissioner Maynard stated that temporary licensure may be a red herring, and it may be more worthwhile to move along the full licensing process if temporary operators would enter and be removed from the market in under a year.

#### 4. MGC Preparations for Matters Related to Sports Wagering (2:27:22)

#### a. Update on 205 CMR 238.00: House Rules

General Counsel Grossman stated that adjustments had been made to 205 CMR 238.03 to change language in accordance with past meetings. He stated that the regulation would return to the Commission shortly with additional regulations necessary for the commencement of sports wagering operations. The *Draft of Regulation 205 CMR 238.03 and Small Business Impact Statement* were included on pages 10 through 15 of the Commissioner's Packet.

#### b. Process for Sports Wagering Test Lab Certification (2:28:49)

Deputy General Counsel Carrie Torrisi explained that draft regulation 205 CMR 233.06 authorized entities certified as independent test labs for gaming equipment to be certified as independent test labs to provide certification for sports wagering equipment. She stated that staff recommended that the two existing certified independent test labs, Gaming Labs International (GLI) and BMM Testlabs (BMM), submit a petition for authorization for the Commission to review during the September 19, 2022, meeting. The *Draft of Regulation 205 CMR 244.06 and* 

Small Business Impact Statement were included on pages 16 through 20 of the Commissioner's Packet.

#### 5. <u>Horse Racing Application and Related Issues</u> (2:30:51)

a. 205 CMR 2.01: new regulation governing the application for a new license for the conduct of horseracing, initial review of draft and Small Business Impact Statement

General Counsel Grossman explained that the draft regulation 205 CMR 2.01 codified the statutory directive that an application to conduct horse racing start a review process. He stated that the application reflected provisions of G.L. Chapter 128A and had been approved by the Commission at the September 12, 2022, meeting. He stated that the regulation had not been redlined as it was new. The *Draft of Regulation 205 CMR 2.01 and Small Business Impact Statement* were included on pages 21 through 26 of the Commissioner's Packet.

General Counsel Grossman explained that regulations regarding horse racing had additional administrative requirements regarding the promulgation of regulations under G.L. Chapter 128A § 9(b). He stated that the draft regulation must be submitted to the legislature for a sixty-day review process, and that it would extend the normal sixty-to-ninety-day promulgation process.

General Counsel Grossman stated that the emergency adoption of regulations in the context of horseracing must be designed to protect the health or safety of public participants or animals. Chair Judd-Stein asked how the Commission could reconcile the current regulation with the emergency requirements. General Counsel Grossman stated that the statute affords the Commission clear authority to release the application in the form done previously and that the application incorporates G.L. 128A. He stated that under G.L. 128A § 2. the Commission has authority to add additional questions to the application, as the regulation was simply intended to support the application in the future.

Chair Judd-Stein introduced Dr. Alexandra Lightbown, Director of Racing and Chief Veterinarian. Dr. Lightbown suggested a language change to clarify that the regulation addressed parimutuel wagering that was occurring on live racing, simulcasting, and advance-deposit wagering.

Commissioner O'Brien moved that the Commission approve the small business impact statement and draft of 205 CMR 2.01 as included in the Commissioners' Packet and as further discussed and edited here today, particularly noting Dr. Lightbown's edit and further that staff be authorized to take the steps necessary to file the required documentation with the Secretary of the Commonwealth to begin the regulation promulgation process, and further move the staff be authorized to modify chapter or section numbers or titles and to file any additional regulations as reserved or make any administrative changes as necessary to execute the regulation promulgation process. The motion was seconded by Commissioner Skinner.

The motion passed unanimously.

b. <u>Discussion of impact of Massachusetts Sports Wagering Act on prospective new horse racing licensee(s) relative to mobile/digital sports wagering.</u> (2:42:40)

General Counsel Grossman stated that he was actively researching the effect of awarding a horse racing license under G.L. Chapter 128A vis-a-vis sports wagering. Chair Judd-Stein inquired as to whether the new application was available on the Commission website. Executive Director Wells stated that both the application for new applicants and renewals was available on the website. Chair Judd-Stein noted that the deadline for the application, including applications for renewal, is October 1, 2022. General Counsel Grossman stated that Plainridge Park Casino was the only renewal, and that sports wagering would not be an issue for them as they qualify for a category one sports wagering license.

- 6. Commissioner Updates (2:46:50)
  - a. Plan for Sports Wagering Roundtable related to Mobile/Digital Sports Wagering Operators

Chair Judd-Stein stated that a roundtable for potential mobile sports wagering operators was scheduled for an in-person meeting on September 22, 2022, at the Massachusetts state house. She explained that in recognition of time constraints Executive Director Wells had created two questions which addressed consumer protections should temporary operators shut down and the operators' opinions on a simultaneous or staggered launch.

Commissioner O'Brien asked about the potential length of the meeting given each operator would have five minutes to address the Commission. Chair Judd-Stein stated that with the assumption that there would be thirty to forty operators present, the maximum length of the meeting would be three hours and forty-five minutes. Commissioner O'Brien stated that due to circumstances she would likely be remote and asked for twenty to thirty minutes for the Commissioner's to ask questions.

Commissioner O'Brien stated that the first question might be better suited for the Commission as the potential operators may not have appreciation for regulatory implementation. Executive Director Wells stated that the applicants may be worried about having their license pulled after paying \$1 million, and that potential licensees may want to expedite the final licensure process despite the structure in the statute requiring temporary licensure. Commissioner O'Brien stated that she wanted to narrow the questioning to avoid repetition in topics the Commission had already considered. Commissioner Maynard stated that the potential applicants may not want to apply for a temporary license knowing there would be a later competitive process for full

licensure and they would not be awarded a full operator's license. Chair Judd-Stein stated that the roundtable would allow the Commission to learn the level of interest in the industry related to temporary licensing.

Commissioner Skinner expressed an interest in having time to hear the applicant's concerns. Commissioner Hill stated that in his experience, the Commission would likely hear a theme of similar concerns from the operators. Chair Judd-Stein stated that due to the format it was harder to have a detailed conversation with the applicants, and that the Commission might require additional written comments or a virtual roundtable. Commissioner Skinner stated the Commission should communicate at the roundtable that the applicants would have an opportunity to submit written comments. The Commission edited the questions for the roundtable to address their concerns.

Chair Judd-Stein stated that an issue that arose in the responsible gaming roundtable was the Commission's authority to regulate advertisements. Commissioner Maynard responded that it would be helpful to know the parameters of what the Commission can govern related to nationalized media. Chair Judd-Stein stated that the Commission could look into procuring a law firm with first amendment law experience. Commissioner O'Brien stated that there was also a difference between legal compliance and practicability of regulations being implementing. Commissioner Hill expressed it would be informative to invite national, regional, and local networks to explain how the commercials are implemented.

Chair Judd-Stein stated that while there is consensus related to the legal construct, there may be issues getting comment from various entities. Chief Financial and Accounting Officer Derek Lennon explained that fees under \$10,000 qualified for incidental one-time procurement. He stated that there were existing statewide contracts for legal services that could be utilized, and that the marketing firm contracting with the Research and Responsible Gaming Division could answer questions related to marketing. Chair Judd-Stein stated that the state law contract gave the Commission flexibility.

Chair Judd-Stein asked if the Commission could pick three industry experts or if there were concerns about the process. Attorney Povich stated that the Commission could invite parties to receive information, and there did not seem to be a conflict. He stated that different states have different requirements and national commercials typically had language riders included to address that. Chair Judd-Stein stated that the Commission had questions related to marketing but they needed to understand how markets work differently on a regional versus national level.

Hearing no other business, Chair Judd-Stein asked for a motion to adjourn.

Commissioner Hill moved to adjourn. Commissioner O'Brien seconded the motion.

#### **Dear Commissioners:**

As part of their Application for a License to Hold or Conduct a Racing Meeting in 2023, Steve O'Toole, Director of Racing, Plainridge Park Casino, included their requested premium-free period as part of Exhibit 27. This period is Sunday June 18, 2023 to Saturday September 9, 2023 in accordance with Massachusetts General Law 128C, § 2 (4).

Recommendation: That the Commission approves the Plainridge Park request for approval of their premium free period from Sunday June 18, 2023 to Saturday September 9, 2023.

#### **EXHIBIT 27**

Include as Exhibit 27 a master list of requested simulcast imports. A new form ("Licensee Request for Simulcast Import") MUST be completed for EACH signal and submitted to the Commission no later than November 29 of each calendar year. Approval letters from the host racetrack's regulatory authority and both representative horsemen's groups must be on file with MGC by the close of business on the day prior to the first day of import.

#### **Notice of "Premium Free" Election**

Plainville Gaming and Redevelopment, LLC identifies and elects the period from Sunday June 18, 2023 to Saturday September 9, 2023 as the period for "which no premium need be paid" for simulcast signals received in accordance with MGL 128C, section 2 (4). The remaining period subject to be paid as outlined in the premium provisions in 128C, section 2 (5).

#### **Dear Commissioners:**

As part of their Application for a License to Hold or Conduct a Racing Meeting in 2023, Steve O'Toole, Director of Racing, Plainridge Park Casino, included their list of requested simulcast import locations as Exhibit 27.

Chapter 128 of the Acts of 2022 of the Commonwealth of Massachusetts Section A1 amends Chapter 128C of the General Laws by adding Section 9, which eliminates simulcast wagering on greyhound dog racing. Section 18 states this will take effect on August 1, 2023.

Recommendation: That the Commission approves the Plainridge Park request for approval of the simulcast import locations for horse racing listed in their Application for a License to Hold or Conduct a Racing Meeting in 2023, for the calendar year 2023.

That the Commission approves the Plainridge Park request for approval of the simulcast import locations for greyhound dog racing listed in their Application for a License to Hold or Conduct a Racing Meeting in 2023 until August 1, 2023, consistent with Chapter 128 of the Acts of 2022.

### Acts of 2022, Chapter 128

# AN ACT TO EXTEND LIVE HORSE RACING AND SIMULCASTING IN THE COMMONWEALTH

Whereas, The deferred operation of this act would tend to defeat its purpose, which is to further regulate simulcasting, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 18. Section A1 shall take effect on August 1, 2023.

#### **Dear Commissioners:**

As part of their Application for a License to Hold or Conduct a Racing Meeting in 2023, Steve O'Toole, Director of Racing, Plainridge Park Casino, included their request for authorization for account wagering through PENN ADW, LLC, d/b/a Hollywood Races, using the eBet Technologies platform, as Exhibit 29. The Massachusetts Gaming Commission first authorized this system at their October 26, 2016 meeting.

Recommendation: That the Commission approves the Plainridge Park request for approval of their account wagering through PENN ADW, LLC, d/b/a Hollywood Races, using the eBet Technologies platform listed as Exhibit 29 in their Application for a License to Hold or Conduct a Racing Meeting in 2023.

That PENN ADW, LLC, d/b/a Hollywood Races, not accept wagering in Massachusetts on greyhound dog racing after July 31, 2023, consistent with Chapter 128 of the Acts of 2022.

In accordance with 205 CMR 6.20, Plainville Gaming and Redevelopment, LLC ("PGR"), d/b/a Plainridge Park Casino ("Plainridge"), requests through this harness racing license application for 2023, authorization from the Massachusetts Gaming Commission ("MGC") to offer account wagering in 2023. PGR has contracted with PENN ADW, LLC, ("PENN") a licensee of the MGC, to operate account wagering under the d/b/a *Hollywood Races* (agreement previously attached). Account wagering offered by Plainridge dates to its "WinLine" System originally approved by the Massachusetts State Racing Commission on April 3, 2002.

PENN has contracted with eBet Technologies ("eBet"), a licensee of the MGC, to provide all technical and wagering platform services for *Hollywood Races* to on and off-track customers of Plainridge accessible via the website, <u>www.hollywoodraces.com</u> and through a mobile app (available on both iOS and Andriod systems).

In 2021, Massachusetts account holders registered with *Hollywood Races* wagered \$4.95 million, representing approximately 20% of the total live and simulcast handle for PRG during the year.

Since 2016, pari-mutuel wagering on-track at Plainridge and through *Hollywood Races* has been combined with *myChoice* the Plainridge Park Casino customer rewards program with points earned for redemption of food and beverage offerings at the racetrack/casino and for racing related handicapping information (programs, etc.).

PGR's parent company, Penn Entertainment, Inc. has over 30 years experience in account wagering through its subsidiary Mountainview Thoroughbred Racing Association previously d/b/a EbetUSA.com and Telebet and as of September 2018, Hollywood Races also holds Multi-Jurisdictional Account Wagering licenses in the states of Oregon and New York and accepts wagers from residents of 24 states.

Suffolk Downs' Chief Operating Official Michael Buckley has submitted a request for approval of simulcast import locations dated November 30, 2023. These locations usually are approved as part of a racing licensee's application for live racing. Under the current statutes, Suffolk is authorized to simulcast without conducting live racing. Suffolk Downs did not apply for live racing dates in 2023, necessitating a separate approval by the Commission.

Chapter 128 of the Acts of 2022 of the Commonwealth of Massachusetts Section A1 amends Chapter 128C of the General Laws by adding Section 9, which eliminates simulcast wagering on greyhound dog racing. Section 18 states this will take effect on August 1, 2023.

# AN ACT TO EXTEND LIVE HORSE RACING AND SIMULCASTING IN THE COMMONWEALTH

Whereas, The deferred operation of this act would tend to defeat its purpose, which is to further regulate simulcasting, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

#### **Dear Commissioners:**

Suffolk Downs' Chief Operating Official Michael Buckley has submitted a request for approval of the following Advance Deposit Wagering providers: XpressBet LLC and its affiliate 1/ST Bet, TVG, Twin Spires, FanDuel Racing, NYRA Bets, BetMGM, and Caesars Racebook for 2023. All of these have been approved previously by the Commission, except for Caesars Racebook.

Caesars Racebook has a marketing affiliation with NYRA Bets for parimutual racing. NYRA Bets has been authorized in Massachusetts since 2016 as an Advance Deposit Wagering provider. A document has been provided regarding the association between the two. It is similar to the NYRA Bets affiliation with BetMGM. Through their partnership with Caesars Racebook, NYRA Bets "administers all aspects of the racing function provided to Caesars Racebook horse racing customers" and supplies the NYRA Bets technology to them. NYRA Bets Fraud Mitigation and Player Integrity teams monitor and supply Caesars Racebook with any suspicious wagering reports. Caesars Racebook is currently operating in Florida, Indiana, Kentucky, Maryland, Montana, North Dakota, Ohio, and Oregon. Past practice has been to reciprocate when Account Wagering providers are already operating in other jurisdictions. We do not have any information that there have been issues with account wagering by this provider. Please note that the below recommended approval is for Account Wagering purposes only, and similar to BetMGM, has no bearing on any potential license application for other activity.



Recommendation: That the Commission approves the Suffolk Downs request for approval of XpressBet LLC and 1/ST Bet, TVG, Twin Spires, FanDuel Racing, NYRAbets, BetMGM and Caesars Racebook as their Advance Deposit Wagering vendors, for parimutuel wagering purposes only.

That the above vendors not accept wagering in Massachusetts on greyhound dog racing after July 31, 2023, consistent with Chapter 128 of the Acts of 2022.

I write in accordance with 205 CMR 6.20 to request that the Commission approve account wagering, or advance deposit wagering (ADW), vendors for Sterling Suffolk Racecourse, LLC ("Suffolk Downs") for 2023.

Suffolk Downs seeks approval of XpressBet, its affiliate 1/ST Bet, TVG, Twin Spires, FanDuel Racing, NYRA Bets, BetMGM, and Caesars Racebook as its 2023 account wagering providers. The Commission has previously approved each of these vendors other than Caesars Racebook.

With respect to BetMGM, and consistent with the terms on which the Commission approved BetMGM in February 2022, SSR confirms that it seeks approval of BetMGM as an ADW provider only and not in connection with any other wagering services that BetMGM might provide.

With respect to Caesars Racebook, it has a marketing affiliation with NYRA Bets for parimutuel racing. The Caesars Racebook app launched in June 2022 and is currently available in eight states: Florida, Indiana, Kentucky, Maryland, Montana, North Dakota, Ohio, and Oregon. NYRA Bets, which has been an authorized ADW provider in Massachusetts since 2016, has informed us that parimutuel wagering on horse racing through the Caesars Racebook-branded app operates on the existing NYRA Bets infrastructure. NYRA Bets hosts the patron accounts and wallets and provides customer service and wagers utilize NYRA Bets' tote, streaming, data, settlement and related operations. As with BETMGM, we seek approval of Caesars Racebook as an ADW provider for parimutuel wagering only.

Request for Simulcast Import Locations for 2023

#### **Dear Commissioners:**

Massasoit Greyhound Association President George Carney, Jr., has submitted a request for approval of simulcast import locations dated December 1, 2022. These locations usually are approved as part of a racing licensee's application for live racing, however live greyhound racing is not allowed. Under the current statutes, Massasoit (Raynham) is authorized to simulcast without conducting live racing.

Chapter 128 of the Acts of 2022 of the Commonwealth of Massachusetts Section A1 amends Chapter 128C of the General Laws by adding Section 9, which eliminates simulcast wagering on greyhound dog racing. Section 18 states this will take effect on August 1, 2023.

Recommendation: That the Commission approves the Massasoit (Raynham) request for approval of their simulcast import locations for horse racing listed in their December 1, 2022 letter for calendar year 2023.

That the Commission approves the Massasoit (Raynham) request for approval of the simulcast import locations for greyhound dog racing listed in their December 1, 2022 letter until August 1, 2023, consistent with Chapter 128 of the Acts of 2022.

### Acts of 2022, Chapter 128

# AN ACT TO EXTEND LIVE HORSE RACING AND SIMULCASTING IN THE COMMONWEALTH

Whereas, The deferred operation of this act would tend to defeat its purpose, which is to further regulate simulcasting, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION A1. Chapter 128C of the General Laws is hereby amended by adding the following section:-

Section 9. Notwithstanding sections 1 to 8, inclusive, or any other general or special law to the contrary, no racing meeting licensee, including a licensee holding racing meetings in connection with a state or county fair, as defined in section 1 of chapter 128A, shall simulcast or accept a simulcast wager on greyhound dog racing.

SECTION 1. The first paragraph of section 12A of chapter 494 of the acts of 1978 is hereby amended by striking out the words "and until July 31, 2022", inserted by section 1 of chapter 27 of the acts of 2021, and inserting in place thereof the following words:- and until July 31, 2023.

SECTION 15. Section 74 of chapter 10 of the acts of 2015 is hereby amended by striking out the words "July 31, 2022", inserted by section 15 of said chapter 27, and inserting in place thereof the following words:- July 31, 2023.

SECTION 16. Section 17 of chapter 27 of the acts of 2021 is hereby repealed.

SECTION 17. Notwithstanding section 2 of chapter 128A of the General Laws and sections 1, 2, 2A and 4 of chapter 128C of the General Laws or any other general or special law to the contrary, the running race horse meeting licensee located in Suffolk county licensed to conduct live racing pursuant to said chapter 128A and simulcast wagering pursuant to said chapter 128C in calendar year 2022 shall remain licensed as a running horse racing meeting licensee until July 31, 2023 and shall remain authorized to conduct simulcast wagering pursuant to said chapter 128C until July 31, 2023; provided, however, that the days between the effective date of this act and July 31, 2023 shall be dark days pursuant to said chapter 128C and the licensee shall be precluded from conducting live racing during that period unless it applies for and is granted a supplemental live racing license pursuant to said chapter 128A; provided further, that all simulcasts shall comply with the Interstate Horse Racing Act of 1978, 15 U.S.C. 3001 et seq. or other applicable federal law; provided further, that all simulcasts from states which have racing associations that do not require approval in compliance with the Interstate Horse Racing Act of 1978, 15 U.S.C. 3004(a)(1)(A) shall require the approval of the New England Horsemen's Benevolent & Protective Association prior to being simulcast to a racing meeting licensee within the commonwealth; and provided further, that if the association agrees to approve the simulcast for 1 racing meeting licensee, it shall approve the simulcast for all otherwise eligible racing meeting licensees.

SECTION 18. Section A1 shall take effect on August 1, 2023.

Attached to this memo are research plans for two studies that are included in the 2022 Act to Regulate Sports Wagering (House Bill No. 5164), and M.G.L Chapter 23N.

- M.G.L. 23N Section 20: Research study examining the feasibility of allowing retail locations in the Commonwealth to operate sports wagering kiosks. The attached document outlines a comprehensive scope for research to be undertaken following a competitive procurement process beginning in January 2023.
- Act Regulating Sports Wagering, Section 25: A research study on the participation by
  minority business enterprises, women business enterprises, and veteran business
  enterprises in the sports wagering industry in the Commonwealth. The attached
  document outlines a comprehensive scope of research that can be undertaken after the
  launch of sports wagering in the Commonwealth, and sufficient time has passed to
  assess the industry.

Following feedback and approval by the Commission, the Research and Responsible Gaming Division is prepared to deliver to the Legislature by December 31, 2022, as required by statute.



### Research Plan for a Prospective Study of the Feasibility and Impact of Sports Wagering Kiosks in Retail Locations

#### **Background**

The Massachusetts Gaming Commission is responsible for creating a fair, transparent, and participatory process for implementing the expanded gaming law (2011) and Act to Regulate Sports Wagering (2022). In its creation, the commission established processes designed to:

- ensure that its decision-making and regulatory systems earn the confidence of the public and participants,
- provide the greatest possible economic development benefits and revenues to the people of the Commonwealth,
- reduce to the maximum extent possible the potentially negative or unintended consequences of gambling,
- allow an appropriate return on investment for gaming providers that assures the operation of casino-resorts of the highest quality.

The 2011 Gaming Act required that the commission establish an "annual research agenda" to understand the social and economic effects of expanding gaming in the commonwealth and to obtain scientific information relative to the neuroscience, psychology, sociology, epidemiology and etiology of gambling. The 2022 Act to Regulate Sports Wagering (House Bill No. 5164) Section 23 extends the scope of the research agenda to include an understanding of the effects of sports wagering in the commonwealth.

#### Study of the Feasibility of Sports Wagering Kiosks

The Act to Regulate Sports Wagering Section 20 requires the MGC to conduct a study into the feasibility of allowing retail locations in the commonwealth to operate sports wagering kiosks.

As required by the new law, this study should address the feasibility, and the potential economic, public health, and safety impacts of such a decision. It should include a discussion and/or evidence-based recommendations that address whether to do so and how to do so in a way that will maximize benefits and minimize negative consequences, including ways to understand and incorporate diversity, equity and inclusion considerations for retailers, consumers, and communities.


#### What is a Sports Wagering Kiosk

Sports Betting Kiosks provide users with a self-service way to legally place bets, access handicapping services, obtain sports information, and view locally advertised promotions. Traditional sports books have

limited hours of operation and a limited number of locations in high traffic areas. Customers may have to travel long distances and/or wait in long lines at peak betting times. Sports Betting Kiosks can deliver expanded (24/7) and more convenient access. Sports Betting Kiosks can accept cash, winning tickets, and vouchers, and grant full access to all sports propositions and pari-mutuel horse racing. The kiosks include tools for compliance with currency transaction reports and book wagering reports. <sup>1</sup>

Survey of Sports Wagering Kiosks in the U.S. According to the American Gaming Association<sup>2</sup>, as of November 21, 2022 sports betting is legal in 36 states and live in 31 states (see map below).

Only nine states (Arizona, Connecticut, Delaware, Kansas, Louisiana, Maryland, Montana, Ohio, and Washington DC) allow for kiosks in non-gaming settings such as a restaurants or bars. Please see the Appendix to this document for a review of relevant legislation in these jurisdictions.

#### Study Requirements

The MGC will seek the services of at least one qualified entity to conduct a prospective study on the feasibility, and potential impact, of allowing retail locations in the commonwealth to operate sports wagering kiosks.

The successful applicant should consider multiple sources of information including but not limited to studies conducted as part of the MGC research agenda, other academic and non-academic literature, key informant interviews, and economic reports and data. Applicants are also encouraged to think more expansively by including a review of studies showing the impacts of implementation of similar technology; for example, video lottery terminals. Methodology should include a review of jurisdictions with kiosk availability, including the structure, implementation and, where available, data or evaluations on the anticipated and actual impacts of such kiosks to date. Methodology should include consultation with retailers, convenience stores, restaurants, women and minority owned businesses, small business owners, experts from the Massachusetts Lottery, and experts from the Office of the Treasurer and Receiver General, including the Alcoholic Beverages Control Commission.

#### Research Questions

The study should answer, at a minimum, the following research questions:

- 1. What is the economic impact of the existing sports wagering market on retail establishments that serve alcoholic beverages for on premises consumption, such as restaurants and bars?
- 2. What are the essential requirements for a retail setting to host a sports wagering kiosk? Including but not limited to:
  - Capacity to comply with social responsibility and other regulatory requirements, including monitoring and data collection requirements
    - Applicability of pre-existing licenses and related compliance infrastructure in retail locations that provide restricted products such as alcohol for on-premises consumption
  - Money-handling capacity and methods for accepting wagers and providing payouts and winnings
  - Human resources capacity and requirements, including skills and training
- 3. What types of retail settings may be best suited to hosting sports wagering kiosks?
- 4. What are the anticipated economic impacts of sports wagering kiosks at retail locations?
  - On various types of retail locations? For example, retail establishments that serve alcoholic beverages for on premises consumption, such as restaurants and bars; retail establishments that sell alcohol for off-premises consumption, such as package stores; or retail establishments that do not sell alcohol?
  - For other population groups such as minority communities, or those living far from inperson wagering locations?
  - For minority-owned businesses?
  - For the Commonwealth?
  - For retail locations that do not offer sports wagering kiosks?
- 5. What are the anticipated impacts on the Massachusetts Lottery, particularly in the context that many of the potential retail locations would likely offer both lottery products and sports wagering?
  - Is there evidence indicating that cannibalization of the lottery by sports wagering kiosks may occur?
  - What is the projected impact on the Lottery's contribution to unrestricted local aid to cities and towns?
  - What are recommendations to mitigate adverse impact to the Lottery's contribution to unrestricted local aid (if adverse impact is projected?)

- 6. What are the anticipated public health impacts of sports wagering kiosks at retail locations, and particularly public health impacts for populations most at-risk for problem gambling?
  - What kinds of measures should be considered to promote responsible gaming in order to minimize gambling-related harm and maximize player choice?
- 7. What are the anticipated security, safety, and potential crime-related impacts of sports wagering kiosks at retail locations?
  - For consumer protection and enforcement of age restrictions?
- 8. What is the anticipated market recapture from the black market if sports wagering kiosks are available at retail locations?
  - What are the anticipated economic and public health impacts of market recapture, particularly in communities far from authorized in-person sports wagering?
- 9. What is the anticipated impact on minors of sports wagering kiosks at retail locations which allow persons under the age of 21 to enter?
  - What measures should be considered to prevent persons under the age of 21 accessing a sports wagering kiosk in a restaurant or bar which permits persons under the age of 21 to enter?
- 10. What if any, are the anticipated cannibalization effects on casino and sports wagering operators licensed by the MGC?
- 11. If kiosks are implemented in retail settings, how frequently should public health, safety, and economic impacts of sports wagering kiosks be reassessed by the Commission?

Additional research questions or topics are welcome, provided they address the issues of feasibility and impact of sports wagering kiosks at retail locations.

The proposal should clearly detail how the proposed methods will answer each research question.

#### Budget

Anticipated funding available for this feasibility study will be approximately \$100,000-\$150,000.

#### Research Team Qualifications

The teams and individuals selected to carry out the research should have the following qualifications and experience:

- In-depth knowledge of research methods in the related subject areas
- Experience and expertise in qualitative and quantitative research
- Experience and expertise garnering community input and understanding for research impacting communities
- Experience and expertise in the analysis of factors and covariant indicators of economic development
- Understanding of the gambling landscape in Massachusetts
- Understanding the mission and goals of the Massachusetts Gaming Commission

- Demonstrated experience in knowledge translation for a range of target audiences
- Understanding the associations and influence of social determinants of health on behaviors, behavioral outcomes, and health outcomes
- Knowledge of other bodies of research work in the areas of problem gambling and economic development
- Demonstrated experience designing, managing and coordinating complex research projects
- Illustration of a commitment to diversity through composition of research team and/or participants, partnerships, and/or use of certified diverse vendors/subcontractors on the project

#### **Timeline**

This scoping document will inform the development of a competitive RFR with an anticipated release in January 2023.

#### Appendix: Statues and Regulations Pertaining to Sports Wagering Kiosks in Non-Gaming Settings such as Restaurants and Bars

Methodology: A search was conducted using the "Odds on Compliance" database about what state statutes and regulations exist permitting sports wagering kiosks to be placed/used in a non-gaming setting like a restaurant or a bar. Research was limited to the following nine states that the American Gaming Association (AGA) identified as allowing these kinds of kiosks: Arizona, Connecticut, Delaware, Kansas, Louisiana, Maryland, Montana, Ohio, and Washington DC.

Each state's individual page in the database and was reviewed, and the search focused on the documents listed under the headings, "Statute" and "Regulation." Within those documents, there was a search for keywords that are relevant to this issue. "Kiosk" was referenced in different ways depending on the state, so also included is a column in the chart below about alternative terms used to reference "kiosk" in statutes and regulations. Examples include "equipment," "machine," and "electronic." Then once language (if any) was found that referenced kiosks, a further search was completed for any mention of a "bar," "restaurant" or "public accommodation."

To be noted is that some states had minimal statutes and regulations referencing kiosks in non-casino settings, though the AGA initially identified them as allowing it.

### Research Plan for a Study of the Participation by Minority, Women, and Veteran Business Enterprises in the Sports Wagering Industry in Massachusetts

#### **Background**

The Massachusetts Gaming Commission (MGC) is responsible for creating a fair, transparent, and participatory process for implementing the expanded gaming law (2011) and Act to Regulate Sports Wagering (2022). In its creation, the commission established processes designed to:

- ensure that its decision-making and regulatory systems earn the confidence of the public and participants,
- provide the greatest possible economic development benefits and revenues to the people of the Commonwealth.
- reduce to the maximum extent possible the potentially negative or unintended consequences of gambling.
- allow an appropriate return on investment for gaming providers that assures the operation of casino-resorts of the highest quality.

The 2011 Gaming Act required that the commission establish an "annual research agenda" to understand the social and economic effects of expanding gaming in the commonwealth and to obtain scientific information relative to the neuroscience, psychology, sociology, epidemiology and etiology of gambling. The 2022 Act to Regulate Sports Wagering (House Bill No. 5164) Section 23 extends the scope of the research agenda to include an understanding of the effects of sports wagering in the commonwealth.

#### Global and National Context

Several initiatives have involved monitoring diversity, equity, and inclusion initiatives across the gaming industry. The All-In Diversity Project, an industry-led not-for-profit initiative seeking to benchmark diversity, equality and inclusion across the global betting and gaming industry, released a report concerning the sector's workforce covering the period 2020-2021 (to account for the impact of the pandemic). This report noted that the number of males (56%) exceeded the number of females (43%) for the first time in 5 years, that the biggest gap was at entry level, and noted this was a "real cause for

concern when looking at long term prospects for role models, mentors and talent pools." Globally, of note for sports wagering is the projection that "women's sport is growing at a faster rate" than men's"cue an increase in female sports betting markets and female sports-bettors."

In 2018, the U.S. Chamber of Commerce Foundation's Corporate Citizenship Center, in conjunction with the American Gaming Association (AGA) conducted a survey of 15 AGA member respondents representing 168 United States member properties concerning corporate social responsibilities. While the survey speaks to the gaming industry vs. sports wagering specifically, the survey found that 69% of respondents reported having "an institutionalized diversity and inclusion hiring effort," 45% reported having diversity and inclusion retention strategies, and 29% reported having employee affinity or resource groups. They compared these results to findings from a 2014 Diversity and Inclusion survey of human resources professionals from many different industries conducted by the Society for Human Resource Management indicating percentages of 57%, 38%, and 15% respectively. In 2021, the AGA conducted an industry-wide assessment of member activities related to Environment, Social and Governance issues, which captured how member organizations were prioritizing strengthening diversity, equity, and inclusion initiatives. While not specific to the sports wagering industry, the AGA report provided case examples from member organizations that offer sports wagering products.

Study of the Participation by Minority, Women, and Veteran Business Enterprises in the Sports Wagering Industry in the Commonwealth

The Massachusetts Gaming Commission is working with licensees, their contractors, vendors, and community leaders to ensure that the state's new expanded gaming industry is inclusive and provides opportunities that reflect the diversity of the Commonwealth.

The 2011 Expanded Gaming Act required casino applicants to establish training programs that promote the development of a skilled and diverse workforce. The casino application process required all gaming applicants to set diversity hiring goals and submit strategic plans for the inclusion of minorities, women and veterans in the workforce. Applicants were also required to formulate their own specific diversity goals related to minority-, women- and veteran-owned businesses to participate as contractors in all stages of building their gaming establishments (design, construction, and operation). Casinos are also required to regularly provide to the Commission detailed, statistical reports on the diversity of their workforce and vendor contracting. In July 2021, the Diversity and Legislative Affairs division of the MGC released its third report chronicling industry insights regarding impacts to local businesses, workforce and diversity measures covering the 2019 calendar year. According to this report:

- Of casino construction and operations employees, more than 4,300 were minority, 3,200 were women, and nearly 400 were veterans;
- Casino licensees spent more than \$64 million with diverse vendors and suppliers.<sup>6</sup>

The 2022 Act to Regulate Sports Wagering Section 25 requires the MGC to build upon the existing research, and conduct a study on the participation by minority, women, and veteran business enterprises in the sports wagering industry in the commonwealth.

#### Study Requirements

The MGC will seek the services of at least one qualified entity to conduct a study on the participation by minority, women, and veteran business enterprises in the sports wagering industry in the commonwealth. The study must include methods for increasing racial and gender diversity in the workforce in the sports wagering industry, including whether to set reasonable and appropriate goals and procedures for increasing the number of minority business enterprises providing sports wagering industry-related services to sports wagering licensees and employers.

The successful applicant should consider multiple sources of information including but not limited to information from licensees; licensee, industry-specific, local, state, and national employment data stratified by gender, race/ethnicity, and veteran status; studies conducted as part of the MGC research agenda; other academic and non-academic literature; key informant interviews; and economic reports and data.

#### Research Questions

The study should answer, at a minimum, the following **research questions**:

- What is the participation of minority, women, and veteran business enterprises in the commonwealth in activities related to the regulation, licensing and promotion of sports wagering operators?
  - As a percentage of total participation and dollars spent?
  - o As mean and median contract size compared to total?

- Compared to similar industries?
- O What kinds of organizational policies and practices are in place related to solicitation of and contracting with minority, women, and veteran business enterprises in the commonwealth for organizations and agencies engaging in these activities?
- What is the level of participation of women, minority and veteran employees working for sports wagering licensees and employers?
  - As a percentage of total participation?
  - o At different levels of employment within organizations?
  - o Compared to similar industries?
  - What kinds of organizational policies and practices are in place related to recruitment and retention of a diverse workforce?
  - What kinds of considerations are there related to employment impact, compensation, benefits, trajectory, and turnover for women, minority, and veteran employees compared to employees from other groups?
- What is the level of participation by minority-owned and women-owned businesses that contract with or provide services to sports wagering licensees and employers?
  - As a percentage of total participation and dollars spent?
  - As mean and median contract size compared to total?
  - o Compared to similar industries?
  - What kinds of organizational policies and practices are in place related to solicitation of and contracting with minority, women, and veteran business enterprises in the commonwealth?
- What are the barriers to employment of women and minorities in the sports wagering industry?

#### The proposal should clearly detail how the proposed methods will answer each research question.

#### **Timeline**

An evaluation of participation by minority, women, and veteran business enterprises in the sports wagering industry should take place long enough after implementation of sports wagering that preliminary findings may be assessed, but early enough to inform and maximize potential improvements in processes. We thus anticipate engaging in a procurement process to select an entity to conduct this evaluation by July 2023, with initiation of the evaluation by September 2023. We anticipate including this study in the gaming research agenda in FY24 with advice from the Gaming Policy Advisory Committee and approval from the Massachusetts Gaming Commission.

#### Budget

Anticipated funding available for this study will be approximately \$100,000-150,000.




