- <u>Item #3 Gaming Economic Development Fund White Paper Update</u>. Commissioner Stebbins will present this item for a vote. He will be sending a draft addendum to the staff for review, and then set time aside for discussion per the Chair.
- <u>Item #4 Legislative Activities Report</u>. Mr. Ziemba will have this report ready regarding the status of racing and sports gaming legislation. Dr. Lightbown will join in the presentation. The Chair will accept a verbal report in lieu of materials.

- <u>Item # 10 Plainridge Park Racecourse Request for Approval of Racing Officials and Key Operating Personnel</u>. Dr. Lightbown will present this request for a vote. Mr. O'Toole will be present.
- <u>Item #11 Standardbred Owners of Massachusetts (SOM) Recognition Request as Breeder's Representative Group.</u> Dr. Lightbown will present this request with a PowerPoint presentation. This request will require a vote.
- <u>Item #12 Massachusetts Thoroughbred Breeders Association (MTBA) Request to Race at Finger Lakes</u>. Dr. Lightbown will postpone this item until either the first or second meeting in April. This request will require a vote.
- <u>Added Item:</u> Dr. Lightbown will request a variance of 205 CMR 3.12(6) that addresses the length of time horses can be out before resuming racing (variance from the 30-day requirement to 45 days). This will require a vote.

<u>Added Item:</u> Dr. Lightbown. PPC would like to request promotional fund use for an event. This item will require a vote. PPC's Director of Racing, Steve O'Toole will be presenting.

<u>Added Item:</u> Ms. Lillios will request approval for a new MGM Qualifier. This item will require a vote.

<u>Added Item:</u> Mr. Lennon, Mr. Band, and the IT Department would like to present a Promotional Gaming Update on the IGT house system calculation of promotional play. This will be part of the administrative update.

<u>Added Item:</u> Ms. Griffin would like to add an agenda item regarding the Gaming Mitigation Program, reporting on a published RFP. There may be a guest speaker.
