<u>Item #13 - Regulations</u> - The Legal Division confirmed no changes or updates to the regulations that were scheduled for May 4th.

<u>Item #14 – Community Mitigation Fund Grants</u> – Division Chief of Community Affairs Joe Delaney confirmed that workforce grants will be discussed.

<u>Item #18 – Meeting Minutes</u> – Associate General Counsel Young confirmed there will be two sets of meeting minutes to review and discuss on this date (November 29, 2022 and December 1, 2022).

 $\underline{\text{Item } \#19 - \text{Legislative Update}} - \text{Commissioner Hill confirmed there will be one legislative bill for discussion.}$ 

<u>Item #20 – Regulations</u> – The Legal Division confirmed this item.

<u>Item #21 – Delegation of Authority</u> – Commissioner Maynard confirmed this item will be presented to the Commission on May 4, 2023 and will require a vote on May 16, 2023 to approve the finalized document.

<u>Item #22 – Encore Broadway Expansion Initial Discussion</u> – Chief Delaney inquired about any items the Commissioners would like Encore Boston Harbor to submit for a final review and decision on their application. Chair Judd-Stein requested a further discussion about the process moving forward.

<u>Item #23 - Quarterly Report for MGM, PPC, and EBH</u> – Chief Delaney requested this item be moved to a further date and stated he will work with the operators on confirming a date that works for them.</u>

Item #24 – Office Lease Update – Executive Director Wells confirmed this item.

<u>Add-On Item –  $3^{rd}$  Quarterly Budget Update</u> – Chief Lennon requested time to provide an update about the  $3^{rd}$  quarter budget during this meeting.

<u>Add-On Item – Standardization of House Rules</u> – Chair Judd-Stein requested the Commission revisit this topic. Operations Manager Carpenter mentioned that the Sports Wagering Division could create a procedure for further consideration.

<u>Item #27 – ILEV Review Process</u> – Chief Delaney confirmed this is still under review.

<u>Item #28 – Encore Broadway Expansion</u> – Chief Delaney confirmed that once the Division has this meeting on May 16, 2023, they will request certain materials from Encore Boston Harbor and anticipate starting the discussion no earlier than June 2023.

<u>Item #29 – Compliance Committee</u> – Commissioner O'Brien requested this item remain under review.

<u>Item #30 – Patron License and Survey Report</u> – Director Vander Linden requested this item remain under review.

<u>Item #31 - Springfield Community Driven Research Project</u> – Director Vander Linden confirmed they are nearing the end of the review of this project, but requested this item remain under review until its finalization. He confirmed that this topic was about the impact of gaming establishments on housing and involved two zip codes near MGM Springfield.

<u>Item #32 – MGM HCA Compliance Update</u> – Chief Delaney reported he was in the process of scheduling meetings with the licensees and that this could be a multi-step process. Chief Delaney requested to keep this item under review.

Item #33 – Recognition of Jockey Guild – Dr. Lightbown requested to keep this item under review.

<u>Item #34 – Proposed Research Agenda</u> – Director Vander Linden confirmed this item should be all set.

<u>Item #35 – Approval of Certificate of Operations</u> – Director Band confirmed the Division is looking for a new server group and to keep this item under review.

<u>Item #36 – Event Catalog Additions</u> – Chair Judd-Stein confirmed we will keep this item under review.

<u>Add-On Item – Mission Statement</u> – Chair Judd-Stein confirmed she is planning to put together a working group to re-examine the MGM mission statement given the expansion of sports wagering.

<u>Add-On Item – Bonus Bet Language</u> – Operations Manager Carpenter confirmed the updates the operators made to their bet language. He mentioned that the Commission could request new language to change it. Chair Judd-Stein asked the Division to confirm with Legal.

<u>Add-On Item – Advertising Language</u> – Commissioner O'Brien requested time to check and review the operators' use of certain phrases (i.e. "risk-free," "win or lose," "guaranteed") in their advertising. Chair Judd-Stein suggested adding this topic under the Legal Division's regulation items.

Having no further business, Commissioner O'Brien moved to adjourn. Commissioner Hill seconded.
