The report will cover how ADW is conducted in MA vs. simulcasting and betting in person for live racing. Mr. Bourque should describe a section on revenue. This item could be incorporated into the administrative update. Also, the difference between a mobile bet and the ADW should be discussed, as it is in the public interest to make that distinction.
