<u>Item #5 – Sports Wagering</u> – Sports Wagering Operation Manager Sterl Carpenter confirmed the Sports Wagering Division will have house rules from Fanatics, DraftKings, and Fan Duel, each submitting multiple changes.

<u>Item #6 – Discussion of CMF Review Process</u> – Chief of Community Affairs Joseph Delaney confirmed he will bring forward a policy proposal and memorandum identifying some of the existing issues with the CMF and potential solutions for the Commission's review.
