1. Call to Order

Interim Chair Jordan Maynard called to order Agenda Setting Meeting #171 of the Massachusetts Gaming Commission ("Commission") at 10:01 AM.

<u>Item #6 – Fiscal 25 Budget Approval</u> – CFAO Lennon confirmed this item for discussion at the June 20, 2024, meeting. CFAO Lennon noted that the proposed Budget had been circulated for two weeks prior to this meeting, and that the packet for commissioners would include the proposed budget, public comments regarding the budget, and an additional budget table.

<u>Item #7 – Review of Potential Partnership with Gam-Ban – Responsible Gaming – Director Vander Linden requested that this item be moved to the next public meeting.</u>

<u>Item #8– Community Mitigation Fund – Request for Amendment</u> – Chief Delaney requested that this item be removed from the agenda, as the request for amendment from the City of Hampden had been withdrawn.

<u>Item #9 – MGC Seal of Approval – Deputy General Counsel Stempeck confirmed this item for presentation at the June 20 meeting.</u>

<u>Item #10 – Tribal Litigation Update – Legal</u> – Deputy General Counsel Stempeck confirmed that he would provide an update on the status of litigation to the Commissioners on June 20th.

<u>Item #11 – FY 2025 Research Agenda – Responsible Gaming</u> – Dr. Andrews requested an agenda item to discuss the FY 2025 Research agenda after it received comment from GPAC.

<u>Item #12 – Sports Wagering Player Limitation</u> – Commissioner O'Brien requested an agenda item to discuss the Sports Wagering Roundtable and the comments received. Commissioners reached consensus that this item should be added to a future meeting's agenda.

<u>Item #13 – Recognition of the Jockey Guild – Racing</u> – Director of Racing, Dr. Alexandra Lightbown confirmed an agenda item to discuss recognition of the Jockey Guild at the June 20th meeting.

<u>Add-on Item – Non-Compliance Matter – IEB</u> – Commissioner O'Brien requested an agenda item to bring back a non-compliance event for vote and reconsideration after its initial discussion at a previous public meeting.

<u>Add-on Item – discussion on Illegal Gaming Markets</u> – Commissioner Skinner requested an agenda item for Commissioners to discuss the Illegal Gaming Market and whether a cease-and-desist letter would be a viable initiative for the Commission. Commissioners reached consensus on this issue.

<u>Add-on Item – Gambling Advertising Report</u> – Dr. Andrews requested an agenda item for discussion and presentation of the Gambling Advertising Report at the June 20th meeting.

<u>Add-on Item – IEB – EBH Beverage Amendment</u> – IEB Director Monahan requested an agenda item for the presentation of a Beverage amendment request from Giardinos at the Encore Boston Harbor.

<u>Item #1 – Administrative Update</u> – Executive Director Serpa confirmed that an administrative update would likely come forward on July 11th.

<u>Add-on Item – IEB Civil Administrative Penalty</u> – IEB Director Monahan requested an agenda item for discussion of a Civil Administrative Penalty.

<u>Add-on Item – Executive Session – Public Safety at Casinos</u> – IEB Director Monahan requested an executive session at the July 11th meeting for discussion of public safety initiatives at the casinos.

<u>Item #10 – Responsible Gaming Conference</u> – Director Vander Linden agreed that a debrief on the Responsible Gaming Conference be given sometime in July after the feedback had been analyzed.

<u>Item #11– Licensee Diversity Audit</u> – Commissioner Skinner confirmed this item should remain under review but anticipated that a presentation would occur at a public meeting sometime in in August.

<u>Add-on Item – Sports Wagering Waivers – 205 CMR 257.03</u> – Director Band requested an agenda item for further discussion on the regulation, and the waivers issued to Operators. Compliance Manager Steffen offered clarification that the waivers would expire on June 30, 2024, and noted that it would be beneficial to have those discussions occur close to the expiration date.

4. Commissioner Updates

Chair Maynard noted that it would be beneficial for the Commissioners to have a discussion on the conferences they were attending as participants and as featured presenters at a future public meeting.

5. Other Business

Having no further business, Commissioner O'Brien moved to adjourn. Commissioner Skinner seconded the motion.
