The City of Melrose, located approximately 3.5 miles from Encore Casino with access via the MBTA Orange Line, the Northern Strand Bike Trail, and local roadways, is fortunate to be comprised of abundant historic and cultural resources. The City's cultural center, The Soldiers & Sailors Memorial Building, known as Memorial Hall, is a cherished community resource that is used year-round by local non-profits, school groups, and large regional entities for performances, recitals, community meetings and events. Organizations such as the Melrose Symphony Orchestra, the oldest continuously performing volunteer orchestra in the United States, and the Melrose Youth Ballet, regularly hold performances in the building's large auditorium with musicians and dancers traveling from across New England to participate in the productions. In Fiscal Year 2023, Memorial Hall also hosted the Amazigh Indigenous Cultural Community Organization's New Year Celebration, performances by the Hispanic Flamenco Ballet of Miami Beach, the Bulgarian Lodo Mlado Dance Ensemble, the O'Shea Chaplin Academy Irish Feis, and the Royal Scottish Country Dance Society of Boston, among many others. Altogether, approximately 48,964 guests attended 261 events sponsored by 77 different organizations.

Apart from providing much needed performance and meeting space for groups large and small, Memorial Hall is a local economic driver, bringing thousands of patrons into the community to rehearse or attend concerts, events and meetings. Located within the City's Downtown Historic District, ticketholders have access to an array of international dining options and many vibrant local businesses along Main Street. The Memorial Hall Executive Director works closely with the Melrose Chamber of Commerce to promote the City's business community and encourage patrons to visit local establishments.

Unfortunately, the effects of the gaming establishment and COVID-19 on Memorial Hall's event bookings are significant. As shown in the supplemental table, the number of events held in Fiscal Year 2023 is still below the years prior to the casino opening and the Covid pandemic numbers. This is in part because popular events that were historically held at Memorial Hall, such as Murphy's Boxing, have relocated to the Encore Casino. Together, COVID-19 and the presence of the casino have impacted the City's economy and deprived the City of important revenue streams. To remedy this and capitalize on the large number of visitors and employees attracted to the region by the casino, the City is requesting funds to renovate the interior of Memorial Hall to accommodate additional events and programs that will draw patrons to the City's cultural and commercial amenities.

Since the 1990s, the City has invested millions of dollars to preserve and restore Memorial Hall, an historic civil war memorial built almost 120 years ago. Most recently, in Fiscal Year 2022, \$3.8 million in municipal funds were allocated for critical building envelope repairs, including a new roof, restored windows and doors, and complete masonry repointing. However, additional financial support is required for the City to make all the repairs that are needed. Due to the previous deterioration of the building's envelope, the structure's interior spaces have been severely affected by water damage, as shown in the images attached.

Comprised of two main rooms, the focus of this project is on the Grand Army of the Republic Hall and Rotunda, known as the GAR. The work involves removing the water damaged wallpaper, replacing and restoring water damaged plaster, repairing cracks in the walls and ceiling, and painting the walls and ceiling. The timing of this grant is ideal as the exterior restoration work is close to completion which will ensure weathertight conditions and allow for the interior repairs to begin.

The outcomes associated with investing in the building's interior include continuing to be able to host events in a safe and heathy environment, retaining the existing groups using the building and attracting new users. In turn, this will bolster Memorial Hall's ability to attract new visitors and recoup the number of attendees lost since the casino's opening and the COVID-19 pandemic. The economic activity generated from the increased patronage will support the City's commercial base and contribute to the success and vitality of the City of Melrose.

The City of Melrose will bring back a popular downtown holiday Pop-Up shopping experience for the Melrose community, located outside in the Melrose Family YMCA courtyard. This Pop-Up is an expansion of the City's successful, two-year brick and mortar <a href="Project: Pop-Up program">Project: Pop-Up program</a>. Emerging brands, entrepreneurs, artists, and makers will take week-long turns popping up in the temporary mobile retail unit. To help ensure their success, the brands would be provided the opportunity at a subsidized rate and will receive access to a suite of resources provided by the City's consultant and woman-owned business, Up-Next, LLC.

This program allows smaller businesses without a traditional brick-and-mortar location to introduce their products to a wider audience during peak holiday shopping season in a way they would not be able to otherwise.

As identified in the guidelines, public safety grants are intended to assist municipalities in addressing the increased public safety operational costs associated with the introduction of a gaming establishment to the region. Increased visitation and employment due to the casino will likely increase the interaction between public safety personnel, casino patrons, employees and Melrose residents. The influx of visitors to a casino and its nearby communities can result in an increase in calls for service and put pressure on local emergency services including emergency responders like police and fire departments and EMS. This could lead to increased needs emergency services.

With the addition of this gaming establishment in the region, increased visitation will likely increase the calls for emergency services. Having updated working AED's inside emergency vehicles and municipal buildings, and staff training in utilizing these life-saving tools, is critical.

Gambling harm reduction funding would assist HHS in further identifying populations at-risk for problem gambling, studying the impact of gambling on those populations, identifying solutions to help mitigate identified harms and begin to implement solutions.

This would be an opportunity to **collect and analyze existing quantitative** (i.e. <a href="https://www.umass.edu/seigma/">https://www.umass.edu/seigma/</a> and Youth Risk Behavior Data (YRBS)) and **qualitative data** from existing partners such as the Melrose Health and Wellness Coalition and Melrose Public Schools (MPS).

Creating and using a **specialized survey** to gather information on current habits and perceptions from MPS middle and high school students will inform a **social norming campaign**. Social norms marketing uses campus-based media to inform students about the truly reported behavior among their peers. Accurate information can help lead to changes in perceptions of social norms and, in turn, lead to healthier behaviors I.e. most students are not gambling and here's why.

Specific for those at-risk and current gambling students, a stand-alone brief intervention called **Personalized Normative Feedback (PNF)** will be used. Using a gambling PNF trainer to train MPS faculty and staff, as well as the City's Social Services Coordinator, on this intervention will work well to provide critical support to this particular part of the 6<sup>th</sup>-12<sup>th</sup> grade student population.

Financial literacy can help enable responsible gambling habits. Partnering with the City's Recreation Department to offer **financial management education classes** for youth, adults, older adults and the business community is an integral part of this overall harm reduction strategy.

Since the Milano Center reopened after the COVID-19 pandemic, there are certain days with discrepancies in participation. While there are many factors that this can be attributed to, one is the prevalence of a new casino in the community. The Milano Center organizes day trips for older adults by request. Over the past three years, the average percentage of participants across all trips that attended a trip to the Encore Casino was 29%. Almost one third of all trip participation was to the local casino. On days when the Milano Center organized a trip to Encore, the average attendance at the Center was 56 participants compared to the overall daily average of 68 during the same time period. This is an 18% reduction in center participation on days where there is a trip to the casino.

The Milano Center is proposing to increase participation in activities and trips for older adults that do not encourage gambling by offering a higher quality of programming. This could include contracting with local musical performers, theatre productions, and other entertainment options that the center would not typically be able to afford. This strategy would accomplish two goals. First, it would help support local arts and culture by hiring local entertainers, artists, and instructors to provide their talents to the Milano Center. Second, by offering a more diverse range of activities and programs, Milano Center participants would have greater access to affordable entertainment and may increase the number of participants who attend these types of events.

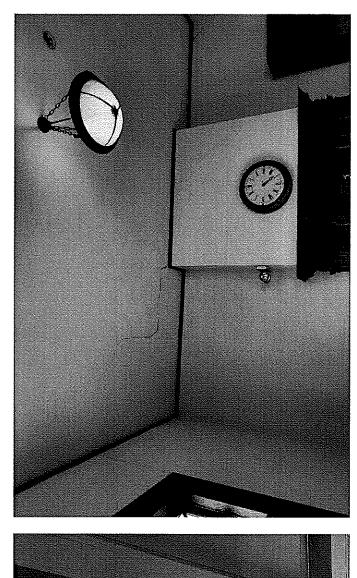


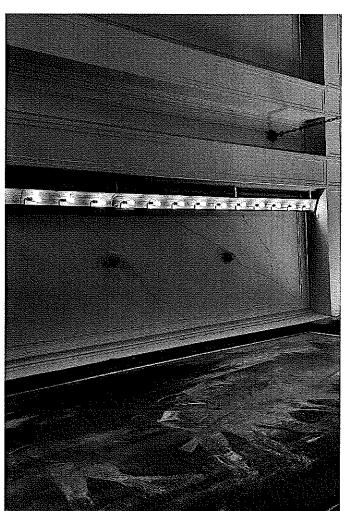
