Future of The Community Mitigation Fund



The CMF has been historically funded by statute from gaming taxes. The approved FY25 State Budget removed this funding mechanism for the year so additional funds have not been added.

- . Existing funding is available for FY 2026.
- II. If funding is not restored in FY 2026, major cuts will need to be made to the program.
- III. To provide level funding for FY 2026 approximately \$4.3 million will need to be transferred from Region A to Region B.

FY 2026 Overview

I. Continuation of the Block Grant Style Program

- The Municipal Block Grant
- The Regional Agency Grant

II. Grant Applications for Municipal Block Grants

Municipalities will be required to submit a single application for the entire community. If a municipality does not apply by January 31, they will forfeit their potential funds for that year.

III. Grant Amounts:

Maximum grant amounts remain the same for FY 2026. Notification letters were sent out to each community.

IV. Contract Duration:

Length of contract being reduced from 4 to 2 years.



Lessons Learned from FY 2025 Grant Round



Project Development and Backup Documentation

I. Several applications last year did not provide sufficient details on proposed projects or the necessary backup documentation to effectively evaluate them. Additional guidance has been included regarding the required project detail and documentation.

II. As per the FY 2026 Guidelines:

- I. Planning projects must have a defined area or issue that will be investigated as well as a clear plan for implementation of the results.
- II. The application should include sufficient backup information for the Review Team to fully understand the project(s). This information could include locus maps, requests for proposals, detailed scopes of work, catalog cuts of proposed equipment purchases, quotes, training course syllabus, etc.



Program Waivers

- I. Given the financial constraints on the program, any waiver requests to exceed the maximum grant amount must be well justified.
- II. The funding waiver was put into place to allow a community to exceed their proposed grant amount if it is insufficient to address a specific impact. For example:

If a community's grant allocation is \$500,000 and it has a transportation construction project that is eligible for an \$800,000 grant, that community can file for a funding waiver for the additional expense as the base grant amount is insufficient to complete the project.

III. The funding waiver is not designed to circumvent the proposed grant amount.

Vehicle Purchases

- I. The CMF has received numerous requests for the purchase of vehicles. For applications requesting vehicle purchases, communities must demonstrate the following:
 - That the vehicle is needed for a new effort being conducted by the community in response to a casino related impact
 - II. The percent of time the vehicle will be used to address the casino impact
 - III. For traffic enforcement vehicles, that the community is significantly impacted by casino related traffic
 - IV. How the proximity of the community to the gaming establishment necessitates the purchase
 - V. That the vehicle purchase will not be for the replacement of an existing vehicle used by the municipality
 - VI. That the request is not for the replacement of existing vehicles in the fleet.



Funding for Non-Public Entities – Anti-Aid Amendment

- I. CMF can not provide direct funding for non-public entities including private businesses and non-profit entities.
- **II. According to the State Comptroller's guidance:**
 - I. "state appropriated funds *may not* be granted to a non-public entity unless: the grant funds are used by the non-public entity solely to cover the actual costs of fulfilling a public purpose to benefit the general public ..., and may not provide a direct benefit or be used for maintenance of the non-public entity"
 - II. If any community is proposing a project that will pass grant funds through to a non-public entity, please contact CMF staff to discuss.

Applicant Meetings

- I. During the last round of funding Community Affairs staff met with several applicants prior to the application deadline to discuss potential projects.
- II. Any community that wishes to discuss their application ahead of the deadline can feel free to reach out to the Community Affairs staff to discuss project ideas, eligibility, etc.





Gaming establishments require a significant number of workers, which provide employment
opportunities for local residents.

Negative Impacts

- Competition from the gaming establishment may have negative impacts on other businesses competing in the hospitality and entertainment industries.
- The presence of a gaming establishment may result in reallocated spending. Reallocated spending is spending on goods and services which would have occurred had the casinos never opened, but which did not occur because an individual chose to spend their money at the casino instead. The main areas where monies are reallocated are transportation, retail items, hotels and travel, restaurants and bars, recreation, non-live entertainment and live entertainment.
- The marketing capabilities of the gaming establishments may put other competing local businesses at a disadvantage.

Eligible Community Planning and Implementation Projects – The following types of projects may be considered to address casino related impacts:

- Marketing and tourism plans to attract casino patrons and employees to the municipality, highlight local businesses, promote recreational and entertainment opportunities, and help communities compete with the gaming establishments for business.
- · Projects to provide economic development opportunities for local businesses.
- Programs to increase business opportunities to provide goods and services to the gaming establishments.
- Other programs to encourage casino employees to live/work/play in the community.

The town of Sudburham has felt lost opportunity costs due to the presence of a casino on their community. The town feels that if appropriate signage was available casino patrons could choose to patronize their restaurants, hotels, and shops. We are proposing a study of the current signage done by a consultant in collaboration with the Department of Public Works. This will identify opportunities for increased signage to make casino patrons more aware of local amenities. The Town will use the rest of the money to go out to bid for sign fabrication and design.

- Increased traffic associated with the gaming establishment may cause increased congestion on the major routes leading to/from the gaming establishment.
- Increased traffic associated with the gaming establishment may result in increased vehicular/bicycle/pedestrian conflicts.

II. Please describe the project in detail and how the proposed project will address the impact indicated above.

In an effort to reduce the volume of traffic on the local streets, provide a protected route for cyclists and pedestrians and improve access to the casino, the Town of Sudburham conducted a planning study for the conversion of an abandoned rail bed into a new shared use path that will connect to the Multi-Community Shared Path that leads to the casino. The study demonstrated that the construction of the shared use path will connect several population centers to the Multi-Community Shared Path which should divert a significant number of trips from single occupancy vehicles to bicycles thereby reducing local traffic congestion. A significant number of casino employees live within the area to be served by the path, which should encourage alternative means of transportation to the casino.

The Town has performed a preliminary design for the project and the estimated construction cost is \$3,000,000. Based on the CMF Guidelines the amount of the grant would be \$1,075,000 (100% of the first \$250,000 and 30% of the amount over \$250,000). This project will cause the Town to exceed the Grant Allocation of \$400,000. Please see the attached Waiver Request for this project.


The Town will complete the project design through the fall of 2024 with the project to be bid before the start of the 2025 construction season. The Town expects to start construction by April 15, 2025.

Transportation Construction Subsidies



- I. The Grant will only fund a portion of the construction costs.
- II. MGC will provide 100% of project costs up to \$250,000 and will fund up to 30% of the costs above that up to \$1.5 Million.
- III. If a municipality has more than one transportation construction project, the total cost of the combined projects will be used to determine the project subsidy (i.e., only the first \$250,000 of the combined projects receives the 100% subsidy).

One Transportation Construction Project

A construction project is estimated to cost \$3 million.

The subsidy would be the first \$250,000 of the project at 100% and 30% of the remaining cost or (\$2,750,000 x 0.30) \$825,000.

The total subsidy would then be \$250,000 + \$825,000 = \$1,075,000.



Two or More Transportation Projects

A community has two construction projects – a bike share network for \$125,000 and an intersection project for \$800,000 totaling \$925,000.


The first \$250,000 would be spent across the two projects – \$125,000 on the bike share and the remaining \$125,000 on the intersection project.

This would leave a remainder of \$675,000 on the intersection project.

Of that, CMF covers 30% or (\$675,000 x 0.30) \$202,500.

The total award for the two projects would be \$250,000 + \$202,500 = \$452,500.






Transportation Planning Eligibility

Traffic studies, roadway design, etc. may only be done on major routes to/from the casinos. These are identified as roads that carry at least 1% of the casino traffic.

- Maps showing these routes are included in the guidelines.
- If a community has data that shows other roads are significantly impacted, that can be submitted for consideration.



For planning of multi-use paths, the community must demonstrate that it will connect into an existing path network that provides access to the casino.

Waivers

- Applicants may request a waiver from any requirement of the Guidelines.
- If any municipality determines that the proposed grant allotment is insufficient to mitigate identified impacts, it may request a waiver for those specific projects.
