Five applications for a license to conduct category 3 mobile sports wagering operations, tethered to the casino licensees, have been submitted to the Commission. The applications were submitted by American Wagering, Inc. ("Caesars"), BetMGM, LLC, FBG Enterprises Opco, LLC (d/b/a Fanatics), Penn Sports Interactive, and WSI US, LLC (d/b/a WynnBET). This meeting is intended to afford an opportunity to offer input and comment on any or all the applications to any member of the public, or entity, who is interested.
