Exhibit 2, PPC Business Description

PRIVILEGED AND CONFIDENTIAL

Plainville Gaming and Redevelopment, LLC d/b/a Plainridge Park Casino ("PPC") intends to apply for a Category 1 License and enter into agreements with up to two Category 3 Licenses as provided in HB 5164.

PPC will operate the Category 1 License for retail sportsbook operations at the property. Services will be provided by Penn Sports Interactive, LLC ("PSI"), a wholly owned subsidiary of Penn Interactive Ventures ("PIV"), which is a wholly owned subsidiary of Penn Entertainment. PSI will seek appropriate licensure as may be required for the retail sportsbook operations.

In accordance with HB 5164, and subject to MGC approval, PSI intends to enter into a separate intercompany agreement with PPC to offer one of PPC's individually branded mobile applications or other digital platforms approved by the commission as a Category 3 License. PPC plans to utilize PSI to offer one of its Category 3 licenses as well as to enter into an agreement with a second Category 3 licensee.

PENN operates 44 entertainment destinations in 20 jurisdictions across the United States with a variety of retail and online gaming, live and simulcast racing, entertainment, and hospitality offerings, and currently has 24 retail sportsbooks in 10 states. These states include Colorado, Iowa, Indiana, Illinois, Louisiana, Maryland, Michigan, Mississippi, Pennsylvania, and West Virginia.

In 2019, PENN opened the first interactive (online) casino in the Commonwealth of Pennsylvania and has since launched online casino in the states of Michigan, New Jersey, and West Virginia with the Barstool Casino. In addition, PENN has launched the online Barstool Sportsbook in the following 12 states: Arizona, Colorado, Illinois, Indiana, Iowa, Louisiana, Michigan, New Jersey, Pennsylvania, Tennessee, Virginia, and West Virginia.
